



### WORCESTER COUNTY HEALTH DEPARTMENT

For each dwelling unit a minimum of 10,000 sq. ft. exclusive of buildings easements or rights of way, and such other permanent or physical objects shall be provided for the subsurface disposal of sewage.


Any approval by Worcester County Health Department of any sewer or suitability thereof is based upon State and County standards existing as of the date of approval; such standards are subject to change and a building permit may be denied in the future, in the event current standards cannot be met as of the date of application for such permit. This subdivision is approved for interim individual water supply and sewage system which must be properly abandoned and connection made to a community system when such a community system becomes available. Such approval runs with the land.
