


PHASE II - BUILDING "B"

NOTES OF CONDOMINIUM PLAT FOR - THE ISLAND AT HIDDEN HARBOUR (A CONDOMINIUM)

1. THIS CONDOMINIUM PLAT IS MADE SOLELY FOR THE PURPOSE OF COMPLIANCE WITH SECTION II-105 OF THE MARYLAND CONDOMINIUM ACT. THUS, COMMON ELEMENTS ARE SHOWN DIAGRAMMATICALLY ONLY TO THE EXTENT FEASIBLE AND MEASURED DIMENSIONS AND FLOOR AREAS ARE CORRECT ONLY TO A REASONABLE TOLERANCE, CAUTION IS URGED IN REGARD TO USING THIS PLAT FOR PURPOSES FOR WHICH IT IS NOT INTENDED, SUCH AS DETERMINING THE NATURE OR DESIGN OF THE STRUCTURE OR OTHER COMPONENTS OF THE BUILDING OR THEIR EXACT DIMENSIONS OR LOCATIONS.
2. THIS PLAT INDICATES THE OUTLINES OF CERTAIN BUILDING COMPONENTS THAT ARE PART OF THE UNITS, IT IS NOT INTENDED TO SHOW THE EXACT LOCATION OR DIMENSION OF THESE COMPONENTS OR ALL OF THEM.
3. FLOOR AREAS OF UNITS ARE BASED ON THE PORTION OF THE FLOOR THAT IS PART OF THE UNIT, ACCORDINGLY, THE AREAS THAT ARE PART OF THE COMMON ELEMENTS AND THE LIMITED COMMON ELEMENTS SUCH AS BALCONIES, WALKWAYS, THE STRUCTURAL WALLS, COLUMNS, VOIDS, ETC, HAVE BEEN DELETED.
4. THE ELEVATION OF THE UPPER AND LOWER BOUNDARIES OF EACH UNIT IS AN AVERAGE ELEVATION AND SUBJECT TO MINOR VARIANCES. IT IS STATED IN FEET ABOVE MEAN LOW WATER AND IS MEASURED TO THE UNFINISHED UPPER SURFACE OF THE STRUCTURAL FLOOR OF THE UNIT IN THE CASE OF ITS LOWER BOUNDARY. AND THE UNFINISHED LOWER SURFACE OF THE CEILING OR THE ROOF OF THE UNIT IN THE CASE OF ITS UPPER BOUNDARY. THE DATUM USED TO DETERMINE THE ELEVATION IS MEAN LOW WATER DATUM (1.57' HIGHER THAN MEAN SEA LEVEL ESTABLISHED IN 1929, BY U.S.G.S)
5. SOLID SHADING OF AN AREA OR COMPONENT INDICATES THAT IT IS A GENERAL COMMON ELEMENT, CROSS-HATCHING INDICATES LIMITED COMMON ELEMENTS AND CLEAR ELEMENTS ARE UNIT ELEMENTS.
6. THESE NOTES ARE INTENDED TO AVOID MISUNDERSTANDING AND ARE NOT INTENDED TO CHANGE THE EFFECT OF THE CONDOMINIUM DECLARATION, WHICH CLASSIFIES VARIOUS COMPONENTS OF THE BUILDING AS SHOWN AS COMMON ELEMENTS OR PART OF A UNIT.
