To the Honorable the Judges of the Circuit Court for Frederick County, sitting as a Court of Equity. The Bill of Complaint of John Renner and Catharine Renner his wife William M. Kump and Margaret Kump his wife, Nathan Slider and Louisa Slider his wife, Haniel Sheffey and Amanda Sheffey his wife of Carroll County, State of Maryland, and Emanuel Renner, Josiah Renner, George W. Hoffman and Elizabeth Hoffman his wife, Henry Favorite and Catharine Favorite his wife, Samuel Renner and Christiana Renner his wife, and Jacob Ashbaugh and Susanna Ashbaugh his wife, of Frederick County State of Maryland, respectfully show to your Honor - that a certain Susanna Renner the mother and grandmother of your Complainants was in her life time seized and possessed of certain real Estate situate lying and being in Frederick County State of Maryland, consisting of parts of several tracts of land called "Nothing venture nothing got," and part of a tract called "First Chance" and part of a tract called "Fifth Wendend" containing about two and three quarter acres of Land, more or less and fully described in the deeds from Samuel Kniss to Susanna Renner and from Philip Cutshall and Lydia Cutshall his wife to Susanna Renner, Certified Copies of which are herewith exhibited, marked Exhibits Nos 1 & 2, which your Complainants pray together with all other Exhibits hereafter produced - your Complainants pray may be taken and considered as part of their Bill of Complaint, the same as if set forth in words and figures -

Your Complainants further state that Jacob Renner the husband of the said Susanna Renner died in the year Eighteen hundred and sixty seven leaving the said Susanna him surviving and that the said Susanna Renner died intestate on the tenth day of March in the year Eighteen hundred and seventy nine seized and possessed of the lands herein before mentioned and leaving the following children and grand children to whom the lands descended as tenants in common viz -

- 1 John Renner, who married Catharine Biehl and resides in Carroll County Maryland.
- 2 Mary Renner who married Henry Kump and died before her said mother leaving the following children viz - 1 William M. Kump married to Margaret Beck 2 Susan Elizabeth married to George W. Hoffman
- 3 Louisa C. married to Nathan Slider, 4 Amanda R. married to Haniel Sheffey, 5 Millard F. Kump, 6 Mary Emma Kump - The said Millard F. Kump and Mary Emma Kump being infants under the age of twenty one years and reside in Frederick County Maryland
- 3 Catharine now the wife of Henry Favorite
- 4 Samuel Renner married to Christiana Beabill
- 5 Emanuel Renner
- 6 Elizabeth Renner who was the first wife of your complainant Henry Favorite
