The Petition of Martha M. Font by Cyrus A. Font her husband and next friend  
respectfully shows unto your Honors that under and in virtue of the provisions  
of the last will and testament of William H. Ramsburg late of Frederick County  
deceased, a copy whereof is herewith filed marked Exhibit A and is prayed to be  
taken and considered as a part hereof as fully as of herein at large, in words and  
figures set forth, after the termination of a life estate therein created in behalf of  
his widow, the whole of his estate was given, bequeathed and devised unto Thomas  
Gorouch and Thomas M. Martell in Trust for the uses and purposes set forth  
in said will as will fully appear from said certified copy as of record marked  
Exhibit A that said will was duly admitted to probate and is now of  
record in the Office of the Register of Wills of said Frederick County, that the  
widow of said William H. Ramsburg has recently departed this life and under  
said will said trust estate should now vest in said Trustees, that the  
said Trustees so as of record named in said will have declined to accept  
said Trust and have renounced said trust: that it is now necessary that  
new Trustees should be appointed in their place and stead, and your  
Petitioner, the said Martha M. Font, being one of the cestui que trust, and  
entitled under said will to the one half of the income from said trust estate  
and being interested therein, now comes here into this Honorable Court and  
prays your Honors to nominate and appoint two new Trustees in the  
place and stead of those who have renounced as aforesaid, to the end that  
the said trusts in said will may be fully and effectually carried out.

decreed, this 29<sup>th</sup> day of March Eighteen hundred and Eighty two that Cyrus  
A. Font and John S. Ramsburg he and they are hereby appointed Trustees  
in the place and stead of Thomas Gorouch and Thomas M. Martell for the  
uses trust and purposes set forth, expressed and contained in the said last  
will and testament of the said William H. Ramsburg, and it is further  
ordered and decreed that before the said Cyrus A. Font and John S.  
Ramsburg proceed to act as Trustees in the premises they shall each  
give bond in the penalty of two thousand dollars to the State of  
Maryland for the faithful performance of their duties in the  
premises to be approved by this Court or the Clerk thereof.
