Jeffery, trustee, as aforesaid, is authorized, ordered and directed to transfer, pay over and deliver to said Wendell B. Clarke, all the trust funds and securities in his hands as trustee for said Wendell B. Clarke, as aforesaid, under said will and agreement, and the said trust shall be thereafter fully extinguished and terminated."

Now therefore in consideration of the premises and to fully carry out and consummate the the provisions of the said decree of said Court and have said trust extinguished and terminated, we the said Virginia O. Jeffery and Edward T. Jeffery her husband, Sarah L. Gunn and Walter C. Gunn, her husband and Charles S. Clarke do hereby grant and assign to said Wendell B. Clarke, all of our respective interests of every kind, present or in remainder, in and to all the trust funds and estate bequeathed to said James C. Jeffery, in trust for the use and benefit of said Wendell B. Clarke for life, by the will of said Horace W. Clarke, deceased, or which said James C. Jeffery is in any manner entitled to hold for the use of said Wendell B. Clarke or to which said Wendell B. Clarke is in any manner entitled, and we the said Virginia O. Jeffery and Edward T. Jeffery her husband, Sarah L. Gunn, and Walter C. Gunn, her husband and Charles S. Clarke, in further compliance with the provision of said decree and in consideration of the premises, do for ourselves and each of us, our and each of our heirs, executors and administrators, fully release, acquit and discharge the said James C. Jeffery, trustee, as aforesaid, from any and all claim we, or any of us, might or could have as next of kin of said Horace W. Clarke, deceased, whether present or in remainder, and we do severally forever exonerate and release said James C. Jeffery, trustee, from all and every claim we might have against him on account of said trust fund.
