This deed made this 9th day of November in the year Eighteen Hundred and Ninety three by us, albert Jones, and Nannie P, Jones, his wife, of Carroll County, state of Maryland, William D, Jones, and henrietta, g, Jones, his wife, of Baltimore City, State of Maryland, Witnesseth; that in Consideration of the sum of Thirty eight hundred and thirty six, dollars and fifteen Cents, (\$3836.15) we the said Albert Jones and Nannie P.
