all the following described real estate of which Bernard A. Winkel died seized consisting of Buildings and Land zoned "Business B" in Frederick City and a wood lot in Liberty District, Frederick County, Maryland, and more particularly described as follows, to-wit:  
**FIRST PARCEL:** All that lot or parcel of land situate, lying and being on the North side of West Patrick Street in Frederick City, Frederick County, Maryland, improved with a filling station and garage building and described as follows: Beginning at an iron pipe on the north side of West Patrick Street at the end of 78.3 feet on a line drawn South 78°-22' East along the north side of West Patrick Street from the southwest corner of the brick dwelling No. 485 West Patrick Street included in a deed from Harry A. Grove and wife to Marion I. Winkel dated July 31, 1923 and recorded in Liber No. 346, folio 411, and running thence by and with the north side of said West Patrick Street (1) South 78°-22' East 52.00 feet to an iron pipe at the southwest corner of the Lydia G. White property formerly conveyed to Virginia J. Roelkey by Magdalene Crum by deed dated March 29, 1901 and recorded in Liber D.I.I.I. Winkel by The Crown Oil & Wax Co. by deed dated August 6, 1948, and recorded in Liber No. 472, folio 398.

**SECOND PARCEL:** All that piece or parcel of land on the South side of West Patrick Street and running through to the North side of West South Street, fronting on West Patrick Street 171 feet, and on West South Street 169 feet, more or less, the said lot being subdivided for separate lots, and improved with dwellings designated as 468, 468, 470 and 474 West Patrick Street, and more particularly described as beginning at an iron pipe on the south side of West Patrick Street at the northwest corner of the property herein conveyed, being at the end of 323.6 feet on a line drawn South 76°-22' East along the South side of said West Patrick Street from its intersection with the east side of Catoclin Avenue, and running thence (1) South 35°-37'-40" West 82.32 feet to an iron pipe on the north side of West South Street, thence by and with the north side of said West South Street (2) by a curve with radius equal to 1901.53 feet for an arc distance equal to 189.30 feet, the chord being South 43°-06'-42" East 169.24 feet to an iron pipe at the southwest corner of the Bernard S. Beginning at an iron pipe on the south side of West South Street at the end of 68.00 feet on the fourth line of the property conveyed to Arthur Bentz by Leonard E. Major and I. Pauline Major, his wife, by deed dated November 22, 1928 and recorded in Liber No. 360, folio 237 and running thence by and with the lines of said deed reversed two courses and distances, (1) South 35°-37'-40" West 68.00 feet to an iron pipe in the north line of and lot No. 46 in Block A in Catoclin Park as shown on a plat recorded in Plat Book No. 3, folio 31, thence by and with the north line of said lot No. 46, (2) South 60°-56" East 23-63 feet to an iron pipe, thence by a line crossing said lot (3) South 78°-10'-40" West 78-57 feet to an iron pipe in the south line of said lot No. 46, thence by and with the outlines of said lot No. 46, two courses and distances, (4) South 51°-34' East 236.10 feet to an iron pipe thence (5) North 25°-03' East 113.68 feet to an iron pipe on the South side of West South Street, thence by and with the South side of said West South Street two courses and distances, (6) by a curve with radius equal to 1961.53 feet for an arc distance equal to 181.10 feet

the chord being North 47°-12'-16" West 23.10 feet to the northwest corner of a triangular parcel, said parcel conveyed to said Bernard A. Winkel by Bernard S. Duvall and wife and The City of Frederick by herein mentioned deeds, thence (7) by a curve radius equal to 1961.53 feet for an arc distance equal to 171.41 feet, the chord being North 43°-29'-14" West 171.37 feet, more or less, to the place of beginning, Containing 29,719 square feet, more or less.

Being all of the property conveyed to Bernard A. Winkel by Bernard S. Duvall and Idella R. Duvall, his wife, by deed dated April 27, 1953 and recorded in Liber No. 568, folio 379 and the City of Frederick by deed dated June 19, 1933 and recorded in Liber No. 568, folio 331, plus parts of the same properties conveyed to said Bernard A. Winkel by four other deeds, the first from Manuel M. Weinberg and Sherman P. Bowers, Trustees, dated November 12, 1941 and recorded in Liber No. 503, folio 183, the second from Thomas J. Kemp and Mary A. Kemp, his wife, dated September 29, 1947 and recorded in Liber No. 503, folio 187, the third from Thomas J. Kemp and Mary A. Kemp, his wife, dated June 28, 1951 and recorded in Liber No. 503, folio 190, the fourth from Lydia G. White and Bruce G. White, her husband, dated November 18, 1943 and recorded in Liber No. 503, folio 192.

**FOURTH PARCEL:** All that wood lot containing 7 acres, 6 square perches, more or less, situated in Liberty Election District, Frederick County, Maryland, mentioned and described in a deed from Wilbur F. Hammaker, et. al. to Bernard A. Winkel, dated March 10, 1947, and recorded in Liber No. 503, folio 193, one of the Land Records of Frederick County, Maryland.
