TO THE HONORABLE, THE JUDGES OF SAID COURT:

Your Complainants, Naomi F. Main and Herman M. Main, her husband, by W. Jerome Offutt, their Solicitor, respectfully shows unto your Honorable Court:

FIRST: That George W. Hildebrand, late of Frederick County, State of Maryland, died intestate on or about the 20th day of May, 1959, seized and possessed of certain real estate, situate, lying and being in the City and County of Frederick, State of Maryland, the improvements thereon being now known and designated as No. 220 East Third Street, said real estate being more particularly described in a Deed from Gilmore R. Flautt, Jr., and Hazel V. Flautt, his wife, to the said George W. Hildebrand, said Deed being dated the first day of October, 1956, and duly recorded in Liber 570, folio 440, etc., one of the Land Records of Frederick County, Maryland, a duly certified copy of said Deed marked "Exhibit A" being filed herewith as part hereof.
