PETITION AND REPORT OF SALE

TO THE HONORABLE, THE JUDGES OF SAID COURT:

The Petition and Report of Sale of Thaddeus J. Hense, Assignee of Mortgage for the purpose of Foreclosure in the above entitled cause, respectfully shows:

FIRST: That on April 9th, 1955, John W. Thompson and Elsie R. Thompson, his wife executed their Deed of Mortgage recorded in Liber No. 544, Folio 550, one of the Land Records of Frederick County to H. V. Higley, Administrator of Veterans' Affairs (who has since been succeeded by J. S. Gleason, Jr., Administrator of Veterans' Affairs) conveying a lot of ground in Petersville Election District, Frederick County, in the State of Maryland, to wit: BEING ALL THAT LOT OR PARCEL OF LAND SITUATE, LYING AND BEING NEAR THE TOWN OF KNOXVILLE AND DESCRIBED AS LOT NO. 2 ON A PLAT RECORDED WITH A DEED FROM CHARLES F. MACKLIN TO FREDERICK G. MIRELY AND SADIE MIRELY, HIS WIFE, DATED 4/15/12, AND RECORDED IN LIBER NO. 300, FOLIO 482, ONE OF THE LAND RECORDS OF FREDERICK COUNTY, AND BEGINNING FOR THE LOT INTENDED TO BE CONVEYED AT A POINT ON THE SOUTH SIDE OF A THIRTY (30) FOOT RIGHT OF WAY, SAID POINT BEING AT THE BEGINNING OF THE FOURTH LINE ON SAID PLAT MARKED BY A LOCUST POST AND RUNNING THENCE SOUTH 33 DEGREES WEST 204 FEET TO AN IRON PIPE ON THE NORTH MARGIN OF THE PUBLIC HIGHWAY U. S. ROUTE NO. 340 AND WITH THE NORTH MARGIN OF SAID HIGHWAY, SOUTH 53 DEGREES EAST 107 FEET TO A POINT, THENCE BY AND WITH THE DIVIDING LINE BETWEEN LOTS NOS. 1 AND 2 AS SHOWN ON SAID PLAT, NORTH 33 DEGREES EAST 204 FEET TO A LOCUST POST ON THE SOUTH SIDE OF THE AFORESAID 30 FOOT RIGHT OF WAY, THENCE BY AND WITH THE SOUTH SIDE OF SAID RIGHT OF WAY AND WITH THE FOURTH LINE OF THE AFORESAID PLAT REVERSED, NORTH 53 DEGREES WEST 107 FEET TO THE PLACE
