THIRD: That the Plaintiff has paid the sum of Fourteen Dollars and Ninety-three Cents (\$14.93) toward the purchase of the real estate hereinabove described and sold by the County Treasurer as aforesaid. That the sum of Thirty-seven Dollars and Thirty-one Cents (\$37.31) including taxes, interest and costs necessary to redeem the property as aforesaid, has not been paid and the property, therefore, has not been redeemed, and that more than one year from the date of sale has passed, all of which is more particularly shown on the Certificate of Redemption issued by the Treasurer of Frederick County and filed herewith and marked "Exhibit B" and prayed to be taken as a part of this Petition.

TO THE END THEREFORE:

1. That a final decree shall be passed foreclosing all rights of redemption of the Defendants in and to the property assessed to John F. Harshman in Tuscarora District, Frederick County, Maryland.

2. And for such other and further relief as the nature of his case may require.
