all that farm located about 3 miles north of Jefferson, along Moser Road, in Jefferson Election District, in the County and State aforesaid, containing 143 acres, more or less, improved with a 9-room asbestos-shingle house, partly modern, with running water, bank barn, wagon shed, hog pen, meat house, spring house and other outbuildings. The land is of good quality, approximately 100 acres of which is under cultivation, 12 acres in permanent pasture, and the remainder in woodland. The property is especially adapted to livestock raising.

TERMS OF SALE: A deposit of 10% of the bid price will be required of the purchaser or purchasers on the day of sale. Balance in cash on ratification of sale by the Court. There is reserved from the sale tenant's 1/2 interest in growing crops, including 21 acres of wheat and 15 acres of barley, together with the right to combine and remove tenant's share of the grain upon maturity thereof. Full possession of the premises, subject to tenant's rights as before reserved, will be given upon ratification of the sale by the Court and final settlement. State and County taxes assessed against the said premises will be adjusted as of April 1, 1964. 
