All that lot or parcel of land situate, lying and being in the Linganore Election District, Frederick County, State of Maryland, and being located on the north side of Maryland Route #26, and being more particularly described as all that lot or parcel of land formerly known as Paradise School No. 3, being part of a tract of land called "The Resurvey on Smith's Lot" and being part of the same land conveyed by Peter Engle to Lewis Keefer by deed dated June 4, 1857, and duly recorded in Liber E.S. 10, at folio 652, one of the Land Records of Frederick County aforesaid, beginning for the outlines of the part hereby intended to be conveyed, beginning at a point on the northern edge of the State Road and at the end of 21.5 feet on the first line of the whole parcel of land and running thence with the lines thereof, as surveyed February 26, 1958, by George Bucher John, Surveyor, (1) North 35 1/4° East, 248.5 feet to a stake; and passing a stake at the end of 30.0 feet; thence (2) north 54 1/4° West, 160.0 feet to a stake; (3) South 35 1/4° West, 248.5 feet to a point on the State Road right of way and passing a stake 15.0 feet short of the end of this line; thence with the said right of way, (4) South 54 1/4° East, 160.0 feet to the beginning and containing 39,760 square feet of land, more or less.
