**PARCEL NO. 1:** All that parcel of land situate, lying and being on the Northeasterly corner of South Market Street and East All Saints Street in Frederick City, Frederick County, Maryland, known as Nos. 72-74-76 South Market Street, have a frontage of 40 feet with a depth of 93 feet which includes the adjoining property on East All Saints Street with a frontage of 29½ feet and a depth of 79 feet.

**PARCEL NO. 2:** All that lot or parcel of ground situate on the west side of South Market Street, in Frederick City, Frederick County, Maryland, beginning for the same on the west side of said South Market Street at the northeast corner of what was formerly Mathias E. Bartgis lot, and running thence by and with the west side of South Market Street North 5½° East 32.05 feet to a point in the north side of a brick fence wall; said point being at the end of 9.8 feet on a line drawn North 5½° East from the northeast corner of the brick dwelling now known as No. 69 South Market Street; and running thence by and with the north side of said brick fence wall South 89° West 69.1 feet; thence South 83° West 66 feet; thence South 78¾° West 27.7 feet to a point; thence South 13¼° East 9.1 feet to a point; thence South 87° East 157.6 feet to the place of beginning, being now known as No. 69 South Market Street.

**PARCELS NO. 1 and 2** being all and the same real estate which was conveyed unto Charles D. Bowie, III, Paul L. Brown, and William C. Hardy by deed from Null, Incorporated, a body corporate, dated March 21, 1969 and recorded in Liber 799, folio 673, one of the land records of Frederick County, Maryland.

Parcel No. 1 on the northeast corner of South Market Street and East All Saints Street is improved with a two-story brick building containing two storerooms which front on South Market Street. The larger storeroom was used as a retail meat and grocery business and the smaller one is being used as a tavern business. There are five apartments on the 2nd floor and there is an oil-fired steam heat system.

Parcel No. 2 on the west side of South Market Street is improved with a brick three-story building. The first floor contains two storerooms. The second floor contains two apartments and the third floor contains two apartments. There is an oil-fired central heating system.

**TOGETHER WITH** the improvements thereon and all rights, ways, easements and appurtenances thereunto belonging or in anywise appertaining.




