WITNESSETH, that for and in consideration of the sum of Ten Dollars and other good and valuable considerations, the receipt of which is hereby acknowledged, we, the said Gusta S. Wachter and Nevin W. Stull, Executors of the Last Will and Testament of John P. Wachter, late of Frederick County, deceased, under a power in said will contained, do hereby grant and convey, in fee simple, unto Lewis F. Martz and Kathleen K. Martz, his wife, all those tracts or parcels of land, situate, lying and being in Lewistown Election District No. 20, Frederick County, Maryland, being the same land and premises granted unto the said John P. Wachter by deed of Philip Wachter and Susannah Wachter, his wife, dated April 1, 1880, and duly recorded in Liber A. F.
