

10. "Eaglehead - Nightingale Section I", which plat is recorded in Plat Book 6, folio 30;
11. "Eaglehead - The Meadows Section II", which plat is recorded in Plat Book 6, folio 31.
12. "Eaglehead - Balmoral Section I", which plat is recorded in Plat Book 6, folio 36.

All of the above plat references being to the Books for the recording of Plats in the office of the Clerk of the Circuit Court for Frederick County, Maryland.
