TRACT NO. IV: All those two tracts, lots and parcels of land situate, lying and being in New Market Election District, Frederick County, Maryland, described and conveyed in a Deed from Henry A. Groff, his wife, unto Linganore Corporation, a body corporate of the State of Maryland, dated September 5, 1969 and recorded in Liber 810, folio 407, one of the Land Records of Frederick County, Maryland, said two lots or parcels of land containing in the aggregate 25 acres and 33 square perches of land, more or less.

TRACT NO. V: All those tracts or parcels of land situate, lying and being in the Mt. Pleasant Election District, County of Frederick, State of Maryland, being part of the tracts of land called "Middle Plantation" and "Addison's Choice", and more particularly described as follows:
