

189. S. $14^{\circ} 51' 08''$ E. 1253.26 feet to the place of beginning, containing 101,900,952 square feet or 2,339.3240 acres of land, EXCEPTING THEREFROM AND THEREOUT the following parcels of land, to-wit:
