THIS DEED, made this 31st day of May, in the year nineteen hundred and forty-one, by Grover L. Michael and Kathrene R. Michael, his wife, both of Frederick County, State of Maryland.

WITNESSETH: That for and in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable considerations, the receipt of which are hereby acknowledged, we, the said Grover L. Michael and Kathrene R. Michael, his wife, do hereby grant and convey unto Paul S. Michael and Blanche A. Michael, his wife, as tenants by the entireties, all that real estate situated in Frederick City, Frederick County, Maryland, and more particularly described as follows:-

BEING the Northern half of Lot No. 14 in Block 6, fronting on Trail Avenue twenty (20) feet and running back for a depth of 135 feet to a twenty foot alley, together with the use of said alley in common with all other lots binding thereon, said part of Lot No. 14 being the same as shown and described in the plat of the Frederick City Manufacturing and Development Company Northwest Addition to Frederick, Maryland, recorded in Liber W.
