

# COMMITTEE'S SALE

**PARCEL NO. 1:** All that parcel of land, with the improvements thereon known and designated as No. 262 West Patrick Street, being the same property described in a Deed dated September 25, 1919 from Harry G. Phebus and wife unto Walter C. Stockman (now deceased) and Annie L. Stockman, his wife, recorded in Liber 329, folio 15 and the additional parcel 4 feet by 10 feet described in a Deed to Walter Stockman from Charles E. Morgan and Elsie M. Morgan, dated September 18, 1926 and recorded in Liber 360, folio 58, both Land Records of Frederick County, Maryland. The property is improved with a two one-half story brick dwelling having bath, oil fired heating system and one car garage.

**PARCEL NO. 2:** All that real estate, with the improvements thereon designated as 213 South Jefferson Street, described in a Deed from G. Leicester Thomas and wife unto Walter C. Stockman and Annie L. Stockman, his wife, dated November 5, 1927 and recorded in Liber 364, folio 328; the property is improved with a one one-half story frame, composition roof bungalow with bath and oil fired steam heating plant and a frame garage. The lot is about 50 feet wide and a depth of 150 feet.

**PARCEL NO. 3:** All those parcels of land with the improvements thereon designated as Nos. 207 209, 211 and 213 Center Street, being the same property conveyed unto Walter C. Stockman and Annie L. Stockman, his wife, from Edward D. Storm, Executor, in Deed dated August 31, 1955, recorded in Liber 551, folio 323; the lots are improved with two duplex dwelling houses, each having 6 rooms with bath and heated by steam-fired furnaces, the lots have a total width of about 62 feet with depth of 157 feet.

**PARCEL NO. 4:** All that parcel of land with the improvements thereon designated as 21 East Sixth Street, being same real estate conveyed in a Deed from Nellie Glessner Miller, Executrix unto Walter C. Stockman and Annie L. Stockman, his wife, in a Deed dated March 24, 1948, recorded in Liber 465, folio 411; the lot is about 15 feet wide and a depth of 181 feet. The improvements are in poor condition.

**PARCEL NO. 5:** All that parcel of land with the improvements thereon designated as 335 East Patrick Street, being same real estate described in a Deed from William Adolph Hahn, et al., unto Walter C. Stockman and Annie L. Stockman, his wife, dated February 17, 1950 and recorded in Liber 484, folio 41; the lot is about 30 feet wide and a depth of 324 feet. It is improved with two story frame dwelling with bath.

**PARCEL NO. 6:** All that parcel of land with improvements thereon designated as 5 Hamilton Avenue, being same property described in Deed from C. Edgar Clingan, Attorney in fact to Walter C. Stockman and Annie L. Stockman, his wife, dated April 15, 1943 and recorded in Liber 438, folio 315; improved with semi-detached two story brick dwelling having steam heat and bath.
