WHEREAS, the party of the first part is justly indebted unto JAMES W. ROUSE & COMPANY,
INCORPORATED, whose Post Office address is: P.O. Box 905, Columbia, Maryland 21044

, a corporation organized and existing under the laws of the State of Maryland, in the principal sum of FIFTY-NINE THOUSAND SIX HUNDRED FIFTY AND NO/100ths-----Dollars (\$59,650.00), with interest from date at the rate of nine and one-half per centum (---9½---%) per annum on the unpaid balance until paid, for which amount the said party has signed and delivered a certain promissory note bearing even date herewith and payable in monthly installments of FIVE HUNDRED ONE AND 66/100-----Dollars (\$ 501.66), commencing on the first day of February, 1979, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 2009.

NOW, THEREFORE, THIS INDENTURE WITNESSETH, that the party of the first part, in consideration of the premises, and of one dollar, lawful money of the United States of America, to the parties of the first part in hand paid by the party of the second part, the receipt of which, before the sealing and delivery of these presents, is hereby acknowledged, has granted and conveyed, and does hereby grant and convey unto the party of the second part, as Trustee, its successors and assigns, the following-described land and premises, situate in the county of Frederick and State of Maryland, to wit:
