THIS DEED Made this 6th day of January, 1934, by us, Mae I. Gross and Howard Gross, her husband, of Frederick County, Maryland.

WITNESSETH: That for and in consideration of the sum of TEN (\$10.00) DOLLARS and other good and valuable considerations, we, the said Mae I. Gross and Howard Gross, her husband, do hereby grant and convey in FEE SIMPLE unto Harry C. Dorcus and Lola A. Dorcus, his wife, as tenants by the entirety, all our right, title and interest in and to all the following described tracts or parcels of land, to-wit:

FIRST: All that tract or parcel of land described as parcel No. 1 in a deed from Grace E. Staley and Irving Staley, her husband, Roy M. Dorcus and Mildred Dorcus, his wife, dated March 2nd, 1931, and intended to be recorded among the Land Records for Frederick County. And being the same parcel of land described in a deed from Joseph L. Shank to Charles W. Dorcus and Emma E. Dorcus, bearing date April 1, 1926, and recorded in Liber No. 358, Folio 48, one of the Land Records for Frederick County; and being known as Lot No. 25 on the Plat of the town of Woodboro, and being part of a tract of land called "Woodstown land,"

SECOND: All that right of way described in a deed and agreement bearing date December 28th 1931, by George W. Creager and Maggie C. Creager, parties of the first part, and Harry C. Dorcus and Mae I. Gross, parties of the second part, and intended to be recorded among the Land Records for Frederick County.
