SECOND: That your Complainants, through their counsel, have made diligent efforts to search the Land Records of this County to determine current record title owners of said land, but that your Complainants believe and aver that the only reference to the ownership of said land appears among the "Survey Records", in Book THO 1, page 223, in which it is indicated that the subject property was part of all that tract conveyed to one, "John Thompson", from the Land Office from the Western Shore, by deed dated July 22, 1803. That said document is incapable of clear photostatic reproduction to be attached hereto.

THIRD: That said real estate is vacant and unoccupied, and that your Complainants are in constructive and peaceable possession of same.
