DEED OF APPOINTMENT OF SUBSTITUTE TRUSTEES

WHEREAS, Allen L. Edwards and Janet M. Edwards, his wife did by Deed of Trust dated September 16, 1982 and recorded among the Land Records of FREDERICK County, Maryland, in Liber 1180, folio 211, grant and convey to Robert J.
