



ARTICLES OF INCORPORATION  
of  
WILLING WORKERS CLUB, OF  
BARTONSVILLE,  
FREDERICK COUNTY,  
MARYLAND  
INCORPORATED.

THIS IS TO CERTIFY:

First: That we, the subscribers, all citizens of the State of Maryland, and of the United States of America, whose Post Office Address is R.F.D. 1, Frederick County, Maryland, all being of full legal age, do, under and by virtue of the General Laws of the State of Maryland, authorizing the formation of corporations, associate ourselves with the intention of forming a corporation, said subscribers being, Mrs. Catherine Hill, Miss Vivian Ross, and Mrs. Geraldine Davis.

Second: The name of the corporation, (which is hereinafter called the corporation) is Willing Workers Club, Incorporated, of Bartonsville, Frederick County Maryland, Incorporated.

Third: The purposes for which the Corporation is formed and the business or objects to be carried on and promoted by it are as follows:-

(1) Religious, fraternal, patriotic, educational and recreational, meetings, gatherings etc., in said community, especially for the recreation and welfare of the young people of said community.

(2) To take by gift or devise and to purchase, sell, transfer and lease land and personal property and to do all things necessary and essential thereto.

(3) To do all things necessary and essential to the carrying on of the activities, rehabilitation, welfare and social work of the club, including the establishment and operation of recreational rooms and club facilities for the use and comfort for the members of the club and those interested in the welfare of the members and the young people of said community.

Fourth: The post-office address of the place at which the principal office of the Corporation in this State will be located is R.F.D. 1, Frederick, Maryland; the resident agent of the corporation is Mrs. Geraldine Davis, whose Post-Office Address is R.F.D. 1, Frederick, Maryland, said resident agent is a citizen of the State of Maryland and actually resides therein.

Fifth: The Corporation shall have twelve directors and Mrs. Catherine Hill; Miss Vivian Ross; Mrs. Geraldine Davis; Mrs. Richard Diggs; Mrs. Addie Norris, Mrs. Catherine Brooks, Mrs. Louise Collins, Mrs. Helen Brooks, Mrs. Cora Lee Bowie, Mrs. Rebecca Weedon, Mrs. Edna Diggs; and Miss Celestine Bowle, shall act as such until the first annual meeting or until their successors are duly chosen and qualified.

Sixth: This Corporation is not for profit; it shall have no capital stock; it shall have perpetual existence, subject to the provisions of the laws of the State of Maryland and the United States of America and to the by-laws.
