**NOTE:** Corporation, Firm or Partnership Names designated by INITIALS; (no Surname—A A A Auto Club Assn.; C I T Corporation; W L W Radio Station) located on First Mixed Group Page, according to FIRST INITIAL. Names beginning with NUMBERS—refer to "N" subindex or key sheet.

Most users prefer to make "Special Groups" of (1) SCHOOLS, Boards of Education, Colleges, Universities (2) CHURCHES-CHURCH BOARDS, Trustees of Churches (3) CEMETERIES, Trustees of Cemeteries (4) LODGES, Fraternities, etc. When so indexed, make cross references in the proper column of correct Subindex Sheet or Sheets. For example, type SCHOOLS (ALL) in column headed "Sch" and assign it to a numbered sheet. In the "Boa to Boq" column, type Boards of Education—See Schools; in the "Coa to Coq" column, type Colleges—See Schools; in the "U" column, type Universities—See Schools (no Sheet Number for cross references).

**TO THE INDEXER:** All Common names and the varying active names in different localities should be set out. Basis for "Set Out Names" is Family, Firm, Corporate names and Special Groups which you know or estimate will file 10 or more instruments PER ANNUM. You have a knowledge of many such names—refer to present Indexes and make a list (or lists in the case of Direct and Reverse). Type names in alphabetical sequence in the proper column or columns of the correct subindex or key sheet. Assign like sounding, differently spelled names to same page figure when the name falls in the same Unit or Section; make cross reference or type "See Also" when the name falls to different Units or Sections. Use judgment in spacing names in the proper column or columns. Sheets for "Mixed Name Groups" have been numbered from 1-up for each unit and a few sheets have been numbered for "Set Out Names", each of the 63 units. Page to which the first set out name of this unit is assigned is stated on other side. Additional names are assigned to succeeding ODD numbered pages. You may have to page some of the unnumbered extra sheets for set out names.
