INSTRUCTIONS FOR BINDING DECLARATIONS OF INTENTION IN THIS BINDER
(With Index)

1. **Thrust** binding posts through the top and bottom holes from the outside in Cover No. 1.
2. Force the pressboard strip down over the posts to hold them upright and in alignment.
3. When a declaration is executed place it face down over the posts. This method of filing is necessary to keep the court serial numbers in order until the volume is permanently bound.
4. At close of business each day place Cover No. 2 over the posts and screw the slotted caps in place so as to avoid any possible misplacement of the original declarations.
5. Index daily all declarations filed, so that when binder is filled and ready for permanent binding the indexing will be completed.
6. When 100 declarations have been accumulated in the binder, place the completed index over the posts, place Cover No. 2 in position and bind temporarily by screwing down the slotted caps. Then set aside for permanent locking by an Examiner.
7. Notify the District Director of Naturalization or Head Naturalization Examiner in charge of your district that the volume is ready for permanent binding, giving the number of original declarations assembled therein.

Forward a requisition (Form 2201) to the bureau for new binder and declarations (Form 2202-L-A) in sufficient time to permit of them reaching you just before binder is filled; or if declarations only are needed, order that form and note on requisition that binder not required. The channel back for permanent binding will not accompany its own binder, but will be sent with supply for following binder. This prevents misplacement of back while binder is being filled.




