

#### THE

## CHARTER,

GRANTED BY HER LATE MAJESTY

### QUEEN ANNE,

#### TO THE CITY OF

## ANNAPOLIS.

NNE, by the Grace of GOD, of Great-Britain, France and Ireland, and the Dominions thereunto belonging, QUEEN, Defender of the Faith, &c. To all and fingular our faithful Subjetts within cur Province of MARYLAND, Greeting. WHEREAS there is a very pleafant, bealthful, and commodious place for trade, by act of the general affembly of this our province laid out for a town and port, and called Annapolis, in honour of Us; which faid town and port bath, in few years, (especially fince the accession of our trusty and well beloved John Seymour, Esquire, our captain-general and governor in chief of this our province, to the government thereof, ] very confiderably increased in the number of its inhabitants, as well as buildings both public and private, fo that it excelleth all other towns and ports in our faid province, and for that our prefent feat of government within our province aforefaid is fixed at the faid port and town, whereby the same is become the chief mart of the whole country ;

WE, being willing to encourage all our good and faithful subjects, as well at present residing and inhabiting, or which bereafter shall or may inhabit or repde, within the Jame port of Annapolis, of our royal grace, good will and m re motion, with the advice of our council in our faid province, have thought fit, and do, by thefe our letters patent, conflitute and erect the faid town and port of Annapolis, together with the circuits and precincts thereof, including the lands heretofore laid out for the faid town and port of Annapolis, public pasture and town common, together with the river and creeks adjacent, into a city, by the name of THE CITY OF ANNAPOLIS; and do grant to the inhabitants of the faid city, that the same city shall be an Incorporate City, confifting of a Mavor, one perfon learned in the law, flyled and bearing the office of Recorder of the faid city, and fix Aldermen, and ten other perfons to be Common-Council-Men of the faid city ; which faid Mayor, Recorder, Aldermen and Common-Council-Men, Shall be a body incorporate, and one community for ever, in right and by the name of Mayor, Recorder, Aldermen and Common Council, of the Jaid city of Annapolis; shall be able and capable to fue and be fued at law, and to all and execute, do and perform, as a body incorporate, which shall have succession for ever, and, to that end, to have a common feal; and that Amos Garrett, Efquire, one of the inhabitants of the faid city, shall for the prefent be and be named mayor of the Jaid city for the enfuing year, and Wornell Hunt, Efquire, recorder thereof, and William Bladen, John Freeman, Benjamin Fordham, Evan Jones, Thomas Bordley and Josiah Willson, Esquires, inhabitants of the Jaid city, shall be aldermen thereof so long as they shall well helave themselves therein, having first taken and sub-Scribed scribed the teft and several oaths for security of the government, as by law established, and also the oath app inted by Us, or our pr. lent governor, to be taken by the mayor, recorder and alderm n, of the city of Annapolis aforefaid, which shall be administered to them by our governor in chit, or keeper of the great leal of this our province for the time being, or by fuch other perfon or perfons as we, our beirs and fucceffors, or our governor aforefaid for the time being, shall from time to time authorile and appoint to administer the same ; and we grant that the faid mayor, recorder and aldermen, or the major part of them, shall elect and choose ten other of the most sufficient of the inhabitants of the faid city, being freemen thereof, to be of the common-council of the faid city for so long time as they shall well behave them jelves.

AND, to perpetuate the fuccession of the faid mayor, recorder, aldermen and common-council, in all time to come, we do grant, that for the future they shall affemble in some convenient place in the faid city upon the feast day f St. Michael, the archangel, in every year, and shall elect and choose, by the major wate of such of them as shall be then pr fent, one other of the aldermen of the faid city for the time being to be mayor of the Jaid city for the enfuing year; and, upon decease or removal of the faid mayor of the faid city for the time being, or upon any decease or deceases, removal or removals, of the faid recorder or aldermen, or any of them, or within one m nth after fuch respective decease or deceases, removal or removals, the residue of the said aldermen, together with the said mayor (if he shall be living) or the major part of them, shall, at a set time by them to be appointed, within the laid city and precincls,

cinEts, elect and nominate fome other perfon or perfons to be mayor, recorder, alderman or aldermen, of the faid city, in the place and places of fuch perfon or perfons fo deceased or removed respectively, as the case shall require, so as the faid mayor, so to be elected and nominated, be at the time of such election and nomination actually one of the aldermen of the faid city, and fo as the faid recorder, to to be elected and nominated, be a perfon learned in the law, and so as the faid alderman or aldermen, fo to be elected and nominated, be actually at the time of fuch election and nomination of the commoncouncil of the faid city, the faid mayor, recorder, alderman or aldermen, fo to be elected and nominated, first taking the feveral and respective oaths before mentioned, to be appointed as aforefaid, and shall likewife then fill up, by the election of the free voters of the faid city, out of and from among the inhabitants and freeholders of the faid city, the full number of ten perfons to be common-council-men; and that the faid perfons hereby appointed and named, or bereafter to be elected and nominated, mayor, recorder or aldermen, be justices of the peace within the city, precincts and liberties thereof, having first taken the oaths usually appointed to be taken by the justices of the peace.

AND the faid mayor, recorder and aldermen, hereby named and appointed, or hereafter to be elected and nominated, or any three of them, whereof the faid mayor or recorder for the time being shall be one, shall have, within the precincts of the faid city, full power and authority to make constables, and other necessary officers, and to rule, order and govern, the inhabitants thereof; as justices of the peace are or shall be authorifed to do, and shall have power to execute all the laws, ordinances and and flatutes, in that behalf made, as fully and amply as if they were authorifed thereto by express commission named therein, willing and commanding, that no other justices of peace or quorum, within our faid county or province, do, at any time hereafter, take upon them, or any of them, to execute the office of a justice of peace within the faid city, or in the precincts thereof, notwithsstanding any commission at large authorising them thereunto, saving the authority and jurifdiction of her majesty's justices of over and terminer and jail delivery, now or hereaster to be assigned, during the time of their holding their several respective courts in the faid city.

AND further, we will and grant unto the faid mavor, recorder, aldermen and common-council, of the faid city for the time being, full power and authority, after the space of fix years, to elect a sheriff for the faid city, (but that, until then, the sheriff of Anne-Arundel county for the time being shall be sheriff of the faid city,) and to make, order and appoint, fuch bylaws and ordinances among themselves, for the regulation and good government of trade and other matters, exigencies and things, within the faid city and precincts, as to them, or the major part of them, Shall feem meet, to be confonant to reason, and not contrary, but, as near as conveniently may be, agreeable to the laws and flatutes now in force ; which faid by-laws shall be observed, kept and performed, by all manner of perfons trading and refiding within the faid city, under fuch reasonable pains, penalties and forfeitures, as shall be imposed by the faid mayor, recorder, aldermen and common-councilmen, or the major part of them, then assembled, from time to time, not exceeding forty shillings sterling; the faid [ 8 ]

faid pains, penalties and forfeitures, to be raifed by diffrefs and fale of the goods of fuch perfon fo offending, and to be employed for the public benefit of the faid city, at their difference.

AND further, we do grant and give full power, licence, privilege and authority, to the mayor, recorder; aldermen and common-council-men, of the faid city for the time being, and their successors for ever, and also all freebolders of the faid city; that is to fay, all perfons owning a whole lot of land, with an house built thereon according to law, and all perfons actually refiding and inhabiting in the fuid city, having a visible estate of the value of twenty pounds scrling at the least, and likewife all persons that bereafter shall serve five years to any trade within this city, and fhall, after the expiration of their time, be actually boulekeepers and inhabitants in the fame, to fend two citizens and delegates to every of our affembly or affemblies bereafter to be held, or at any time or times bereafter to be called to be held, for this our faid province of Maryland, to be elected . and chosen out of the inhabitants actually being and refiding within the faid city, having a freehold, or wifible estate, of the value of twenty pounds sterling therein, by the faid mayor, recorder, aldermen, common-councilmen, freeholders and free men, as aforefaid, or the major part of them, being then prefent, by virtue of our writ or writs of election, to be fent to them for that purpofe; which faid writ or writs we do hereby grant shall be iffued out and fent to the faid mayor, recorder and aldermen, when and so often as occasion shall require ; pro-wided, that all such electors or waters as aforefaid do take an oath to be true to the interest of the faid city, before they be admitted to fuch vote; and provided alfo, and

and at all times after the end of the next general affembly to be held for this province, no free man as aforefaid, not being a freeholder as aforefaid, Shall have the liberty of fuch vote as aforefaid until three months after fuch his freedom obtained.

AND, when bereafter there shall bappen any general affembly to be held, according as writs shall be sent for the several and respective counties for electing deputies or delegates for their several and respective counties in this our province of Maryland, we further grant, that the said citizens and delegates, by them so as aforesaid elected and sent, shall have full and free votes and voices in all and every of our general affemblies, touching or concerning all matters or things there to be discoursed and bandled, as other the deputies or delegates of the several and respective counties formerly have bad, now have, or bereafter shall have.

AND further, we grant and give licence to the mayor, recorder, aldermen and common-council, of the Jaid city, for the time being, and their fucceffors for ever, to have and to hold two markets weekly within the faid city, on every Wednesday and Saturday in the week, in some convenient place to be by them appointed within the precincts and liberties of the faid city, and alfo two fairs yearly, to be kept on Monday called St. Philip and Jacob's day, and on the feaft of St. Michael, the archangel, (or on the next day fucceeding each or. either of them in cafe they shall happen to fall on the Lord's day, ) for the fale and vending all manner of goods, cattle, wares and merchandifes, what foever; on which faid fair days, and first two days before and after, all perfons coming to the faid fairs, together with their cattle.

cattle, goods, wares and merchandifes, and returning thence, shall be exempt and privileged from any arrest, attackments or executions, whatsoever; and that the said mayor and aldermen shall have power to set such reasonable toll upon such goods, cattle, merchandises and other commodities, as shall be sold therein respectively, as shall be thought fit, not exceeding six-pence on every beast fold, and the twentieth part of the value of any commodity, and shall and may hold a court of pypowdry, during the said fair, for the determination of all controversies and quarrels which may happen therein, according to the usual cours in England in the like cases, and we grant unto them all prosits and perquisites due, incident and belonging, to said market-fair and court of pypowdry.

AND further, we do grant that the faid mayor, recorder and aldermen, or any three or more of them, shall hold a court of hustings within the faid city, where they are hereby empowered to make proper officers, and settle reasonable fees, not exceeding what are now allowed in the county court, and shall have jurisdiction, and hold plea of trespass and ejectment for any lands or tenements within the faid city, as also of all writs of dower for the fame lands and tenements, and of all other actions, perfonal and mixed, and, as a court of record, give judgement, and award execution thereon, according to the laws and statutes of England and this province; provided the demand in the faid action, perfonal and mixed, exceed not the sounds of tobacco.

AND provide l nevertbeles, That any party or pareses, plaintiffs or defendants, shall be at their liberty, on good grounds, to bring writs of babeas corpus and certiorari to remove any plaints from the faid buffings to the provincial court of this province, and alfo to appeal from the judgment of the mayor's court, or bring writs of error, at their choice, to the provincial court, under fuch limitation and regulation as is already, by the act of affembly of this province, affigned for profecuting appeals and writs of error from the county courts to the provincial.

IN TESTIMONY whereof, we have caused these our letters to be made patent.

#### An ACT confirming and explaining the charter to the city of Annapolis.

HEREAS this prefent general affembly have taken into their confideration the charter lately granted to the city of Annapolis, and being defirous to give all due encouragement to cohabitation, have refolved to confirm the fame charter, and to explain and reftrain fome claufes and grants therein contained, they humbly pray that it may be enacted,

II. AND IT IS HEREBY ENACTED, by the Queen's most excellent Majesty, by and with the Advice and Conjent of her Majesty's Governor, Council and Affembly, of this Province, and by the Authority of the fame, That the faid charter to the city of Annapolis, bearing date, at the faid city, on the twentyfecond day of November, anno 1708, in the feventh year of her majefty's reign, fealed with the great feal of this her majefty's province, and figned with the fign manual of his excellency John Seymour, Efquire, captain-general and governor in chief thereof, incorporating the inhabitants of Annapolis into a city and body corporate, and the feveral articles, claufes, grants, powers, authorities and privileges, therein contained, shall, by virtue of this act, be held, taken, ftand.

stand, remain, and be firm and valid, to all intents and purposes whatfoever, within the fame charter mentioned and expressed, subject nevertheless to the feveral reftrictions and explanations herein fpecified and declared; (that is to fay,) that it shall in no wife be intended, conftrued, meant or taken, to infringe the liberties and privileges of the public, either in regard to the public lands and buildings by them heretofore purchafed and built, but that the fame shall be referved and continued for ever to the uses and purposes to which they have already been allotted; and that all and every the judges and juffices of the feveral courts of judicature, which have ufually held their courts within the fame city, in the public court-house thereof, shall and may continue fo to do; and the juffices, commissioners and sheriff, of Anne-Arundel county, shall have, hold and exercise, their jurifdiction, in as full and ample manner, to all intents and purpofes, in the port of Annapolis, as heretofore had been ufual.

III. AND BE IT FURTHER ENACTED AND DE-CLARED, That the by-laws to be made by the faid corporation fhall not affect, or be binding to, any other the inhabitants of this province, but wholly reftrained to the inhabitants and refidents of the faid city; and that the claufe in the faid charter, empowering the corporation to fet toll on horfes, cattle and other commodities, to be fold on the two fair days of the first of May, and of St. Michael the archangel, yearly, shall not, in anywife, enure, be construed or extended, to empowering the corporation to affess any toll or impost upon cattle, goods, wares or merchandifes, whatfoever, to be fold therein, if the goods, wares wares or merchandifes, fhould not amount to the value of twenty fhillings current money; but if it exceed twenty fhillings value, and not above five pounds current money, then the fum of fix-pence fhall be paid for the fee or toll thereof; and for all goods, &c. exceeding in value five pounds current money, then it fhall be lawful to affefs the fum of twelve-pence current money for the fee or toll thereof, and no more.

IV. AND, whereas the citizens and burgefies of the feveral boroughs in England have formerly been allowed but half wages, in refpect to the falary of the knights of the fhires, BE IT THEREFORE ENACT-ED, That the citizens reprefenting the city of Annapolis, fhall only be allowed half the wages to the delegates and reprefentatives as is and fhall be allowed to the delegates of the feveral counties of this province, and no more.

V. AND, whereas Wornell Hunt, Efquire, the prefent recorder of the faid city, is not yet qualified for that truft, by reafon he hath not been relident in this province during the term of three years, neverthelefs the faid Wornell Hunt, by virtue of this act, fhall be deemed, and is hereby qualified and enabled, to hold and execute the faid office of recorder of the city aforefaid, any law, flatute, ufage or cuftom, to the contrary in anywife notwithflanding.

VI. AND BE IT ENACTED, by the Advice and Confent aforefaid, That the land called the Town-Common be referved and lemain to the use of the proper owner or owners, unless the citizens can make it it appear to have made fatisfaction for the fame the next feffion of affembly.

An ACT for fettling all disputes concerning the boundaries of the several lots within the city of Annapolis, and confirming the same to the respective takers up, improvers and purchasers thereof, and for laying out ten acres of land, out of the town passure, into twenty lots more, to be added to the said city.

THEREAS the original plot of furvey of the town of Annapolis, now erected into a city, has been deftroyed by the fire of the fladt-house in the year one thousand feven hundred and four, and little or no footsteps left to find out the bounds of the feveral lots, whereby many difputes and lawfuits are like to arife among the inhabitants and proprietors of the faid lots; and, forafmuch as justice may the more speedily, and at far lefs charges, be administered upon any fuch difputes by three or more indifferent perfons, appointed by law to act as commissioners to hear and finally determine them, and afcertain the boundaries and proprietorships of the lots within the faid city, as near as may be, according to the true intent and meaning of the original furveys of fuch proprietorships, and of the lots, of the town and port of Annapolis, made by Mr. Richard Beard, deceafed; it is therefore prayed, that it might be enacted,

II. AND BE IT ENACTED, by the Right Honourable the Lord Proprietary, by and with the Advice and Confent of his Lord/hip's Governor, and the Upper and Lower Houfes of Alfembly, and the Authority of the fame, That the honourable colonel William Holland, D colonel

colonel Thomas Addison, captain Daniel Mariartee and Mr. Alexander Warfield, or any three of them, be and are hereby appointed, authorifed and empowered, commiffioners for hearing, and finally determining, all or any the difputes that have and may arife among any the takers up, improvers or purchafers, of all or any the lot or lots of land laid out within the faid city, concerning either the property or bounds of any the faid lots, and that, to that end, the aforefaid commiffioners, or the major part of them, together with James Stoddart, Efquire, who is hereby appointed to furvey the aforefaid city, and the feveral lots, ftreets, and public grounds therein, do, fome time before the first day of August, in this prefent year of our Lord God feventeen hundred and eighteen, meet within the fame city, and calling before them, or the major part of them, the respective proprietors and claimers of the lots aforefaid, hear and examine their pretentions thereto, and caufe the bounds thereof to be afcertained and flaked out according to the true intent and meaning of the original plot or furvey of the town of Annapolis, heretofore made by the aforefaid Mr. Richard Beard, fo that no man, that has built by miftake, be ouffed of his poffertion, and finally to afcertain the properties of the feveral claims therein, and caufe their feveral determinations to be fairly transcribed, and transmitted in the fecretary's office of this province, as the fettled and indifputable bounds and properties of all and fingular the faid lots, and parties claiming the fame.

III. AND, to the end that the refpective owners of any parcels or quantity of lands, lying within the furvey or plot of the faid city, may receive just and equitable

equitable fatisfaction from the feveral claimers or poffeffors of fuch lots as may happen to fall within the respective bounds they claim property in, BE IT EN-ACTED, by the Authority, Advice and Confent, aforefaid, That fuch respective owners or claimers of any quantity or parcel of land, lying within the faid city, do appear before the faid commissioners, at or before the first day of August next, or at any other day or time as the faid commissioners, or the major part of them, shall appoint or direct, at the faid city, and upon oath, by the aforefaid commissioners, or any of them, to be administered to them, declare whether or no they know, or have heard, of any fatisfaction or payment for all or any part of the faid lands, heretofore made to themfelves, or any others, by, from or under, whom they claim the fame; and that, at the fame time, the faid claimers and owners of fuch quantities or parcels of land make good, and fhew to the faid commissioners, their respective rights and claims to the aforefaid lands, and receive fuch reafonable fatisfaction therefore from the respective proprietors of lots within fuch their lands, as the aforefaid committioners, or the major part of them, shall direct; and that, in default of fuch claim and making good their feveral rights to the aforefaid quantities or parcels of land as aforefaid, they, the faid claimers and proprietors, and their heirs and affigns, shall be for ever hereafter precluded and barred from any claim, right, or interest thereto, and the aforefaid quantities or parcels of land shall be deemed to be held by the owner of fuch lots, under the like rents and fervices as other lots and lands within the city aforefaid now are.

IV. AND,

IV. AND, whereas, for the better encouragement of poor tradelmen to come and inhabit within the faid city, and carry on their refpective trades therein, the corporation of the faid city have fupplicated this general affembly, that twenty more finall lots fhould be laid and added to the faid city, BE IT THERE-FORE ENACTED, by and with the Authority, Advice and Confent, aforefaid, That the faid commissioners, or the major part of them, by this act nominated and appointed, shall caufe ten acres of the public pasture, lying on the north fide of the faid city, and to the eaftward of the ferry road that leads by the hill whereon the powder-houfe now itands, to be furveyed and flaked out into twenty lots, to be taken up by any perfon or perfons that shall build a dwellinghouse upon the same, according to the directions of the aforefaid act for crecting Anne-Arundel and Oxford towns into ports and towns; which taking up, and building upon, as aforefaid, upon paying to the proprietors of the faid ten acres what fum the faid commiffioners, or the major part of them, shall affefs and award to be paid for each lot, fhall, by virtue of this act, make and veft a fure and indefeatible eftate, in fee, in and to the respective takers up, and builders thereon, and to their heirs and affigns, in all or any the aforefaid twenty lots fo to be laid out as aforefaid, any law, flatute or ufage, to the contrary notwithstanding.

V. PROVIDED NEVERTHELESS, and it is the true intent and meaning of this act, That no perfon already possessing a lot, or any part of a lot, within the faid city, shall have liberty to take up any of the faid twenty lots, for and during the space of two whole years years from the laying out the faid twenty lots, nor fhall any perfon take up any the faid twenty lots, in the name of any other, for his own use.

VI. AND, for the continuing the fucceffion of commiffioners and furveyors, until the bufinefs referred to them be completed, BE IT ENACTED, as aforefaid, That in cafe of the death, or absence, of any the faid commiffioners or furveyor, that the furvivors be, as they are hereby, empowered to choofe others, by majority of voices, to ferve in the fread or place of fuch as are abfent or deceafed; and alfo, that the faid commiffioners be allowed each fifteen shillings per day for their attendance; and that all charges arifing on the execution of this law, shall be afcertained by the faid commissioners, and fatisfied and raifed by an equal affeffment, by the lot, upon the feveral proprietors thereof, to be levied in fuch manner as the faid commissioners shall direct; and the faid commissioners, or the major part of them, are hereby empowered and authorifed to inquire if any thing be due, and, if any thing, what is due, from the public for any part of the lands laid out, in the city aforefaid, for the use of the public, and to make their report thereof to the next affembly, to the end that the proprietors of the faid lands may have just fatisfaction made them for the fame.

VII. AND BE IT LIKEWISE FURTHER ENACT-ED, That the clerk of the mayor's court, for the time being, be clerk to the faid commissioners, to enter their proceedings in the premises aforefaid; which faid proceedings shall be entered in the records of the mayor's court, whereto all perfons concerned may have recourfe. VIII. AND VIII. AND BE IT LIKEWISE ENACTED, That the commissioners aforefaid shall take the oaths appointed to be taken by the act for afcertaining the bounds of land within this province, in the like manner as is directed by that act.

An ACT to confirm an estate, in see-simple, to such persons as already have, or hereaster shall purchase, any the lands lying in the new town, commonly called The Addition to the city of Annapolis, or any land adjoining to the said city of Annapolis, commonly called the Town Pasture or Common, and to invest them with the same privileges, within the city of Annapolis, as other the streeholders therein now have, or hereaster may enjoy.

WHEREAS fundry perfons lately have, and ftill do continue to purchafe lots or parcels of ground, lying as well in the new town, commonly called The Addition to the city of Annapolis, as in the land adjoining to the faid city of Annapolis, commonly called The Town Pafture or Common, from the refpective proprietors thereof: And whereas the faid purchafers do defign to fettle and improve the faid lots; but, forafmuch as it may hereafter be doubted whether their title to the faid lots are good and valid, or, that by virtue of their refpective purchafes, they may be entitled to the fame rights and privileges that other the inhabitants or freeholders of the faid city do now, or hereafter may, enjoy,

II. BE IT THEREFORE ENACTED, by the Right Honourable the Lord Proprietor, by and with the Advice and Confent of his Lordship's Governor, and the Upper and Lower Houses of Assembly, and the Authority of the fame, That the feveral lots or parcels of ground already purchafed, or that fhall hereafter happen to be purchafed, from the respective proprietors thereof, either in the faid Addition to the city of Annapolis, or the lands adjoining thereto, called The Town Pafture or Common, be carefully furveyed by fome fkilful furveyor, and, when fo done, the faid respective lots, or parcels of land, be numbered in usual manner, and returned into the mayor's court office of the city aforefaid.

III. AND BE IT FURTHER ENACTED, by the Authority aforefaid, by and with the Advice and Confent aforefaid, That the feveral purchasers aforefaid, their heirs or affigns, shall, from the time of their respective purchafes, have, hold and enjoy, an abfolute estate, in fee-fimple, in the faid lots, or parcels of land, by them already purchased, or that shall hereafter happen to be purchased, as aforesaid; and that they the faid purchafers, and their affigns, shall, by virtue of the respective purchases aforefaid, and building a fubstantial dwelling-house, with four hundred foot of flooring, befides garrets or roofs, shall, for every quarter of an acre fo improved, have and enjoy all and fingular the privileges that the freeholders or inhabitants of the faid city have heretofore had, or hereafter shall have, notwithstanding the faid lots, or parcels of land, have not been heretofore laid out into lots; and that the fame lots may hereafter be deemed within, and as part of, the city lots, any law, ftatute, ulage or cuftom, to the contrary notwithstanding.

IV. PROVIDED, That it may be lawful for the prefent owners to fell unto any purchasers, to hold of him him or them, under the like rents and conditions as the faid owners hold the fame under the lord proprietor, as in the cafes of lord mefne and tenant in England, in cafe they make their deeds of bargains and fale accordingly.

V. AND PROVIDED ALSO, That convenient ftreets and alleys be duly regarded, faving to his lordfhip the lord proprietor, his heirs and fucceffors, and to all bodies politic and corporate, and all others not mentioned in this act, their feveral and refpective rights.

#### DECLARATION of RIGHTS.

#### SECTION XXXVII.

THAT the city of Annapolis ought to have all its rights, privileges and benefits, agreeable to its charter, and the acts of affembly confirming and regulating the fame, fubject, neverthelefs, to fuch alterations as may be made by this convention, or any future legiflature.

#### CONSTITUTION and FORM of GOVERNMENT.

#### SECTION IV.

HAT all perfons, qualified by the charter of the city of Annapolis to vote for burgefles, fhall, on the fame first Monday of October, feventeen hundred and feventy-feven, and on the fame day in every year for ever thereafter, elect, viva voce, by a majority

majority of votes, two delegates, qualified agreeable to the faid charter; that the mayor, recorder and aldermen, of the faid city, or any three of them, be judges of the election, appoint the place in the faid city for holding the fame, and may adjourn from day to day as aforefaid, and shall make return thereof as aforefaid; but the inhabitants of the faid city shall not be entitled to vote for delegates for Anne-Arundel county, unless they have a freehold of fifty acres of land in the county, diffinct from the city.

#### SECTION XIV.

THAT the fenate be chosen in the following manner: All perfons, qualified as aforefaid to vote for county delegates, shall, on the first Monday of September, 1781, and on the fame day in every fifth year for ever thereafter, elect, viva voce, by a majority of votes, two perfons for their refpective counties. qualified as aforefaid to be elected county delegates. to be electors of the fenate; and the sheriff of each county, or, in cafe of fickness, his deputy, (fummoning two justices of the county, who are required to attend for the prefervation of the peace,) shall hold, and be judge of, the faid election, and make return thereof as aforefaid : And all perfons, qualified as aforefaid to vote for delegates for the city of Annapolis and Baltimore-town, shall, on the fame first Monday of September, 1781, and on the fame day in every fifth year for ever thereafter, elect, viva voce. by a majority of votes, one perfon for the faid city and town respectively, qualified as aforefaid to be elected a delegate for the faid city and town respectively; the faid election to be held in the fame manner as the election of delegates for the faid city and town ; (INA) A

the right to elect the faid elector, with respect to Baltimore-town, to continue as long as the right to elect delegates for the faid town.

An ACT to enable the corporation of the city of Annapolis to fell or leafe certain lands, and to enlarge and afcertain the jurifdiction of the mayor's court of the faid city.

WHEREAS the ground heretofore laid out and referved for the building of fhips and other veffels, within the faid city, is found to be inconvenient for fuch purpofes,

II. BE IT ENACTED, by the General Affembly of Maryland, That the corporation of the city of Annapolis, and their fucceffors, shall have full power and authority to fell and dispose of the faid ground, or to leafe the fame, as they shall think most advantageous, and to make and execute any conveyance or conveyances, leafe or leafes, thereof, or any part thereof, as they may think proper, under the feal of the corporation; and fuch conveyance or leafe thall be good and effectual in law, if recorded within the time limited by law; and that fo much of the monies arifing from fuch fales, and of the rents to be referved on any leafes respecting the premises, shall be applied towards the purchase of one or more places within the faid city, as the faid corporation shall think fit, for the building of thips and other vefiels, and the overplus, if any, shall be applied by the corporation of the faid city for the benefit thereof.

III. AND BE IT ENACTED, That every conveyance for any ground whatever, which shall be purchased as aforesaid by the said corporation, shall be made to the mayor and corporation of the said city, and their successors; and that all rents referved on any leases to be made as aforesaid by the said corporation, shall be referved and made payable to the said mayor and corporation, and their successors; and that such conveyance shall be good and effectual in law, if recorded within the time appointed by law.

IV. WHEREAS, by the charter of the faid city, all pains and penalties imposed by the laws of the faid corporation are recoverable by diffrefs and fale of the offender's goods, and it is reprefented to this general affembly, that it frequently happens that offenders against the by-laws of the faid corporation escape with impunity, not being poffeffed of any goods whereon the faid penalties may be levied; for remedy whereof, BE IT ENACTED, That all fines, forfeitures and penalties, which have been heretofore imposed, or shall be hereafter imposed, by any laws of the faid corporation, or which have been heretofore incurred, or shall be hereafter incurred, shall and may be recovered by execution against the perfon of the offender, or by execution against the perfon of his bail or fecurity, if the fheriff fhall return his writ non eft inventus against the principal.

V. AND, for the better defraying the charge and expence annually incurred by the corporation of the faid city, for the fitting of the mayor's court, the meeting of the corporation, the payment of the profecutor, clerks, conftables and other officers, and for the the repairs of the fireets and dock, and for other neceffary purpofes, BE IT ENACTED, That the corporation of the faid city fhall have full power and authority to impofe a tax on all property within the faid city, or precincts thereof, not exceeding the fum of fix-pence, in any one year, for every one hundred pounds worth of property, direct the collection thereof, by execution thereof against the property or the perfon of the owner.

An ACT to enable the corporation of the city of Annapolis to lay a tax on property within the faid city and the precincts, to regulate and licenfe ordinaries and retailers of spirituous liquors within the faid city, and the precincts thereof.

WHEREAS it is reprefented to this general affembly, that the annual ordinary expences of the corporation of the city of Annapolis, for the fupport of the mayor's court and its proper officers, and the neceflary charge of repairing the ftreets, require confiderable fums of money, and the funds belonging to the faid city are very trivial, and greatly inadequate to the annual expences thereof; and it is alfo reprefented, that the dock of this city requires immediately to be cleaned, and that there is no market-houfe in the faid city;

II. BE IT ENACTED, by the General Affembly of Maryland, That the corporation of the faid city of Annapolis, and their fucceffors, be and they are hereby authorifed to lay a tax, not exceeding one fhilling current money in any one year, for every hundred pounds of property within the faid city, and the precincts cincts thereof, as the faid corporation may think proper.

III. AND BE IT ENACTED, That the power of regulating ordinaries and retailers of fpirituous liquors within the faid city, and precincts thereof, fhall be hereafter vefted in the faid corporation, and their fucceffors; and the mayor's court of the faid city only fhall hereafter grant licences to ordinary-keepers, and retailers of fpirituous liquors within the faid city, and its precincts, under fuch regulations and rules as the faid corporation, and their fucceffors, may make; and the faid corporation, and their fucceffors, may referve and lay fuch fine on every licence granted by the faid mayor's court to any ordinary-keeper, or retailer of fpirituous liquors, within the faid city, and its precincts.

IV. AND BE IT ENACTED, That the monies arifing from faid tax, and from the fines, and for licences to ordinary-keepers, and other retailers of fpirituous liquors, levied or imposed in virtue of this act, shall be appropriated and applied, by the corporation of the faid city, to defray the usual and ordinary expences thereof, and the amending and keeping in repair the ftreets of the faid city, and the cleaning out the dock, and the building a market-house, and to such other uses as the faid corporation may judge most for the benefit and advantage of the faid city.

V. THIS act to continue and be in force for and during the term of ten years, and until the end of the next feffion of affembly which shall happen thereafter.

#### 'An ACT to empower the corporation of the city of Annapolis to suppress public and excessive gaming.

**B**E IT ENACTED, by the General Alfembly of Maryland, That the mayor, recorder, aldermen and common-council-men, of the city of Annapolis, shall be and are hereby authorised and empowered, from time to time, to make and execute any by-law or ordinance for prohibiting, restraining and punishing, any public and excessive gaming in the faid city, and the precincts thereof.

II. AND BE IT ENACTED, That the faid precincts, and power of the faid corporation, fhall extend to a line drawn fouth from the head of Dorfey's Creek, on the north-weft of the faid city, at or near the poor-houfe, to the creek on the fouth fide thereof, called the Spa Creek; and all perfons within the faid city, and faid precincts to the extent of faid line, fhall be fubject to the by-laws or ordinances of faid corporation.

#### A BY-LAW to repeal all former by-laws of this corporation.

WHEREAS the by-laws of this corporation arc now revifed, BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That all by-laws heretofore made and published, shall be and arc hereby repealed, abrogated, and made null and void.

II. PROVIDED NEVERTHELESS, That all perfons who have violated or broke any of the by-laws hereby repealed, fhall be liable to be profecuted and convict for fuch violation or breach, and to the penalties and forfeitures mentioned in fuch by-law, the prefent repeal notwithftanding, fo as fuch profecution fhall be commenced before the firft day of July next,

A BY-LAW to afcertain the allowance to juries for verdicts, and by whom the fees to the feveral officers of the mayor's court shall be paid.

DE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That in all actions of meum and tuum which shall be brought in this court, and tried by a jury, the party, for whom a verdict is given or found, shall fatisfy and pay to fuch jury, as an allowance in every caufe, the fum of twelve shillings current money, which shall be allowed in his, her, or their bill of cofts; in cafe any jury, who shall be fworn and charged in any caufe, shall be ready to give their verdict therein, but the plaintiff or plaintiffs in fuch. caufe shall refuse to appear to such verdict, whereby the faid plaintiff or plaintiffs in fuch caufe shall be nonfuit, that then, and in fuch cafe, the faid jury shall be allowed the aforefaid fum of twelve shillings current money, in the fame manner as if they had given their verdict in fuch caufe, and the fame fhall be paid by the defendant or defendants therein, and be allowed in his, her, or their bill of coffs against the plaintiff or plaintiffs in fuch caule; and in all criminal causes to be tried as aforefaid, the party or parties who shall be thereof legally convicted by verdict of a jury, shall, and are hereby obliged, to pay and fatisfy fuch jurors who shall try the same as aforefaid, the like fum of twelve shillings current money.

II. AND BE IT ESTABLISHED AND ORDAINED, by the authority aforefaid, That the feveral and refpective jurors, hereafter to be impannelled, fhall and are 1 a

are hereby obliged, conftantly and every court, to attend their respective duties; and every juror or jurors, in default thereof, without reasonable cause, to be allowed by the court, shall be fined by the court, to

the ufe of this corporation, not exceeding the fum of twenty fhillings current money; that all perfons, against whom any prefertment or prefertments shall be found by the grand jury, and who shall be thereof legally convicted, by confession, verdict of a jury, or otherwife, shall be obliged to pay the several and respective officers of the mayor's court of the city of Annapolis, all and singular the several which he, the or they, shall be charged, according to the rate established, or to be established, by the faid court.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the profecutor of the mayor's court of this city shall have and receive, as a yearly falary, the fum of twenty pounds current money for his fervices in all cafes whatever, not otherwise provided for by law, which shall be paid by the treasurer of the corporation, out of the monies received by him for the use of the corporation, on producing an order of the court for that purpose.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the clerk of the corporation, and of the faid mayor's court, shall have and receive, as a yearly falary, the fum of fifteen pounds like money, for his fervices in all cases whatever, not otherwise provided for by law, to be paid as aforefaid.

A BY-LAW to oblige officers to attend their duty, and to direct fheriffs in the execution of their office. BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That whatfoever ministerial officer or officers belonging to the mayor's court, shall omit or neglect to appear and give their respective attendances according to the faid court's adjournment, without further notice, be fined for such neglect, by the court then fitting, not exceeding the sum of twenty shillings current money, to the use of this corporation, unless fickness, or other cases of absolute necessity, impede them, to be adjudged and allowed by the court.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That when and as often as any perfon shall be elected, according to the directions of the charter of the city of Annapolis, from and after the publication of this by-law, as sheriff of the faid city, and shall neglect or refuse to qualify himself, and to execute the faid office, being under no apparent disability or incapacity to execute the fame, or privileged, shall be fined not exceeding the sum of three pounds current money, to the use of this corporation, to be levied by distress and sale of the party's goods fo refusing.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every theriff, before he proceeds upon the execution of his office, thall enter into a bond, in the name of the flate of Maryland, to the use of this corporation, with two good securities, to be approved by the court, in the penalty penalty of one hundred pounds current money, conditioned as follows, to wit: " The condition of the above obligation is fuch, that if the above bound A. B. as theriff of the city of Annapolis, thall well and truly difcharge his duty in the faid office, regularly account with the treasurer of the corporation, and pay him all monies received by him the faid A. B. for their ufe, then the above obligation to be void, otherwife to remain and be in full force and virtue in law."

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That fuch fheriff, before he enter upon the execution of his office, fhall take the oath of fidelity to this flate, and repeat and fubfcribe a declaration of his belief in the chriftian religion, and alfo take the following oath of office, to wit: "I, A. B. do fwear, that I will well and faithfully demean myfelf in the office of fheriff of this city, during the time of my continuance therein, according to the beft of my fkill and knowledge. So help me God."

#### A BY-LAW to prevent accidents by fire.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That in case any chimney shall catch fire, so as to blaze out at the top thereos, the master or mistress of the family occupying or possessing the house to which fuch chimney belongs, shall be fined the sum of forty shillings current money, for the use of this corporation, to be recovered by indictment or confession.

AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That every dwelling-houfe, or feparate tenement, with a chimney wherein any fire thall be made, within this city, or the precincts thereof, thall be furnished and provided with one good and fufficient ladder, hanging from the ridge of the house, for every such chimney, and also one other good and fufficient moveable ladder, to reach from the ground to the hanging ladder or ladders aforefaid.

III. PROVIDED, That if any dwelling-houfe, or feparate tenement, as aforefaid, fhall be provided, for each chimney as aforefaid, with a good and fufficient ftanding ladder, which fhall reach from the ground to the ridge of fuch houfe, they fhall not be liable to be furnifhed with the hanging ladders as aforefaid.

IV. PROVIDED ALSO, That all perfons who have the convenience of a communication to the tops of their houfes, through the roofs of the fame, fhall not be fubject to any penalties by this by-law inflicted refpecting ladders to fuch houfe or houfes.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That every occupier of a dwelling-houfe, or feparate tenement, as aforefaid, in the faid city, or the precincts thereof, claiming an immediate freehold at leaft in fuch houfe or tenement, and every landlord refiding within the faid city, or the precincts thereof, who fhall leafe or rent out, to any other perfon or perfons, any dwelling-houfe or tenement as aforefaid, within the faid city, or the precincts thereof, fhall furnifh and provide as aforefaid, for every fuch dwelling-houfe or tenement fo occupied,

pied, or leafed or let out as aforefaid, the aforefaid ladders; and that the fame be taken and deemed as annexed to, and go with, every fuch dwelling-houfe or tenement, under the penalty, to every fuch perfon occupying, leafing or letting out as aforefaid, for every offence, the fum of forty fhillings current money, to the ufe of this corporation, with the like penalty for every three months neglect, to be recovered and applied as aforefaid.

VI. AND BE IT ESTABLISHED AND ORDAIN-ID, by the Authority aforefaid, That the receipt of any tenant of any fuch dwelling-houfe, or feparate tenement, within the faid city, or the precincts thereof, for fuch ladders, to the landlord, thall be deemed and taken as full and fufficient evidence that fuch landlord has complied with his duty, purfuant to this by-law, in furnishing and providing for fuch dwelling-house or tenement the ladders aforefaid ; and, in cafe any fuch tenant shall refuse or neglect, upon tender of fuch landlord, or by any other perfon by his authority, of fuch ladders, to deliver a receipt for the fame, fuch receipt being demanded, fuch landlord shall be discharged from all the penalties aforefaid, and fuch tenant shall, in lieu and stead of fuch landlord, become liable to all the forfeitures and penalties aforefaid ordained against fuch landlord for not furnishing and providing ladders as aforefaid, and to be recovered and applied in the fame manner.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That any perfon occupying any fuch dwelling-houfe or tenement, within the faid city, or the precincts thereof, the owner, claimer

claimer or landlord, whereof, as aforefaid, is not a refident within the faid city or precincts, fuch occupier shall, and he is hereby declared, deemed, conftrued and taken, to be obliged and required to furnish and provide for such dwelling-house, or tenement, the ladders aforefaid.

VIII. PROVIDED ALWAYS, and it is the true intent and meaning of this by-law, That it fhall and may be lawful to and for the occupier laft aforefaid, upon removing from or quitting his dwelling-houfe, to take and carry with him the ladders aforefaid, any thing herein contained to the contrary in anywife notwithftanding.

IX. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That any perfon or perfons that shall make, cause to be made, or permit, any fire in any wooden chimney, iron pot, tub of wood filled with dirt, or other like contrivance, hereafter, shall, if a free man, forfeit and pay the sum of forty shillings current money for every such offence, to be recovered as aforefaid to the use aforesaid, and, if a fervant or flave, the master, mistres, or person employing such fervant or flave, shall forfeit and pay the sum of forty shillings like money, to be recovered and applied as aforesaid.

X. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That no perfon or perfons, hereafter, fhall fuffer any flack or rick of hay, flraw or fodder, to be out of doors upon their lots, or keep any hay, flraw, or fodder of any fort, in any dwelling-house, on pain of forfeiting forty shillings, and the the like fine for every month fuch ftack or rick shall be fuffered to be on fuch lot, or hay, straw or fodder, remain in any dwelling-house, to be recovered as aforefaid for the use atoresaid.

XI. PROVIDED NEVERTHELESS, That nothing contained in this by-law fhall be conftrued to prevent any of the inhabitants of this city from making and curing of hay within this city, or the precincts thereof, nor fhall fuch perfons incur the penalties aforefaid in cafe they fhall find it neceffary for the prefervation of fuch hay, during the time of curing, to form it into ricks or flacks.

XII. PROVIDED ALSO, That it fhall and may be lawful for any perfon or perfons importing hay, fraw or fodder, into the faid city, by water, to fecure the fame in ricks or flacks, the faid ricks or flacks to be at leaft one hundred yards diftant from any houfe.

XIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any carpenter or joiner, working within this city, or the precincts thereof, fhall leave, or fuffer to be left, in his fhop or work-houfe, any confiderable quantity of fhavings or chips, upon his flutting up his faid fhop or workhoufe at night, the faid carpenter or joiner, for every fuch offence committed, fhall forfeit not exceeding the fum of forty fhillings current money, to the ufe of the corporation, to be recovered and applied as aforefaid.

XIV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That any perfor refiding

fiding within this city, or the precincts thereof, who fhall carry any fire uncovered through the ftreets, lanes or alleys, of this city, fhall, if a free man, forfeit and pay, for every fuch offence, the fum of fifteen fhillings current money, to the ufe of this corporation, to be recovered either before the mayor, recorder, or any one of the aldermen, of this city, or by indictment or confession in the mayor's court, and, if an apprentice, fervant or flave, the mafter or miftrefs of fuch apprentice, fervant or flave, fhall forfeit and pay the fum of fifteen sufficient money for every fuch offence, to be recovered and applied as aforefaid.

## A BY-LAW to prohibit keeping sheep, goats, swine or geese, within this city, or the precincts thereof, except in styes or enclosures.

TE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame. That from and after the twentieth day of July, inftant, no perfon or perfons within the faid city, or precincts thereof, shall keep or fupport any sheep, goats, fwine or geefe, within this city, or the precincts thereof, except fuch theep, goats, fwine or geefe, as they may or shall keep in pens or styes within their respective enclosures, (the faid pens or flyes not to be contiguous to the flreet, or offenfive to any of the inhabitants,) under the penalty of twenty shillings current money for every theep, goat or fwine, and under the penalty of two fhillings and fixpence current money for every goole, by him kept or Supported contrary to this by-law, to the use of this corporation,

corporation, to be recovered before the mayor, recorder, or any one of the aldermen, or in the mayor's court by indictment or confession.

II. AND BE IT ESTABLISHED AND ORDAINED. by the Authority aforefaid, That it shall be lawful for the conftables of this city, or either of them, and they are hereby directed and required, to take up any fheep, goats, fwine or geefe, going at large within the faid city, or its precincts, and to impound the fame, giving notice thereof at the market-house for five days, and if no perfon shall claim such sheep, goats, fwine or geefe, within the five days aforefaid, and if claimed, and the owner will not pay, within the faid five days, the fum of two shillings and fixpence current money for each day fuch fheep, goats or fwine, shall be impounded, and fix-pence per day for each goole fo taken up, it shall and may be lawful for the perfon making fuch feizure to fell fuch fheep, goats, fwine or geele, and, after deducting twelve fhillings and fix-pence current money for the five days impounding as aforefaid, or two and fix-pence for each goofe, as the cafe may be, he shall pay the balance, if any, to the fheriff of this city, for the ufe of the owner, or of the corporation if not demanded within three months from the time of the fale, and that the mayor's court make them fuch compensation for their trouble as they may think proper, to be deducted out of the money arifing from the fales, and retained for the use of this corporation by this by-law; and that the faid conftables, and each of them, fhall account with the mayor's court for the faid fales at their next fitting after fales made.

AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That it shall be lawful for any perfon to take up any fheep, goats, fwine or geefe, going at large within this city, or its precincts, and to impound the fame, giving notice in the manner and for the time preferibed in this bylaw, and if no perfon shall claim fuch sheep, goats, fwine or geefe, within the five days aforefaid, and if claimed, and the owner will not pay, within the faid five days, the fum of two shillings and fix-pence current money aforefaid for each day fuch fheep, goats or fwine, fhall be impounded, or fix-pence per day for each goofe, it shall be lawful for the perfon making fuch feizure to fell fuch theep, goats, fwine or geefe, and after deducting twelve shillings and fixpence current money for the five days impounding as aforefaid, or two shillings and fix-pence, as the cafe may be, he shall pay the balance, if any, to the fheriff of this city, for the ufe of the owner, or of the corporation if not demanded within three months from the time of the fale.

### A BY-LAW empowering the mayor, recorder, or any one of the aldermen, to determine in cafes of fmall debts.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That from and after the publication of this bylaw, in all cafes where the real debt or damage doth not exceed five pounds current money, it shall and may be lawful for the mayor, recorder, or any one of the aldermen, of this city, to try, hear and determine, the matter of controversy between the creditor and debtor,

debtor, and, upon full hearing of the allegations and evidences of both parties, to give judgment according to the laws of the land and the equity and right of the matter, and, if need be, charge the constable with the body of the debtor in execution, who is hereby obliged and empowered to carry the perfon fo committed to the fheriff of this city for the time being, together with a certificate or mittimus from fuch mayor, recorder or alderman, giving the judgment, wherein shall be certified the debt and cost whereof fuch perfon shall be convict, by him the faid sheriff to be fafely kept until fatisfaction, or other end thereof; or otherwife, that fuch mayor, recorder or alderman, giving the faid judgment, or any other of them, shall, within one year from the time of the rendition of the faid judgment, award execution thereon (directed to the sheriff of this city) by warrant or mittimus, in the nature of a capias ad fatisfaciendum, fieri facias, or otherwise; and that in cafe upon the return of any warrant on any complaint iffued by the mayor, recorder, or any one of the aldermen, it shall appear that the perfon against whom the fame shall isfue is not to be found, it shall and may be lawful for the creditor to proceed in the mayor's court for obtaining an attachment.

H. BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That when any defendant shall be brought on warrant before the mayor, recorder, or any one of the aldermen, such mayor, recorder or alderman, may, where witness may be wanting, or the parties may not be prepared to make good their allegations immediately on the appearance of the defendant, so that a further time may be necessary

ceffary to examine into the matter of controverly, if he, in his diferetion, shall think fit, give and allow to fuch defendant a future certain day, not exceeding fourteen days, to appear before fuch mayor, recorder or alderman, or any other of them, at a certain place to be appointed, to answer unto such warrant, such defendant giving good and fufficient fecurity, if fuch mayor, recorder or alderman, award it neceffary, by way of recognizance, in the nature of bail, for the defendant's appearance at the time and place appointed, and paying what he shall be condemned in on the faid warrant, or furrendering his perfon to prifon in fatisfaction thereof, or in default of the defendant's giving fuch fecurity, to commit fuch defendant to the conftable, to be delivered over to the cuftody of the sheriff of this city for the time being till he gives fuch bail; and if the defendant shall not appear at the time and place appointed, judgment may be rendered against him on fuch default, or on an ex parte hearing, if the mayor, recorder or alderman, before whom fuch default is made, or hearing had, does not fee cause to the contrary; and if judgment shall be in any manner rendered against the principal debtor, and he does not pay fuch condemnation, or render himfelf on execution, to be iffued returnable at the end of forty days from the iffuing thereof, a warrant shall and may be iffued, and recovery and execution had, against fuch bail, in the fame manner as against principal debtors, faving to fuch bail all manner of defence that special bail in courts of law are entitled to on the return of the first or fecond feire facias, and the liberty of delivering up the principal debtor on return of fuch warrant, on payment of cofts on the faid warrant. III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the conftable ferving the warrant shall give notice to the plaintiff, or his agent, where either of them lives in the city of Annapolis, or the precincts thereof, of the time and place he intends to carry the defendant before the mayor, recorder, or one of the aldermen; and in cafe neither the plaintiff, having notice as aforefaid, nor any perfon for him, nor the plaintiff, nor any perfon for him, when fuch plaintiff lives out of this city, and the precincts thereof, and hath not appointed an agent in that bufinefs, with or without notice, shall appear on the return of the warrant, or shall make default in not appearing at the time and place appointed, when there shall be an appointment by the mayor, recorder or alderman, as the cafe may be, of a future day for an hearing, the mayor, recorder or alderman, before whom any defendant shall be brought on a warrant as aforefaid, or before whom he shall appear on an appointment as aforefaid, may, in his difcretion, hear and determine the matter of controyerly ex parte.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That in all cafes where the debt or demand doth exceed twenty thillings current money, and either plaintiff or defendant thall think him or herfelf aggrieved by the judgment of the mayor, recorder or alderman, he or the thall be at liberty to appeal to the next mayor's court, before the mayor, recorder and aldermen, who are hereby, upon the petition of the appellants, in a fummary way, empowered and directed to hear the allegations and proofs of both parties, and determine upon upon the fame according to the law of the land and the equity and right of the matter, the fame court in which the faid petition fhall be exhibited, without any further continuance or delay, unlefs it fhould appear, to the fatisfaction of the faid court, that further time ought to be given to the party applying for the fame, to enable the faid court to determine the caufe according to the law of the land and the equity and right of the matter, or either of the faid parties may demand a trial by jury, or leave the caufe to be determined by the court, at their election.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That no execution upon judgment to be rendered by the mayor, recorder, or any one of the aldermen, shall be staved or delayed, or any fuperfedeas upon fuch judgment granted, upon any appeal, unlefs the perfon appealing, or fome other on his or her behalf, shall, immediately upon making fuch appeal, enter into bond, with fufficient fureties, fuch as the mayor, recorder or alderman, by whom judgment shall be given, shall approve of, in double the fum recovered, with condition, " That if the party appealing shall not profecute his appeal at the next mayor's court with effect, according to the direction of a by-law, entitled, A By-law empowering the mayor, recorder, or any one of the aldermen, to determine in cafes of fmall debts, and also pay and fatisfy the party in whofe behalf the judgment shall be given, his executors, administrators or affigns, in cafe the faid judgment shall be affirmed, as well the debt, damage and coft, adjudged by the mayor, recorder or alderman, from whofe judgment fuch appeal shall be made, as alfo all cost and damage that fball

fhall be awarded by the mayor's court, then the faid bond to be and remain in full force and virtue, otherwife to be of no effect."

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That no execution for the body or goods of any perfon or perfons within this city, or the precincts thereof, shall iffue on any judgment rendered in the mayor's court, or by the mayor, recorder, or any one alderman, out of court. provided fuch perfon or perfons shall go before the mayor, recorder, or any one of the aldermen, within two months after the rendition of fuch judgment, and, together with fecurity, fuch as the faid mayor, recorder or alderman, shall approve of, confess judgement for his debt and cofts of fuit adjudged, with flay of execution for fix months thereafter; which confession shall be made in manner and form following; that is to fay, "You, A. B. and C. D. do confels judgment to E. F. for the fum of ---- and ---- cofts, which were recovered by the faid E. F. against A. B. on the ----- day of -----, in the year of our Lord one thousand seven hundred and -----. (in the mayor's court, or before -----, mayor, recorder, or one of the aldermen of the faid city, as the cafe may be,) the faid fum of ----, and ---- cofts. to be levied of your bodies, goods or chattels, lands or tenements, for the use of the faid E. F. in cafe the faid A. B. fhall not pay and fatisfy to the faid E. F. the faid fum of -----, and ----- cofts, fo as aforefaid recovered against him, with the additional cofts thereon, on the ----- day of ---- next ;" and fhall be figned by the mayor, recorder or alderman, taking the fame, and certificate thereof shall be procured, under

under the hand of the faid mayor, recorder or alderman, and fuch certificate fhall be a fufficient fuperfedeas to the fheriff to forbear ferving execution upon the body or goods of the perfon fo obtaining fuch certificate.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if the party be taken in execution before any certificate, provided the confession of judgment therein certified shall have been made within two months after the rendition of the original judgment as aforefaid, be produced as aforefaid, fuch certificate, being afterwards obtained, shall be a fufficient superfedeas to the sheriff to release fuch perfon out of prifon upon that execution, the party paying or giving fecurity to the faid fheriff for his fees due for that imprisonment; and the mayor, recorder or alderman, before whom fuch judgment shall be confessed as aforefaid, shall return the fame to the clerk of the mayor's court, by the next court in courfe which shall be held after the taking the faid confession, under the penalty of thirty fhillings current money for every neglect, to be recovered by action of debt or bill of indictment, to be entered on record, for which entry fuch clerk shall receive eight-pence current money; and, after the expiration of the time limited in fuch confession, it shall be lawful to take out execution thereon, without any fcire facias or any other delay, against either the principal or the fecurity, or all or either of them, for fuch judgment fo confessed as aforefaid, any by-law, ufage or cuftom, to the contrary in anywife notwithstanding.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That all warrants and executions in virtue of this by-law, fhall be made returnable at a certain day, not exceeding forty days after the teft thereof, before the mayor, recorder or alderman, iffuing the fame, or fome other of them, who are hereby authorifed and required, upon application of the party, to call upon the conftables for fuch returns, and in cafe of nonpayment by any conftable who admits the receipt of any debt or demand, it fhall and may be lawful for the mayor, recorder or alderman, to give judgment, and award execution forthwith, againft fuch conftable, directed to the fheriff of this city.

IX. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That witneffes shall be allowed two shillings and fix-pence current money per day for each day's attendance, and no more.

X. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That in all cafes where witneffes do not attend according to fummons, the mayor, recorder or alderman, before whom fuch witnefs ought to have attended, fhall and may enforce obedience to his procefs by attachment of contempt, to be made returnable to the next mayor's court, which court is hereby authorifed and required to take cognizance thereof, and, in the difcretion thereof, to fine the offender any fum not exceeding twenty fhillings current money for every fuch offence.

XI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the mayor's G court

court shall not hold plea of any debt or damage in cafes within the jurifdiction given to the mayor, recorder and aldermen, by this by-law, which shall not exceed five pounds current money, any by-law to the contrary notwithstanding.

XII. PROVIDED ALWAYS, That this by-law thall be deemed, confirued and underflood; to extend only to debts due on contract, and to damages for the nondelivery of grain or other articles contracted to be delivered.

XIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any constable to whom any warrant is delivered (hall not make return thereof according to the command of the fame, it shall be lawful for the mayor, recorder or alderman, who islued the warrant, upon application of the plaintiff, or of his agent or attorney, and proof made of the delivery of the faid warrant, by the confeilion of the faid constable, or by the oath, or affirmation, as the cafe may require, of the faid plaintiff, his agent or attorney, or any other credible witnefs, to call fuch conftable before him, and, unlefs a good excuse is offered, fine him for his faid neglect any fum not exceeding feven shillings and fix-pence current money; and if any conftable shall make due return of any warrant, by which it shall appear that he has taken the body of the defendant, and shall fail to produce him to the mayor, recorder or alderman, before whom the warrant shall be returned, it shall be lawful for the faid mayor, recorder or alderman, to fine the faid conftable for fuch offence any fum not exceeding feven shillings and fix-pence current money, and.

and fuch mayor, recorder or alderman, may appoint another day, not exceeding fourteen days from the return day of the faid warrant, for producing the body of the defendant; and in cafe the faid conftable shall not produce the body of the defendant upon the appointed day, it shall be lawful for the faid mayor, recorder or alderman, at the request of the plaintiff, his agent or attorney, to enter judgment for the plaintiff, for the amount of his debt and cofts, against fuch conftable, on which judgment an execution may be iffued by the faid mayor, recorder or alderman, directed to the fheriff as aforefaid; provided, that it shall always be in the diferention of fuch mayor, recorder or alderman, on due proof made that the constable could not produce the body of the defendant, becaufe the faid defendant was too ill to be removed, or for any other good caufe, to appoint any other reasonable time for producing him, in which case he the faid mayor, recorder or alderman, shall have power to enter judgment, and to iffue execution, against the faid conflable on default of producing the body of the defendant in the manner before directed ; and provided alfo, that before any execution shall be islued against the faid constable, the plaintiff, or his agent or attorney, fhall make it appear to the fatisfaction of the faid mayor, recorder or alderman, that he has made or tendered to the faid conftable an affignment of his caule of action against the defendant.

XIV. AND BE IT ESTABLISHED AND ORDAIN-RD, by the Authority aforefaid, That in cafe the fheriff of this city for the time being shall neglect to make due return of any execution directed to him by virtue of this by-law, it shall be lawful for the mayor,

mayor, recorder or alderman, who iffued the faid execution, on proof as aforefaid of the delivery of the writ of execution to the faid fheriff, to fine fuch fheriff for every fuch neglect any fum not exceeding ten shillings current money; and in cafe any sheriff shall make due return of any execution directed to him as aforefaid, by which it shall appear that he has taken the body of the defendant, and shall fail to produce him, it shall be lawful for the mayor, recorder or alderman, before whom the faid writ of execution is returned, at the request of the plaintiff, his agent or attorney, at any time within forty days from the return day of the faid execution, to enter judgment for the plaintiff, against the faid sheriff, for the amount of the debt and cofts, on which judgment execution may be iffued, directed to the conftable of this city for the time being, who is hereby required to execute the fame; provided, that fuch judgment shall not be entered until proof thall be made, on oath or affirmation as aforefaid, that the debt and cofts have been demanded by the plaintiff, his agent or attorney, of the faid fheriff, and that he hath refused or neglected to pay the fame.

XV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any theriff, against whom judgment shall be entered as aforefaid, shall fatisfy the plaintiff the amount of his debt and costs, he shall have the same remedy against the defendant, on the plaintiff's judgment against him, as the plaintiff himself might originally have had.

XVI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the mayor, recorder corder or alderman, imposing any fine in virtue of this by-law, may iffue execution for the fame, in the nature of capias ad fatisfaciendum or fieri facias, directed to the fheriff or constable, as the cafe may require, and the fame shall be applied to the use of this corporation.

XVII. AND BE IT ESTABLISHED AND OR-DAINED, by the Authority aforefaid, That all conftables hereafter to be appointed, fhall take the following oath : "I, A. B. do fwear, that I will faithfully and honeftly ferve in the office of conftable for the city of Annapolis, and will well and truly, according to my power, fkill and knowledge, perform and execute the duties belonging to the office of conftable, fo long as I fhall continue in fuch office. So help me God."

XVIII. AND BE IT ESTABLISHED AND OR-DAINED, by the Authority aforefaid, That upon every arreft made by any conftable on any warrant iffued in virtue of this by-law, it shall be lawful for the conftable making the arreft to take bond from the perfon arrefted, in a fum not exceeding ten pounds, conditioned for his appearance before the mayor, recorder, or one of the aldermen, to be named in the faid condition, on the return day of the warrant, to answer the fuit of the plaintiff; and in cafe of refufal to give fuch bond, with fufficient fecurity, fuch conftable may deliver fuch perfon to the sheriff of this city, to be by him fafely kept until the return day of the faid warrant.

XIX. AND, whereas the office and duties of the mayor, recorder and aldermen, will be confiderably increased,

increased, and it is reasonable that every perfon who dedicates his time or labour to the public should receive a reasonable and adequate compensation for his fervices; therefore, BE IT ESTABLISHED AND OR-DAINED, by the Authority aforefaid, That it shall and may be lawful for the mayor, recorder and aldermen, to ask and receive the fees allowed and limited by this by-law for fervices expressed in the following table, and fuch fees shall be taxed and paid by the party against whom judgment shall be rendered, to wit : For iffuing a warrant for debt for any fum not exceeding three pounds, fix-pence; if above three pounds, nine-pence; every fummons, including all the witneffes applied for at the fame time, nine-pence current money; and the whole expence of fubpœnas for witneffes in no one cafe shall exceed three shillings; cafa, fame fees as on warrants, according to the fums; fieri facias, fame fees as on warrants, according to the fums; recognizance for defendants appearance, fupertedeas of judgment, one fhilling; every oath administered, fix-pence; probate of account, four-pence; every affidavit, fix-pence; every judgment rendered, fame fees as on warrants, according to the fums; commitment, one shilling; releasement, one fhilling; taking acknowledgment of any deed, each one fhilling; taking any other acknowledgment, one fhilling; taking appeal bond, two shillings; a pass, one shilling.

XX. AND BE IT ESTABLISHED AND ORDAIN-ID, by the Authority aforefaid, That the mayor, recorder and aldermen, for the time being, shall severally take the following oath, to wit: "I, A. B. do fwear, that I will not directly or indirectly receive 2DV

XXI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the fheriff, constable, or other officers, who shall ferve any warrant or precept for bringing any defendant before the mayor, recorder, or any alderman, to answer for any fmall debt, shall have two shillings and fix-pence current money for fo doing, and no more, and for every execution, where it is not immediately prayed upon rendering judgment, the further fum of two fhillings and fix-pence current money, and no more ; and that any fheriff, conftable, or other officer, who fhall extort or receive any further or greater fee for the fervices aforefaid, shall be liable to render four times as much as shall be fo extorted, exacted or received, to the party grieved; and that difputes concerning fuch extortion shall be triable and determinable by the mayor, recorder, or any one alderman, and not elfewhere.

## A BY-LAW relating to apprentices, fervants and flaves.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That any perfon or perfons refiding within this city, or the precincts thereof, who fhall receive, harbour or entertain, any apprentice, indented or bound out by the county court, or any bought indented fervant or flave, belonging to or employed by any perfon or perfons within the faid city, or precincts thereof, or who fhall trade, barter, or any way deal with, fuch apprentice, fervant or flave, without leave or licence in writing first had and obtained from the master or mistrefs of fuch apprentice, fervant or flave, for his, her, or their fo doing, shall forfeit and pay the fum of three pounds current money for every fuch offence.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That in cafe any free perfon reliding within the faid city, or the precincts thereof, fhall buy, or by dealing procure, any firong liquor for any fuch apprentice, fervant or flave, that fuch free perfon fhall forfeit and pay the fum of three pounds current money for every fuch offence.

AND BE IT ESTABLISHED AND DEDAINE

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That in cafe any fuch apprentice, fervant or flave, refiding in or belonging to any inhabitant of the faid city, fhall employ or procure any perfon whatfoever, (not being an inhabitant of the faid city,) to buy or deal for ftrong liquor, or in cafe any fuch apprentice, fervant or flave, fhall counterfeit, or caufe to be counterfeited, any written

written leave or licence from their mafter or miftrefs, or fhall make use of any such counterfeit leave or licence, for the purpose of imposing upon retailers or others, in order to procure strong liquor, then and in every such case the master or mistress of such apprentice, fervant or flave, shall forfeit and pay the sum of thirty shillings current money, or such apprentice, fervant or flave, shall suffer such corporal punishment by whipping, not exceeding twenty stripes, or imprifonment, not exceeding two days, as the mayor, recorder and aldermen, for the time being, in court fitting, shall adjudge.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That no perfon inhabiting within this city, or the precincts thereof, fhall fell, barter or deliver, to any apprentice, indented or bought fervant, or to any flave, any quantity of rum, wine, cyder, or other fpirituous liquors, mixed or unmixed, without the leave or permiffion of the mafter or miftrefs of fuch apprentice, fervant or flave, in writing on paper, expreffing the quantity every time of fuch fale, barter or delivery, under the penalty of three pounds current money for every offence.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That no perfon refiding within this city, or the precincts thereof, fhall fell, barter or deliver, to any fuch apprentice or fervant as aforefaid, or to any flave, any quantity of rum, or other fpirituous liquors as aforefaid, on a Sunday, under the penalty of three pounds current money for every offence.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every retailer of rum, or other fpirituous liquors, who fhall retail the fame within this city, or the precincts thereof, by clerks, deputies, ftorekeepers, or any other perfons, fhall be liable for and fubject to the penalty aforefaid for any rum or fpirituous liquors fold, bartered or delivered, to any fuch apprentice as aforefaid, fervant or flave, by fuch clerk, deputy, ftorekeeper, or other perfon.

VII. AND, for the better discovery of offenders, BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That proof of any fuch apprentice, fervant or flave, coming out of any house within this city, or the precincts thereof, with any rum, or other spirituous liquors as aforefaid, the mafter or miftres of fuch house being known or suspected to harbour or entertain, or deal with, or fell rum or spirituous liquors to, apprentices, fervants or flaves, shall be sufficient evidence to convict the mafter or mistress of fuch house.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED. That all and every the penalties and forfeitures by this by-law inflicted, fhall and may be recovered in the mayor's court of this city by indictment or confettion, and thall be applied to the use of this corporation.

#### A BY-LAW for repairing the public freets.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council,

II. AND BE IT ESTABLISHED AND ORDAINED, That every fuch mafter, miftrefs, or principal of a family, as aforefaid, fhall and they are hereby obliged to fend with fuch labourers fit and convenient tools for the purpofes and ufes aforefaid; and in cafe any fuch mafter, miftrefs, or principal of a family, fhall, without good and fufficient excufe, to be allowed of by the mayor's court, refufe or neglect to fend fuch their able working hands, with fuitable tools, to work and labour on the public freets and paffages, when thereto required, according to the directions of this by-law, he, fhe or they, fhall forfeit and pay, for every fuch working hand fo refuted, the fum of five fhillings current money, for the ufe of this corporation.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the faid conflable for the time being thall keep an exact lift of the perfons he fummons, the time when, and the labourers

bourers by them fent, and likewife who refufes or neglects to fend, and return lifts of fuch as refufe or neglect, to the next mayor's court which fhall meet thereafter, upon his corporal oath; which oath fhall be good evidence to make the perfon or perfons liable to pay the fine aforefaid, without any further or other evidence, unlefs difproved by other indifferent teftimony.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every perion or perfons having a cart with a horfe or horfes, which are hired for carting within this city, and the precincts thereof, shall, and they are hereby obliged. alternately to fend fuch cart and horfe or horfes, with a driver, fix days in the year, when thereto required, to work on, and cart materials for, repair of the faid freets, under the penalty of twenty shillings current money for every day he, the or they, thall refute or neglect to fend fuch cart and horfe or horfes, and driver, to work as aforefaid; and that every perfon or perfons having a cart with a horfe or horfes for their own use, for carting as aforefaid, shall, and they are hereby obliged, alternately to fend fuch cart and horfe or horfes, with a driver, two days in the year, when thereto required, to work and cart materials as aforefaid, under the penalty aforefaid for every day he, fhe or they, fhall neglect or refuse as aforefaid; and that the oath of the conftable for the time being who shall fummon the owner or owners of fuch cart or carts, shall be good evidence of fuch refufal to fubject them to the fine aforefaid, unlefs difproved by other indifferent teftimony. A BY-LAW for the future defraying the charges of the city of Annapolis in holding their courts of hustings and meetings of the corporation.

DE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That for the future, whenever, from the extremity of the weather, or any other reason, it may be proper to hold a meeting of the corporation or court of huftings of the faid city, at a public or any other house, it shall and may be lawful for the court of huftings, at the end of every fuch meeting or court, or thereafter, to fettle with the perfon whole house is made use of, the allowance to be made him or her for the trouble of the houfe, and that upon fuch agreement the faid court give an order, figned by their clerk, to fuch public houfekeeper, or fuch other perfon whole house may have been made use of, on the treasurer of the corporation, for the payment thereof, which shall be allowed him in account.

A BY-LAW to prevent the mildhiefs arifing on the great number of large and fierce dogs infelling the fireets, lanes, alleys, and other public places, within the city of Annapolis, and the precincts thereof, and for laying a tax upon dogs within the fame.

**B**<sup>E</sup> IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That from and after the publication hereof, upon complaint made to the mayor, recorder, or any alderman, by a perfon of good repute and credit, either on his or her own behalf, or on the behalf of his or her her fervant or flave, that he, fhe or they, have been attacked, hurt, or otherwife put in fear, by any male or female dog or dogs within the ftreets, lanes, alleys, and other public places, within the faid city, or the precincts thereof, the mafter, miftrefs or owner, of fuch male or female dog or dogs, fhall be obliged, on remonstrance made to him or her by the faid mayor, recorder or alderman, to reftrain, fecure and confine, the fame conftantly within his or her enclosures.

AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That from and after the first day of August next, no perfon shall fuffer any female dog in heat to go at large within the faid city, or the precincts thereof, whilst in that condition, under the penalty of fifteen shillings current money for every offence, to be recovered and applied as aforefaid.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the theriff of this city for the time being, who is hereby empowered and directed to collect the taxes aforefaid from the inhabitants, agreeably to the lift delivered to him by the conftable as aforefaid, on or before the firft day of January yearly and every year, and the fame pay to the treasurer of this corporation for the time being; and if any owner of any dog thall neglect or refule to pay the tax imposed as aforefaid, and the fame thall be unpaid after the firft day of November in each and every year, the faid theriff thall execute the perfon or property of fuch owner, at his difcretion.

**B**<sup>E</sup> IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That no inhabitant of the faid city, or the precincts thereof, after the publication hereof, fhall fuffer any carrion, flinking fifh, flefh, dead creatures, broken glafs bottles, loofe oyfter-fhells (in quantities,) or other filth, to be, remain or continue, for the fpace of twelve hours, in or upon any of the ftreets or paffages

paffages next to the dwelling-house of such inhabitant, on pain of forfeiting twenty shillings current money for every such offence, to the use of the corporation, to be recovered by indictment or confession.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That no perfon or perfons thall throw, or caufe to be thrown; or thall permit or fuffer any other perfon under his or her direction to throw, or caufe to be thrown, any carrion, ftinking fifh, flefh, dead creatures, broken glafs bottles, loofe oyfter-fhells (in quantities,) or other filth, in or upon any ftreet or paffage of the faid city, on pain of forfeiting twenty fhillings current money for every fuch offence, to the ufe aforefaid, to be recovered in manner aforefaid.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That no inhabitant of the faid city shall suffer any carrion, stinking fish, dead creatures, or other offensive filth, to be, remain or continue, above ground, for the space of twelve hours, in any lot or enclosure in the faid city, occupied by such inhabitant, on pain of forfeiting twenty shillings current money for every such offence, to the use aforefaid, to be recovered in manner aforefaid; or throw, or cause the same to be thrown or laid, in or upon any other lot or enclosure within the faid city, on pain of forfeiting forty shillings current money aforefaid for every such offence, to be recovered as aforefaid, to the use aforefaid.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That no hole or pits shall

fhall be dug or funk in any part of the faid city, not actually enclosed, except for finking wells, cellars, poft-holes, or neceffary drains or water courfes; and that if any holes, pits, drains or water courses, to be dug for the purpoles aforefaid, shall be left uncovered, and not fo fecured as to prevent danger of any kind, by the fpace of twenty-four hours, the perfon offending shall forfeit twenty shillings current money for every offence, to the use aforefaid, to be recovered in manner aforefaid; and that all wells dried up, or not used nor actually enclosed, shall be filled up, and fo fecured as to prevent danger, by the owner, proprietor or tenant, of the lot wherein fuch well or wells are, after the publication hereof, on pain of forfeiting forty shillings current money, and the fum of twenty shillings for every week afterwards that fuch well or wells shall remain not filled up and fecured as aforefaid, to be recovered as aforefaid, to the ple aforefaid ; and that in cafe any fuch well or wells as aforefaid shall be in any lot not tenanted, and the owner and proprietor of fuch lot is not an inhabitant of the faid city, then and in fuch cafe the conftable of the faid city for the time being is hereby required and directed to fill up, and fecure as aforefaid, fuch well or wells by the time laft mentioned, on pain of forfeiting, for his neglect, twenty shillings current money, and the fum of twenty fhillings like money for every week afterwards that fuch well or wells shall remain not filled up and fecured as aforefaid, to be recovered as aforefaid, to the use aforefaid; and the faid conftable is hereby authorifed and empowered to warn the working hands, inhabitants within the faid city, to affift therein, in the fame manner, and under the fame penalties, as are provided by a bylaw,

AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That no inhabitant of the faid city fhall fuffer any house or houses, whereof fuch inhabitant is owner or proprietor, to remain and be in a ruinous and untenantable condition for the space of one month, unless such house or houses be so fecured and fastened as to prevent the same being a place of meeting, abode or shelter, to fervants or flaves, or other loose, idle, or disorderly persons, on pain of forfeiting forty shillings current money for every such offence, to the use of the corporation, to be recovered as aforefaid.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That in cafe the owner or proprietor of luch houfe or houfes as aforefaid fhall not be an inhabitant of the faid city, then and in fuch cafe, all and every perfon or perfons who fhall be or remain in fuch houfe or houfes as aforefaid for the fpace of twenty-four hours, and fhall not have any apparent or visible means of getting an honeft living, fhall forfeit the fum of forty shillings current money, and the fame fum for every fuch offence, to be recovered as aforefaid, to the use aforefaid, and upon default of paying the faid fum on conviction, be liable to fuch punishment, by whipping or fetting in the flocks, as the court shall adjudge.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That in cafe information shall be given to the mayor, recorder, or any alderman,

alderman, of the faid city, for the time being, of any perfon within the faid city fufpected of an idle and difhonest course of life, that the mayor, recorder or alderman aforefaid, shall iffue his warrant to bring fuch fufpected perfon before him, and if, upon examination, fuch perfon shall not give a reasonable and fatisfactory account of fome lawful method whereby he or the doth get his or her living, then and in fuch cafe the faid mayor, recorder or alderman, before whom fuch perfon fhall be examined, fhall and may require fuch perfon to find good fecurity, in ten pounds current money the principal, and two fureties in five pounds like money, to be of good behaviour during his or her refidence within the faid city; provided always, that in cafe it shall not appear that fuch fuspected perfon hath actually committed a breach of any of the by-laws of the faid city, it shall and may be lawful for the faid mayor, recorder or alderman. to allow and permit fuch perfon to remove out of and depart the faid city; and, in cafe fuch perfon shall actually depart, and totally remove, out of the faid city, in the fpace of twenty-four hours from the time of his or her examination, and not return, the mayor, recorder or alderman aforefaid, is not hereby required to take fuch fecurity as aforelaid.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That in cafe any inhabitant within the faid city fhall, after the publication hereof, fuffer any bog-houfe, houfe of office, fhambles or ftalls, in his or her pofferfion, which fhall prove a nuifance to any inhabitant, patienger or paffengers, within the faid city, to continue fuch nuifance for the fpace of twenty-four hours, fhall forfeit forfeit and pay, for every fuch offence, the fum of forty fhillings current money, to be recovered in the mayor's court by indictment or confeffion, to be applied to the use aforefaid.

A BY-LAW to prevent the filling up of the dock of this city, by throwing filth therein; alfo to prevent idle perfons from washing therein, firing of guns in or across the same, or in any part whatever of this city.

DE IT ESTABLISHED AND ORDAINED, by the B Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That if any perfon or perfons shall throw any earth, stones; oyster-shells, or other fort of filth, into the dock, fuch perfon or perfons, if a freeman or freemen, shall, for every fuch offence committed, forfeit the fum of ten shillings current money, to be recovered by indictment or confession, or before a fingle magiftrate, to the use of this corporation; if an apprentice, or a perfon under age the fon of a freeman, then the mafter, parent or guardian, of the faid apprentice or minor, shall be liable to the penalty of five shillings current money for every fuch offence, to be recovered in the mayor's court by indictment or confeffion, or before a fingle magistrate of this city, as aforefaid, to the use aforefaid; and if an indented fervant or flave, the mafter or miftrefs of fuch fervant or flave fhall pay the fum of five fhillings for every fuch offence, to be applied as aforefaid.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That if any perfon shall strip himself naked, and wash in the day-time in the faid faid dock or harbour, fuch perfon, if a freeman or freemen, fhall, for every fuch offence, forfeit and pay the fum of twenty fhillings current money, to be recovered as aforefaid, and applied as aforefaid; if an apprentice, or a perfon under age the fon of a freeman, the mafter, parent or guardian, of the faid apprentice or minor, fhall be liable to the penalty of five fhillings current money for every fuch offence, to be recovered as aforefaid, to the ule aforefaid; and if an indented fervant or flave, the mafter or miftrefs of fuch fervant or flave fhall pay the fum of five fhillings current money for every fuch offence, to be applied as aforefaid.

#### A BY-LAW to establish corders of firewood in this city, and to oblige the purchasers of firewood to have the same corded.

**B**<sup>E</sup> IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That any number of perfons, not exceeding four, of good repute and skill, inhabitants of this city, to be nominated and appointed by the corporation of the faid city for the time being, shall be wood-corders of all firewood brought to, and fold within, the faid city, and the precincts thereof, and may be removed and displaced at the differentiation of the faid corporation.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That from and after the publication hereof, all firewood brought to, and offered for fale in, the faid city, or the precincts thereof, whether by land or water, shall be fet up, packed, corded and meafured, by one or other of the woodcorders of the faid city for the time being; and that each cord of wood shall be eight feet in length, four feet in breadth, four feet in height, and well flowed and packed; and that the wood-corder, for his trouble in cording, packing and meafuring, the fame, agreeably to the directions of this by-law, shall have and receive the fum of fix-pence current money for each and every cord of wood by him fet up, corded, packed and measured, to be paid by the perfon purchafing the fame.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every woodcorder shall affort the wood he shall be required to cord, according to the different lengths thereof, packing the fame together in feparate parcels, according to fuch lengths, and shall measure the same in such manner, and with fuch allowance, as to make a complete cord of wood as the fame is eftablished by this by-law; which faid allowance fhall be made in the following proportions, to wit: All wood meafuring four complete feet, or upwards, in length, to be rated at four feet; all wood meafuring lefs than four feet in length, and not lefs than three feet, to be rated at three feet ; and every cord of wood, fo corded as of three feet, shall be five feet four inches high, and of the ufual length; and no wood lefs than three feet in length shall be corded.

AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any woodcorder fhall cord any wood within this city, or the precincts thereof, contrary to the directions in this by-law contained, he fhall, for every offence againft the fame, forfeit the fum of twenty fhillings current money.

AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the faid wood-corders, and each of them, fhall, and they and each of them are hereby required, on his or their appointment, and before his or their executing the faid office, to take the following oath, or affirmation if a quaker, before the mayor, recorder, or one of the aldermen, of this city: "That he will, when required, in a just

just and impartial manner, well and truly fet up, pack, cord and measure, all frewood which he fhall. be fo required to cord within the city of Annapolis, or the precincts thereof, according to the beft of his fkill and knowledge, and according to the directions of the by-law, entitled, A By-law to effablish corders of firewood in this city, and to oblige the purchafers of firewood to have the fame corded, and that he will not wittingly or willingly afk, charge, exact, demand or receive, any other or larger fee or reward for doing his duty in his faid office of wood-corder, than is mentioned and directed by the faid by-law;" a certificate of which oath fhall, as often as taken, be returned, by the magistrate administering the fame, to the clerk of the corporation, who is hereby directed to make a minute of fuch oath upon the proceedings of the faid corporation.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the faid woodcorders, appointed and qualified as aforefaid, fhall forthwith cord all fuch wood as they fhall be requefted from time to time to cord, always obferving to cord, without preference or partiality, for the perfon who fhall first request the fame to be done, and alfo obferving to cord in fuch a manner as to leave a passing for a cart, and not to obstruct the public landings, under the penalty of five shillings current money for every cord which he or they shall refute or neglect to cord as aforefaid.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That it shall not be lawful for any wood-corder, or any carter, within this this city, or the precincts thereof, to engage, agree for or purchafe, any firewood brought to the faid city for fale, (except for his own family ufe,) under the penalty of forty fhillings current money for every offence.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any inhabitant within the faid city, or the precincts thereof, fhall purchafe any firewood brought to the faid city, or the precincts thereof, by land or water, and fhall neglect or refufe to have the fame corded and meafured by one or other of the wood-corders of the faid city for the time being, fuch inhabitant fhall forfeit and pay the fum of five fhillings current money for every cord of wood he fhall neglect or refufe to have corded as aforefaid.

IX. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That all the penaltics and forfeitures by this by-law imposed, shall and may be recovered either before the mayor, recorder, or one of the aldermen, of this city, one half to be applied to the use of this corporation, the other half to the informer, or in the mayor's court by indictment or confession, to the use of the corporation.

A BY-LAW to prevent wood, flones, bricks and lumber, from lying on the public landings on the dock in this city an unreafonable time, and to oblige the commanders of welfels to make way for others.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, fame, That in cafe any perfon or perfons thall fuffer any quantity of wood, plank, thingles, flaves, pofts, flones, bricks, thells or lime, to be and remain on any of the faid public wharfs or landings, for the fpace of eight days after their being landed, the proprietor thereof thall forfeit and pay the fum of three pounds current money, to the ufe of the corporation, and for every day the articles aforefaid, or any of them, thall remain on the faid wharfs or landings after the time laft aforefaid, the further fum of ten thillings like money.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the constable of this city for the time being, after fuch forfeiture as aforefaid hath happened or become due, shall and may feize fo much of the premifes as may hereafter lie on the faid wharfs or public landings, as will amount to the value of the faid penalties and forfeitures, and expose the fame to public fale to the highest bidder, after giving three days notice of fuch feizure and fale, until the whole of fuch commodities be feized and fold; and the faid conftable is hereby required to keep a diffinct account of all fuch forfeitures, to be laid before the corporation, and to pay the money arifing therefrom to their ufe, to the treafurer of this city for the time being; provided always, that the faid proprietors or owners, in cafe the commodities aforefaid to feized thould be of lefs value than three pounds current money, shall not incur or be liable to any further or other penalty than the forfeiture of the whole of the effects to them respectively belonging.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That in cafe any difpute fhould arife between the owner or proprietor of the effects before enumerated and the conftable, about the regularity or propriety of fuch feizure, then it shall and may be lawful to and for the owner or proprietor aforefaid, within two days after fuch feizure respectively, to appeal to the mayor, recorder, or any two aldermen, of the faid city, who are hereby authorifed and empowered, in a fummary way, finally to hear and determine fuch appeal.

IV. PROVIDED NEVERTHELESS, AND BE IT HEREBY DECLARED, That if any proprietor of the above-mentioned wood, plank, fhingles, flaves, pofts, ftones, bricks, fhells, lime, or other articles, fhall endeavour to hire any cart or team to carry off the fame, and could not procure the fame, or fhould be prevented by the badnefs or feverity of the weather from carrying off the fame, then in fuch cafe the faid proprietor fhall not be liable to the penalty aforefaid.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the conftable, for his trouble in carrying this by-law into execution, shall be entitled to retain, out of the monies which he shall receive by virtue thereof, ten pounds for every hundred pounds, and in proportion for a greater or lefs fum.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every perfon commanding a veffel lying at a public wharf within this this city, and unloaded, fhall be obliged to make way for, and give place to, any and all veffels loaded with any article or articles brought for fale to the faid city, or to be delivered to any perfor within the fame, or the precincts thereof, under the penalty of five fhillings current money, to the ufe of this corporation, for every hour fuch commander fhall continue his veffel fo as aforefaid obftructing fuch vefiel or veffels aforefaid from coming to the wharf, and after being warned by the conftable to remove the faid obftruction.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That it is the duty of the conftable for the time being, and he is hereby empowered and directed, upon view, or information made to him, of any commander of any empty veffel refuling or neglecting to remove his faid vefiel from the wharf to make way and give place to any veffel or veffels loaded as aforefaid, to order fuch commander to remove fuch veffel and obstruction, and, in cafe of refutal or neglect by fuch commander to remove fuch vefiel and obstruction, the faid constable shall take him before a magistrate, who is hereby empowered to inquire into and determine the fame as juffice shall require, under the penalty of ten shillings current money for every offence, to be recovered and applied as aforefaid.

A BY-LAW to regulate the tread of wheels of carts and other carriages of burthen within the city of Annapolis, and the precincts thereof.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council,

of the City of Annapolis, and the Authority of the fame, That the felloes of the wheels of all and every cart, waggon, dray, or other carriage of burthen, mide ute of or employed by any of the inhabitants of this city, or the precincts thereof, in carrying or transporting of any burthen within the faid city, or the precincle thereof, shall be five inches at the least in the tread, except fuch cart, and other carriage of burthen, as thall be drawn by the force of one horfe only, or of any other fingle beaft; and in cafe any perfon or perfons inhabiting or refiding within the faid city, or precincts thereof, shall, at any time, make use of or employ any cart, waggon, dray, or other carriage of burthen, for the purpoles aforefaid within the faid city, or the precincts thereof, the felloes of the wheels whereof shall not be five inches at the least in the tread, fuch inhabitant or refident shall, for every fuch. offence, upon legal conviction thereof, forfeit and pay the fum of forty fhillings current money, to be recovered by indictment or confession, to the use of the corporation : Provided always, that nothing in this by-law mentioned shall be extended, or construed to extend, to any carriage of hurthen as aforefaid which shall be used or employed only in carrying or transporting victuals for man and horse, wood, bricks, or other articles, to or from the faid city, or the precincts thereof, or to any carriage of burthen as aforefaid which shall be used or employed between the first day of December and the first day of March.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the owners or proprietors of all fuch carts as aforefaid shall, and they are hereby obliged, from and after the publication of L this

this act, to have the tread of their faid cart wheels entirely flod with iron, under the penalty of forty fhillings current money for every neglect or omiffion, to be recovered as aforefaid, to the uie aforefaid, unlefs fuch owner or proprietor choofe to have no iron at all on the tread of fuch wheels, in which cafe it is hereby declared, that no penalty fhall be incurred, any thing herein before contained to the contrary notwithfranding.

### A BY-LAW to prevent the blowing or winding of meat.

BE IT ESTABLISHED and Common-Coun-Mayor, Recorder, Aldermen and Common-Coun-THE IT ESTABLISHED AND ORDAINED, by the cil, of the City of Annapolis, and the Authority of the fame. That from and after the publication of this bylaw, it shall not be lawful to or for any butcher, or other perfon whatfoever, killing or flaughtering by himfelf, fervants or flaves, meat, either for fale or for the use of himfelf, or of any other perfon within the faid city, or the precincts thereof, to blow or wind the fame himfelf, or to caufe, permit or fuffer, the fame to be blown or winded by his fervants or flaves, or for any other perfon to fell, or offer to fale, any blown or winded meat, under the penalty of forty fhillings current money for every offence, to the ufe of this corporation, to be recovered by indictment or confettion.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority afore/sid, That any perfon right in court may feize fuch meat, and forthwith prefent the fame to the view of fome magistrate of the faid corporation,

corporation, who, upon view thereof, is hereby authorifed and empowered to pass judgment, and in cafe his judgment shall be that such meat has been blown or winded, fuch magiftrate is hereby authorifed and required to caufe the faid meat, if tainted, to be buried, if not tainted, to be fent to the jail for the use of the prifoners, or to the poor-house for the use of the poor, and to iffue his warrant for any perfon or perfons whatfoever for the better difcovery, upon oath, of the perfon who did, either by himfelf or by his fervants or flaves, kill, flaughter, fell or offer to fale, fuch meat; and the faid magistrate is hereby directed and empowered to caufe fuch perfon, if inhabiting or refiding within the faid city, or the precincts thereof, to enter into a recognizance, in the name of the flate, to the use of this corporation, with two good fecurities, to make his appearance at the next mayor's court, to answer such complaint against him; and in cafe fuch perfon or perfons shall refule to enter into a recognizance with fuch fecurities, the faid magistrate is hereby directed and empowered to commit fuch offender until he shall enter into fuch recognizance, with fecurities as aforefaid.

A BY-LAW to prevent the introduction of the finallpox into the city of Annapolis, or the precinets thereof.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That whatever inhabitant of the faid city, or the precincts thereof, fhall, for the time being, introduce or bring the finall-pox into this city, or the precincts thereof,

thereof, by inoculation, betwixt the laft day of June and the first day of September, yearly, or shall take or receive into his or her house or family any perfon whatever, not being an inhabitant of the faid city, or the precincts thereof, who either is at the time, or comes to town 'to be, infected with the fmall-pox, in order to nurle or tend fuch perfon in that diffemper, knowing fuch perfon to be then infected, or that fuch perfon came to town with defign to be infected with fuch diffemper, fuch inhabitant, fo introducing or bringing the imall-pox into this city, or the precincts thereof, by inoculation, betwixt the times aforefaid, or taking or receiving, at any time, any fuch perfon, not an inhabitant as aforefaid, fhall, for every fuch offence, forfeit and pay the fum of three pounds current money, to be recovered by indictment or confeffion, to the ufe of this corporation.

II. AND EE IT ESTABLISHED AND ORDAINED, by the Authority afor faid, That every inhabitant of this city, or the precincis thereof, who fhall offend as aforefaid, fhall, for every twenty-four hours that any fuch perfon as aforefaid, not an inhabitant as aforefaid, thall continue in the houfe or family of fuch inhabitant, forfeit and pay the further fum of three pounds current money aforefaid, to be recovered as aforefaid, to the ufe aforefaid.

III. PROVIDED ALWAYS, That this by-law, nor any thing herein contained, fhall extend, or be confirued to extend, to the taking or receiving of any perfon, who, coming to this city, or the precincts thereof, about his neceffary bufinefs, fhall have been, or fhall be, cafually infected with the faid diftemper, and and taken fo ill as that it may not be fafe for fuch perfon to retire from the city, or the precincts thereof; nor to the taking or receiving into his houfe or family any perfon or perfons who may come into this city, or the precincts thereof, to be infected with the finall-pox, in order to nurfe or tend fuch perfon in that diftemper, at the time of a general inoculation within this city, and the precincts thereof.

IV. THIS by-law to commence on the first day of March next.

A BY-LAW for regulating ordinaries within the city of Annapolis, and the precincts thereof, and for granting licences to ordinary-keepers and to retailers of spirituous liquors.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That at every January court, during the continuance of this by-law, the mayor, recorder and aldermen, of this city, or any three or more of them, in court fitting, be and are hereby authorifed, empowered and directed, to grant licences to fuch perfon or perfons, of good repute, as they fhall approve, to be ordinarykeepers, for keeping ordinaries and houfes of enterrainment, and also to such perfon or perfons as they shall approve and think fit, to be retailers of wine, rum, brandy, whifky, or other diffilled fpirituous liquors, ftrong beer and cider, within this city, or the precincts thereof, for the space of one year from the time of obtaining fuch licence; and every perfon licenfed to keep ordinary as aforefaid, fhall, at the time

time of obtaining fuch licence, pay to the fheriff of this city, for the ufe of the corporation, the fum of fix pounds current money, and every perfon licenfed to retail fpirituous liquors as aforefaid, fhall, at the time of obtaining fuch licence, pay to the fheriff of this city, for the ufe of the corporation, the fum of three pounds like money, and for every licence obtained, the party obtaining the fame fhall pay to the clerk of the faid court the fum of two fhillings and fix-pence like money; and no perfon fhall have licence to keep ordinary, or to retail fpirituous liquors, other than the mafter, miftrefs, or principal or head, of the houfe in which faid ordinary fhall be kept, or fpirituous liquors retailed.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That every ordinary-keeper licenfed as aforefaid thall, within two months after obtaining licence as aforefaid, provide, and conftantly keep in his houfe, fix good feather beds, befides those neceffary for the family's use, with fufficient warm covering for the fame, and hay, Indian corn or oats, and ftraw for litter, and ftabling for fix horfes at leaft, under the penalty of three pounds current money for every neglect.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That no perfon inhabiting within this city, or the precincts thereof, not having obtained licence as aforefaid, fhall fell by retail any wine, rum, brandy, or other diffilled fpirituous liquors, ftrong beer or cider, under the penalty of three pounds current money for each offence.

IV. AND

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every perfon applying for licence as aforefaid shall, at the time of granting the fame, enter into a recognizance, in the name of the flate, to the use of this corporation, in the fum of one hundred pounds current money, with two fufficient furcties, conditioned, " That if the perfon or perfons fo obtaining fuch licence shall well and truly observe, perform, fulfil and keep, the feveral matters and things in this by-law particularly specified, and in every respect conform themselves thereto, then the faid recognizance to be void ;" provided, that if the perfon, for whom fuch licence be applied for, be unable to attend the court, or abfent from the city, or the precincts thereof, then a recognizance shall be taken from any other perfon duly authorifed to give the fame on behalf of fuch perfon for whole use fuch licence may be applied for.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That any perfon inhabiting or refiding within this city, or the precincts thereof; (not licenfed agreeably to this by-law) who fhall fell or barter lefs than ten gallons of wine, rum, brandy, or any other fpirituous liquors, ftrong beer or cider, fhall be deemed and taken as a retailer within the intent and meaning of this by-law.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, That no retailer, licenfed as aforefaid, fhall fell any wine, rum, brandy, or other diffilled fpirituous liquors, flrong beer or cider, to be drank in his houfe, nor in lefs quantity than one pint, under under the penalty of three pounds current money for each offence.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That no ordinarykeeper, licented as aforefaid, shall fell or vend any quantity of wine, rum, brandy, or other spirituous liquors, strong beer or cider, to be drank out of his house, unless it be to failors, or persons immediately going by water, under the penalty of three pounds current money for each offence.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That at every January court, during the continuance of this by-law, the mayor, recorder and aldermen, of this city, or any three or more of them, in court fitting, be and are hereby authorifed, empowered and directed, to grant licences to fuch perfon or perfons, of good repute, as they shall approve, to keep billiard-tables within this city, or the precincts thereof, in their houfes, until the next January court, for which fuch perfon shall pay to the fheriff of this city, for the use of this corporation, the fum of thirty fhillings current money; and every perfon or perfons keeping a billiardtable in ufe, without licence as aforefaid, fhall forfeit and pay the fum of forty fhillings for every month he or they shall keep such billiard-table without fuch licence as aforefaid, to the ufe of this corporation.

IX. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That it shall and may be lawful for the mayor, recorder, or any one alderman, man, on application to him made by any perform (not rejected, before fuch application made, by the mayor's court,) and who may be, in his opinion, properly qualified, to grant fuch perform a permit to keep an ordinary or houfe of entertainment, or to retail fpirituous liquors, or to keep a billiard-table, or coffee-houfe, within this city, or the precincts thereof, until the next January mayor's court thereafter.

X. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That every perfon obtaining fuch permiftion from the mayor, recorder, or any one of the aldermen, shall be subject and liable to all the regulations and the penalties inflicted by this bylaw, during the time for which the faid permit shall extend, except that of selling without licence.

XI. AND BE IT ESTABLISHED AND ORDAIN-FD, That every perfon making fuch application, fhall thereupon pay a fum in proportion to the time between the obtaining fuch permiffion and the next January court, to the mayor, recorder or alderman, granting the fame, who are hereby refpectively required to pay over to the treasfurer of the corporation for the time being, all fums of money by him received, within ten days after granting fuch permit, and return a lift of fuch permitfions at the faid January court.

XII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the mayor's court may annually, at their January court fitting, or oftener if they think proper, afcertain, in current money, the rates and prices, for the year next en-M fuing,

fuing, of liquors, victuals, provender and other provisions, and lodging and accommodations, fold or furnished by ordinary-keepers within this city, and the precincts thereof, of which rates the clerk of the court shall furnish each ordinary-keeper with a copy, and be paid therefor the fum of two fhillings and fixpence current money, and every ordinary-keeper shall fet up fuch copy in the most public and convenient place in his house, under the penalty of ten shillings like money for every day's neglect; and if any ordinary-keeper shall, directly or indirectly, ask or receive more than the rates or prices fo fixed and allowed, he shall forfeit and pay twenty shillings current money for every offence, to be recovered before the mayor, recorder, or any one of the aldernien, of this city, or by indictment or confession in the mayor's before the mayor, recorder, or court.

XIII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any ordinarykeeper or retailer shall keep a diforderly house, upon complaint made thereof to the mayor, recorder or aldermen, it shall and may be lawful for any three or more of them, in court fitting, to suppress fuch ordinary-keeper or retailer, and during the vacation or recels of the court, upon complaint made to the mayor, recorder and aldermen, or any two of them, or upon their own observation, of such diforderly house, it shall be lawful for them to suspend such ordinary-keeper or retailer until the next court, who may hear and finally determine on the conduct of fuch ordinary-keeper and retailer, and either entirely suppress, or permit the continuance of, fuch ordinarykeeper or retailer; and if any ordinary-keeper or retailer.

to ne no initiation to have

tailer, fufpended as aforefaid, fhall prefume, during fuch fufpenfion, to keep ordinary or retail, he fhall forfeit three pounds current money for every offence.

XIV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every licenfed ordinary keeper and retailer shall fell only by fealed measures, (except bottled cider, perry, quince-drink and ftrong beer, the produce of this ftate, and fuch liquor as shall be imported into this state in bottles); and every ordinary-keeper and retailer, who shall neglect to keep a fealed quart, pint, half-pint, and gill measures, or who shall refuse or neglect to fell by the fame, shall forfeit and pay forty shillings current money for every refufal or neglect, to be recovered before the mayor, recorder, or any one of the aldermen, on complaint, or in the mayor's court by indictment or confession, to the use of this corporation; and it shall be lawful for the mayor, recorder, or any alderman, on complaint, to enter into any ordinary, or houle of any retailer, and there call for and infpect the measures used by them.

XV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any perfon inhabiting within this city, or the precincts thereof, fhall prefume to keep ordinary within this city, or the precincts thereof, without licence obtained as aforefaid, he fhall forfeit and pay three pounds current money for every offence; and if any perfon, refiding as aforefaid, fhall fell by retail any wine, rum, brandy, whifky, or other diffilled fpirituous liquors, ftrong beer or cider, without licence obtained as aforefaid, aforefaid, he shall forfeit and pay three pounds current money for every offence; provided, that any merchant, or perfon keeping flore for the fale of merchandife, may, without licence, fell any wine, rum, brandy, whilky, and other diffilled spirituous liquors and cider, not lefs than ten gallons at one and the fame time to one or more perfons, fo that fuch liquor, nor any part thereof, be not drank in his houfe or flore; and provided, that any perfon, his agent, clerk, or other manager, may fell or fupply any rum, or other fpirituous liquors, (not lefs than one pint at the fame time,) to tradefmen, labourers or others, hired or employed by fuch perfon, or his agent, clerk or manager.

XVI. AND BE IT ESTABLISHED AND OR-DAINED, by the Authority aforefaid, That it shall not be lawful for any licensed ordinary-keeper to fell any wine, rum, brandy, whisky, or other spirituous liquors, mixed or unmixed, firong beer or eider, at any fair or horse-race, after sunfet, under the penalty of thirty shillings current money for every offence.

XVII. AND BE IT ESTABLISHED AND OR-DAINED, by the Authority aforefaid, That it shall and may be lawful for the mayor, recorder and aldermen, in court fitting, at every January court, to grant licence to any perfon or perfons of good repute, as they shall approve, to keep a coffee-houfe within this city, or the precincts thereof, until the next January court, for which such perfon or perfons respectively shall pay to the sheriff of this city, for the use of the corporation, the sum of three pounds current money; and every perfon or perfons keeping a coffee-house without without licence as aforefaid, fhall forfeit and pay the fum of forty fhillings for every month he or they fhall keep fuch coffee-houfe without fuch licence as aforefaid, to the use of this corporation.

XVIII. AND BE IT ESTABLISHED AND OR-DAINED, by the Authority aforefaid, That all and every the penalties and forfeitures by this by-law inflicted, shall and may be recovered in the mayor's court of this city by indicament or confession, to the use of this corporation.

A BY-LAW to prevent accidents arifing from the galloping horfes through the fireets, lanes or alleys, of this city, and the neglect of carters or others driving carts, drays or waggons, therein.

E IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, . That any perfon reliding within this city, or the precincts thereof, who fhall, by galloping, or otherwife force at an improper fpeed, any horfe, mare or gelding, through any of the fireets, lanes or alleys, of this city, shall, if a freeman, forfeit and pay, for every fuch offence, the fum of fifteen shillings current money, to the use of this corporation, to be recovered either before any one alderman of this city, -or by indictment or confession in the mayor's court ; and if an apprentice, indented fervant or flave, the -master or mistrels of fuch apprentice, fervant or flave, fhall forfeit and pay the fum of ten fhillings current money, to be recovered and applied as aforefaid.

AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That every carter and other perfon, who shall drive any cart, dray or waggon, in this city, or the precincts thereof, shall and are hereby obliged conftantly to attend by the fide of the thill horfe, and not to depart therefrom, unlefs in cafe of absolute neceffity, and in no cafe whatfoever shall get up or ride in or on fuch cart, dray or waggon; and if any perfon shall offend against the true intent and meaning of this by-law, fuch perfon fhall, if a freeman, forfeit and pay, for every fuch offence, the fum of fifteen fhillings current money, to the use of this corporation, to be recovered either before any one alderman of this city, or by indictment or confession in the mayor's court; and if an apprentice, indented fervant or flave, the master or mistrels of fuch apprentice, fervant or flave, shall forfeit and pay the fum of ten shillings current money, to be recovered and applied as aforefaid.

# A BY-LAW to regulate the weighing of hay, straw and fodder, within this city, and the precincts there-

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That a diligent and honeft perfon, and an inhabitant of this city, or the precincts thereof, be appointed by the corporation to take charge of the machine erected within this city for the weighing of hay, ftraw and fodder, who as often as requested shall, by himfelf or deputy, which deputy shall be first approved by the corporation, weigh any hay, ftraw or fodder, or any other article which may be brought to the faid machine

corder, or any one of the aldermen, of this city : " I. A. B. do fwear, that I will faithfully and honefly weigh all fuch hay, ftraw or fodder, or other article, as I may be requefted to weigh, without favour, affection or partiality;" which oath shall be returned, by the perfon taking the fame, to the clerk of this corporation, who is hereby directed to enter fuch oath amongst the proceedings of this corporation from time to time, as often as returned to him; and the faid weigher shall also first enter into bond, with two good fureties, to be approved by the mayor for the time being, in the penalty of two hundred pounds current money, to the state of Maryland, to the ufe of this corporation, conditioned as follows : " The condition of the above obligation is fuch, that if the above bound A. B. as weigher of hay, ftraw, fodder. and other articles, in the city of Annapolis, shall well and truly account for, and pay to the corporation of the faid city, all monies by him or his deputy received under a by-law to regulate the weighing of hay, ftraw and todder, within this city, and the precincts thereof, and shall well and truly discharge his duty in the faid flation of weigher, according to the directions of the faid by-law, then the above obligation to be void, otherwife to remain and be in full force and virtue in law;" and the faid weigher is hereby empowered to receive from the purchafers of hay, ftraw and fodder, respectively, for every one hundred and twelve pounds of hay, ftraw or fodder, he shall weigh for such purchasers, the sum of threepence current money, and fo pro rato, be the quantity more or lefs, and for all other articles weighed by him

him the fum of two fhillings and fix-pence current money the load.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That all hay, ftraw and fodder, fhall be weighed by the long hundred, that is, allowing one hundred and twelve net pounds for every hundred weight thereof.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every perfon within this city, and the precincts thereof, who fhall purchafe any hay, ftraw or fodder, brought by land or water to this city, or the precincts thereof, fhall have the fame weighed by the perfon appointed by the corporation to weigh the fame for the time being, or by his faid deputy, and in cafe the faid purchafer of hay, ftraw or fodder, fhall refufe or neglect to have the fame weighed purfuant to this by-law, fuch purchafer fhall forfeit and pay, to the use of this corporation, the fum of forty fhillings current money for every fuch refufal or neglect, to be recovered by indictment or confession.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the faid weigher fhall forthwith weigh all fuch hay, ftraw and fodder, and other articles, as he may be requested from time to time to weigh, under the penalty of forty fhillings current money for every refusal or neglect, to the use aforefaid, to be recovered as aforefaid.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the faid weigher shall keep keep a book, in which he shall enter each and every load of hay, ftraw or fodder, or other article, weighed by him or his deputy, under feparate and diffinct heads, with the weight thereof, together with the name of the purchaser of the fame, which he shall deliver to the corporation whenever and as often as he is required by them, under the penalty of forty fhillings current money for every refufal or neglect, to be recovered as aforefaid, to the use aforefaid; and the faid weigher is hereby required and directed to make out, under his hand, and deliver to the carrier of the faid hay, ftraw, fodder, or other articles, a certificate expressing the name of the feller of the hay, ftraw or fodder, or other article, with the weight thereof, under the penalty of ten shillings current money for every refufal or neglect, to be recovered as aforefaid, to the use aforefaid.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the faid weigher thall make out two lifts of all the hay, ftraw and fodder, and other articles, weighed by him, with the weight thereof, together with the names of the purchafers, one of which he is to deliver to the clerk of the corporation, to be by him kept, and the other to the treafurer for the time being, at January court annually, under the penalty of forty thillings current money for every neglect, to be recovered as aforefaid, to the ufe aforefaid.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the faid weigher thall and may retain one half of the money he may receive as weigher, as a compensation for his trouble, N and and the other half he fhall pay, at January court annually, to the treasurer of this corporation for the time being.

## A BY-LAW regulating weights and meafures.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the Jame, That no perfon or perfons within the faid city, or the precincts thereof, fhall fell or vend any goods, wares or merchandifes, whatfoever, but by weights or measures stamped, and of fall weight and measure, according to the standard weights and measures now established for Anne-Arundel county, until a standard of weights and measures shall be established by the United States, and when such standard states have the states blished, then according to the standard states of forty states current money for every offence, to the use of this corporation, to be recovered by indictment or confession.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the mayor for the time being thall have full power and authority, either in perfon, or he may appoint fome other reputable perfon or perfons, to infpect the weights and meafures of all retailers, and other perfons vending goods, wares or merchandifes, within this city, as often as he may judge convenient; and if the faid mayor thall difcover any perfon or perfons whofe weights or meafures thall not be ftamped, and, if ftamped, thall not be of full weight and meafure according to the ftandard

ard aforefaid, then the faid mayor fhall bind over fuch perfon or perfons, by recognizance, to appear at the next mayor's court to anfwer the fame; and if the perfon or perfons appointed as aforefaid, fhall difcover any perfon or perfons offending as aforefaid, he or they fhall carry the perfon or perfons fo offending before the mayor, recorder, or fome one of the aldermen, of the faid city, and if the faid mayor, recorder or alderman, fhall judge the information well founded, he fhall bind over the perfon or perfons fo offending, by recognizance as aforefaid.

A BY-LAW to establish a counter of shingles, clapboards, pale-boards and staves, and a measurer of plank, scantling, grain, stax-seed and lime, within the city of Annapolis.

**B**<sup>E</sup> IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That it shall and may be lawful for the mayor's court to appoint a person of good repute to be counter of all shingles, clap-boards, pale-boards and staves, and measurer of all plank and scantling, grain, stax-seed and lime, brought by land or water to, and fold in, the faid city.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That from and after the publication hereof, all fhingles, clap-boards, paleboards and flaves, which fhall be brought by land or water to, and offered for fale in, the faid city, fhall be counted, and all plank and fcantling fo brought and offered for fale, fhall be measured, by the officer

fo as aforefaid to be appointed, if he shall be thereunto required, at the choice and election of either the purchafer or feller of fuch thingles, clap-boards, paleboards, flaves, plank and fcantling, for which trouble he the faid officer shall and may demand, have and receive, of the purchaser or feller of the shingles, clap-boards, pale-boards, flaves, plank and fcantling, who shall require the fame to be counted or measured, the fum of fix-pence current money for every one thousand shingles, and no more, and fo pro rato; for every one thousand pale-boards, clap-boards or flaves, the fum of one fhilling current money, and no more, and fo pro rato; for every one thousand feet of plank the fum of fix-pence current money, and no more, and fo pro rato; and for every one thousand feet of fcantling the fum of fix-pence current money, and no more, and fo pro rato.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That from and after the publication hereof, all grain of any kind, flax-feed and lime, which shall be brought by land or water to, and offered for fale in, the faid city, fhall be meafured by the officer fo as aforefaid to be appointed, with proper measures, to be tried and ftamped by the standard provided for that purpose, if he shall be thereunto required, at the choice and election of either the purchaser or seller of fuch grain, flax-feed and lime, for which trouble he the faid officer shall and may demand, have and receive, of the purchafer or feller of the grain, flax-feed or lime, who fhall require the fame, the fum of one shilling and eight-pence current money for every one hundred bushels of grain, flax-feed or lime, and no more, and fo pro rato.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the faid officer, fo as aforefaid to be appointed, shall, and he is hereby required, on his appointment and before his executing the faid office, to make oath, or affirmation if a quaker, before the mayor, recorder, or any one of the aldermen of this city, " That he, when required, will well and truly, according to the beft of his skill and knowledge, count all shingles, clapboards, pale-boards and flaves, and meafure all plank and fcantling, grain, flax-feed and lime, without any fear, favour, affection, malice or partiality, whatever, to the buyer or feller; and that he will not, willingly or wittingly, charge, afk, take, receive, exact or demand, any other or larger fees or rates for doing his duty in his office, than is mentioned and directed by this by-law."

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the faid officer shall count all shingles, clap-boards, pale-boards and staves, and measure all plank and scantling, grain, stax-feed and lime, as he shall be reasonably requested from time to time, under the penalty of ten shillings current money for every neglect or refusal, to be recovered before the mayor, recorder, or any one alderman, or in the mayor's court by indictment or confession, to the use of this corporation.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the mayor's court fhall be and are hereby empowered, at any time, to difplace or remove the faid officer, if the court fhall fee caufe, and fhall and may nominate and appoint

point another perfon of good repute to fuch office, who fhall have power to execute the fame office, according to the directions of this by-law, on his taking the faid oath of office.

#### A BY-LAW to appoint a treasurer.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That there shall be a treasurer to the corporation of this city, to be nominated and appointed by the corporation, who, before he enters upon the execution of his office, shall enter into bond, in the name of the flate of Maryland, to the use of this corporation, with fufficient fecurity, to be approved by the mayor, in the penalty of three hundred pounds current money, conditioned as follows; that is to fay, " The condition of the above obligation is fuch, that if the above bound A. B. as treasurer of the corporation of the city of Annapolis, shall well and truly discharge his duty in the faid office, and, when required by the corporation, regularly account with, and pay over, all monies received by him for their use, then the above obligation to be void, otherwife to remain and be in full force and virtue in law."

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That the corporation thall be and are hereby empowered, at any time, to difplace or remove the faid treasurer from his office, if they thall see cause, and thall and may nominate and appoint another person to such office, who thall have power to execute the faid office, on his giving bond as aforefaid.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That all officers and others in the receipt of monies to the use of this corporation shall, where no time is limited for the payment of the same, pay the same over to the said treafurer immediately upon the receipt thereof, and where there is a time limited, the said officers and others shall pay over to the said treasurer the monies received by them immediately upon the time limited elapsing.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That it shall and may be lawful for the faid treasurer, and he is hereby empowered, to demand and receive, from all persons, all sums of money due and owing, and which may become due, to this corporation, and, on the receipts thereof, to give discharges for the same.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That it fhall and may be lawful for the faid treafurer to retain a commission of ten per cent. for all monies paid away by him on account of this corporation, and fo pro rato, and no more.

## A BY-LAW to prevent public and exceffive gaming.

**B**<sup>E</sup> IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That from and after the first day of September next, it thall not be lawful, on any pretence whatever, for any perfon or perfons to open or fet up, in any part of this this city, or the precincts thereof, any tables for gambling, either under the denomination of A B, A B C, E O, or Faro tables, or under any other name or defcription whatever, except billiard-tables.

II. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, If any perfon or perfons shall, in opposition to this by-law, prefume to open or fet up, or in any manner to ufe or employ, any or either the tables above mentioned, that he or they shall forfeit, for every time the ball shall be cast, or the cards dealt or fpread, on any of the aforefaid table or tables, the fum of three pounds current money; and every perfon who shall put his money on any or either of the faid table or tables, for the purpose of betting, or shall in any other manner whatever bet, play or game, with the owner or owners of the faid table or tables, or any other perfon or perfons using or possessing the fame, on the chances of the faid table or tables, he or they shall forfeit, for every time the money is fo put down, or for every bet made as aforefaid, the fum of three pounds current money each.

III. AND, as it may fo happen that an offender under this act may efcape before juffice can be executed, BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That on information on oath being lodged with the mayor, recorder, or any of the aldermen, that any perfon or perfons have opened and fet up any of the gambling tables as aforefaid, or played at the fame, that the mayor, recorder, or any one of the aldermen, may and fhall iffue his warrant, returnable immediately, directed to the fheriff, to apprehend prehend the faid perfon or perfons against whom information is lodged as aforefaid, and he or they shall be obliged to enter into recognizance, with sufficient fecurity, in such such as the faid mayor, recorder or alderman, shall determine, to appear at the next mayor's court, there to answer such complaint or information against them, and also to be of good behaviour; and if the faid perfon or perfons cannot find fecurity for

his appearance, the faid mayor, recorder or alderman, before whom he shall be brought, may commit the faid person or persons to jail till he shall find security as aforefaid.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every citizen of Annapolis, or the precincts thereof, who fhall fuffer or permit, under any pretence whatever, any perfon or perfons to open or fet up, in any part of his or her houfe within the faid city, or the precincts thereof, any of the before-mentioned tables for gaming, fhall be fined three pounds current money for every quarter of an hour the faid table or tables fhall remain in his or her houfe, opened or fet up for the purpose of gaming as aforefaid.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That every citizen of Annapolis, or the precincts thereof, who shall suffer or permit, under any pretence whatever, any person or perfons, being inhabitants of the faid city or precincts, under the age of twenty-one years, to play, in any part of any of his or her houses within the faid city, or the precincts thereof, at billiards, or any other game or games, for money, liquor, or any other article or O thing.

rt.

thing, shall be fined the fum of three pounds current money for every offence.

VI. AND ED IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the fines to be recovered in virtue of this by-law, fhall go, one half to the informer, and the other half to the use of the corporation, and where no informer, the whole to the corporation.

VII. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the fines impofed by this by-law may be recovered by indictment or confeffion.

### A BY-LAW to regulate the affize of bread within the city of Annapolis, and the precincts thereof.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen ind Common-Council, of the City of Annapolis, and the Authority of the fame, That it shall and may be lawful for the mayor, recorder and aldermen, or any three of them, monthly or oftener, to fet, afcertain and appoint, in the city of Annapolis, and the precincts thereof, the affize and weight of the feveral forts of bread following, which fhall, in the faid city, and the precincts thereof, be made for fale, fold or exposed to fale, and the price to be paid for the fame; and that in every affize of bread, which shall be fo fet in pursuance of this by-law, due regard shall be had, from time to time, to the market price which flour, whereof fuch bread shall be made, shall be fold; and that the faid affize thall be fet and afcertained according to the table following,

lowing, in avoirdupois weight of fixteen ounces to the pound : When the price of fine flour, middlings and rye flour, by the one hundred and twelve pounds weight respectively, shall be feven shillings, then a four-penny loaf shall weigh three pounds five ounces and a half; when feven shillings and fix-pence, then three pounds three ounces and a half; when eight fhillings, then three pounds two ounces; when eight fhillings and fix-pence, then three pounds and half an ounce ; when nine shillings, then two pounds fifteen ounces; when nine shillings and fix-pence, then two pounds fourteen ounces; when ten shillings, then two pounds twelve ounces and a half; when ten shillings and fix-pence, then two pounds eleven ounces; when eleven shillings, then two pounds ten ounces; when eleven fhillings and fix-pence, then two pounds nine ounces ; when twelve fhillings, then two pounds eight ounces; when twelve fhillings and fix-pence, then two pounds feven ounces; when thirteen shillings, then two pounds fix ounces; when thirteen fhillings and fix-pence, then two pounds five ounces; when fourteen shillings, then two pounds four ounces; when fourteen fhillings and fix-pence, then two pounds three ounces; when fifteen fhillings, then two pounds two ounces and a half; when fifteen shillings and fix-pence, then two pounds one ounce and a half; when fixteen fhillings and threepence, then two pounds and half an ounce; when feventeen shillings, then one pound fifteen ounces and a half; when feventeen shillings and nine-pence, then one pound fourteen ounces and a half; when eighteen shillings and fix-pence, then one pound thirteen ounces and a half; when nineteen fhillings and threepence, then one pound thirteen ounces; when twen-

ty fhillings, then one pound twelve ounces and a half; when twenty fhillings and nine-pence, then one pound eleven ounces and a half; when twenty-one fhillings and fix-pence, then one pound ten ounces and a half; when twenty-two fhillings and threepence, then one pound and ten ounces; when twenty-three fhillings, then one pound nine ounces and a half; when twenty-four fhillings, then one pound eight ounces and a half; when twenty-five fhillings, then one pound feven ounces and a half; and fo in proportion for loaves of a larger or fmaller fize.

II. AND BEIT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That after the fixing and fetting the affize, weight and price, of all kinds of bread by the mayor, recorder and aldermen, or any three of them, the fame fhall, with all convenient fpeed, be made public, in fuch manner as the faid mayor, recorder and aldermen, or any three of them, fhall think proper, and fhall be in force until a new affize fhall be fixed and fet.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That after any affize of bread fhall be fet in purfuance of this by-law, no alteration fhall be made therein, either to raife the fame higher, or to fink the fame lower, unlefs the price of flour fhall be one fhilling and three-pence per hundred weight more, or one fhilling and threepence per hundred weight lefs, than at the laft affize.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That every perion and and perfons who fhall make any loaf-bread of wheat or rye flour for fale in the faid city, and the precincts thereof, fhall mark all the bread he fhall bake with the initials of his chriftian name, and his furname at length, and with the following letters, to diftinguifh the feveral forts; that is to fay, the fine white bread with F, middling bread with M, and rye bread with R; which feveral forts of bread fhall be made in the manner following: The fine white bread of the beft fine white flour, the middling bread of good middlings, and the rye bread of good rye flour, and the loaves of fuch bread fhall be a penny loaf or roll, a two-penny, a four-penny, a fix-penny, an eight-penny, and a twelve-penny loaf, and no other.

V. AND BE IT ESTABLISHED AND ORDAINED. by the Authority aforefaid, That if any perfon or perfons whatfoever, within the faid city, or the precincts thereof, shall, after the affize of bread is fixed and fet as aforefaid, make for fale, fell or expose to fale, any of the feveral forts of bread aforefaid within the faid city, or the precincts thereof, which fhall not be fufficiently baked, or marked with the mark, and of the weight and finenels, directed by this bylaw, every fuch perfon or perfons, offending in the premifes, shall forfeit all such bread fo deficient in weight or finenefs, and not marked as aforefaid, and alfo forfeit and pay the fum of ten shillings current money for every fuch offence, to be recovered before the mayor, recorder, or any one alderman, or by indictment or confession in the mayor's court, and applied to the use of the corporation; and that it shall and may be lawful for fuch perfon or perfons as the faid mayor, recorder and aldermen, or any three of them.

them, fhall appoint, at leaft twice in every month, to examine and weigh all fuch bread, and to feize all fuch as he or they fhall find deficient in weight or finenels, and not baked or marked as aforefaid, and fend the fame to the poor-houfe; and if any baker, or other perfon, fhall refufe to fuffer the perfon or perfons appointed as aforefaid to enter his houfe, or other fufpected place, to examine and weigh his bread, he fhall forfeit and pay the fum of three pounds current money for every fuch offence, to be recovered as aforefaid, and the perfon or perfons appointed as aforefaid fhall have one half part of fuch penalty for his trouble, and the refidue fhall be to the ufe of the corporation.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That if any baker shall conceive himfelf aggrieved by the feizure of bread as aforefaid, he may appeal to the mayor, recorder, or any one of the aldermen, who thereupon shall iffue his warrant to three indifferent and judicious perfons, who shall, under the penalty of feven shillings and fix-pence current money each, to be recovered and applied as aforefaid, view the faid bread, and make report to him according as they shall find the fame, and the faid mayor, recorder or alderman, shall thereupon proceed to give judgment on the faid report, or the report of any two of them; and if it shall appear to the faid mayor, recorder or alderman, that the faid bread was justly feized, the baker shall be liable to the penalty first mentioned, and costs, but in cafe the faid bread upon trial shall be found of due weight and finenefs, and marked and baked as this by-law directs, it shall be returned to the baker, and fuch

fuch baker fhall thereupon be exempted from all cofts arifing in confequence of fuch complaint, which cofts fhall be paid by the corporation; and if any perfon purchafing bread, fhall find it deficient in any of the particulars before mentioned, he or fhe may make complaint thereof, within one day after the faid bread fhall be fo purchafed, to the mayor, recorder, or any one alderman, who is hereby authorifed and required to iffue his warrant for the perfon or perfons of whom the bread was purchafed, and to hear and examine fuch complaint, and if the faid bread fhall be deficient in any of the faid particulars, the baker thereof fhall, for every offence, be adjudged to pay the penalty firft mentioned, with cofts.

VII. AND BE IT ESTABLISHED AND ORDAIN-DD, by the Authority aforefaid, That if any perfon or perfons in the city of Annapolis, or the precincts thereof, fhall adulterate, or mix any potafh, foap, allum, or any other improper or unwholefome ingredient, in any kind of flour of which bread fhall be made for fale, every fuch perfon or perfons fhall, for every fuch offence, forfeit and pay the fum of three pounds current money, to be recovered as aforefaid, and applied as aforefaid.

AND BE IT ESTABLISHED AND OR-DAINED, That the perfon or perfons to be appointed from time to time in virtue of this by-law, to fearch for and feize bread made contrary to the regulations herein before mentioned, fhall take the following oath or affirmation: "I will, to the beft of my fkill and judgment, faithfully do and perform all and fingular the matters and things enjoined and required quired of me by the by-law, entitled, A By-law to regulate the affize of bread within the city of Annapolis, and the precincts thereof."

## A BY-LAW relating to the fweeping of chimnies within the city of Annapolis, and the precinets there-

thall allo forfeit and pay, for every flich offerce . to DE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the fame, That at every January court, during the continuance. of this by-law, the mayor, recorder and aldermen, of this city, or any three or more of them, in court fitting, be and are hereby authorifed, empowered and directed, to grant a licence to fuch perfon as they shall approve, to fweep the chimnies in the faid city, and the precincts thereof, for the fpace of one year from the time of obtaining fuch licence ; and the perfon licenfed as aforefaid fhall, at the time of obtaining fuch licence, pay to the theriff of this city, for the ule of the corporation, the fum of five pounds current money, and to the clerk of the court the fum of five fhillings like money; that the perfon licenfed as aforefaid employ as many fweeps as he may find neceffary, and be obliged to fweep, or caufe to be fwept, all chimnies in the faid city, and the precincts thereof, at the rates hereafter mentioned, and in cafe of his refufal or neglect to fweep, or caufe to be fwept, any chimney within the faid city, or the precincle thereof, for the fpace of twenty-four hours after perfonal application to him, or a written application left at his laft place of abode, he shall forfeit and pay the fum of ten shillings current money for every offence, to be recovered before the mayor, recorder, or any one alderman.

derman, or in the mayor's court by indictment of confeffion, and applied to the use of the corporation : and in cafe the chimney, for the fweeping of which application is made, shall catch fire, fo as to blaze out of the top thereof, after the expiration of tweatyfour hours after application made as aforefaid, he shall also forfeit and pay, for every fuch offence, the fum of forty shillings current money, the fum impofed by law for fuch offence, and the perfon making the application shall not be liable therefor; and if he shall be convict of a fecond offence within the year. he thall forfeit his licence.

II. AND BE IT ESTABLISHED AND ORDAINED. by the Authority aforefaid. That the perfon applying for licence as aforefaid shall, at the time of granting the fame, enter into a recognizance in the name of the flate, to the use of this corporation, in the fum of one hundred pounds current money, with fufficient fecurity, conditioned, " that if the perfon obtain+ ing fuch licence shall well and truly observe, perform, fulfil and keep, the feveral matters and things in this by-law particularly specified, and in every respect conform himfelf thereto, then the faid recognizance to be void."

III. AND BE IT ESTABLISHED AND ORDAIN-RD, by the Authority aforefaid, That in cafe of the death or removal of the perfon licenfed as aforefaid. or in cafe of his having forfeited his licence, it shall and may be lawful for the mayor, recorder and aldermen, or any three of them, in court fitting or out of court, to grant a permit to a perfon, not before rejected by the mayor's court, and who may be in their

their opinion properly qualified, to fweep chimnies within the city of Annapolis, and the precincts thereof, until the next January mayor's court thereafter, he paying for the faid permiffion a fum in proportion to the time between the obtaining fuch permiffion and the next January court, to the mayor, recorder and aldermen, granting the fame, if out of court, and if in court fitting, to the theriff of this city, for the ufe of the corporation.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That the perfon obtaining fuch permitfion shall be liable to all the regulations and penalties inflicted by this by-law, during the time for which the faid permit shall extend, except that of fweeping without licence.

V. AND BE IT ESTABLISHED AND ORDAINED, by the Authority aforefaid, That if any chimney, fwept by the perfon licenfed as aforefaid, or by his fweeps, fhall catch fire fo as to blaze out of the top thereof, contrary to law, within twenty days after the fame fhall have been fwept, the perfon fo licenfed fhall forfeit and pay, for every fuch offence, the fum of three pounds current money, to be recovered and applied as aforefaid, and the perfon whofe chimney fhall fo blaze out, contrary to law, fhall not be liable therefor.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, by the Authority aforefaid, That it shall not be lawful for any inhabitant of this city, or the precincts thereof, to employ any perfon, other than the perfon licensed as aforefaid, to sweep or cause to be swept, for for hire or pay, any chimney within this city, or the precincts thereof, under the penalty of twenty thillings current money for every offence, to be recovered and applied as aforefaid.

VII. AND, whereas it is found by experience, that all chimnies in which fires are conftantly kept ought, for their fecurity from taking fire, to be fwept every month, and it is thought expedient, for the encouragement of the inhabitants in having their chimnies regularly fwept within the time aforefaid, to make the rate or price of fweeping as reafonable as poffible, and as difine or punifoment on those who are negligent, to authorife the perform licenfed as aforefaid to charge a higher rate ; therefore, BE IT ESTABLISH-ED AND ORDAINED, by the Authority aforelaid, That the perfon licenfed as aforefaid be authorifed to charge and receive, from fuch perfons as employ him to fweep their kitchen chimney every month, and their other chimnies monthly, from the first day of October till the first day of May in every year, the following rates, and no more; that is to fay, for a funnel of one flory, fix-pence, of two ftories, ninepence, of three ftories, one fhilling, and of four or more florice, one fhilling and three-pence ; and from all perfons who neglect or refuse to have their chimnies fwept monthly as aforefaid, he shall be authorised to demand and receive for fweeping the fame, one third more for every omifion than if fwept within the month; provided, that no perfon shall be subject to pay the additional rate for fweeping his chimney, unlefs he refufes or neglects to have the fame fivent for twenty-four hours beyond the month, after application made to him for that purpole by the perion licenfed cenfed as aforefaid, his agent, or fome of his fweeps; provided alfo, that nothing in this by-law contained thall be confirued or taken to prevent any perfen or perfons from fweeping his or their chimnies by their fervants or flaves.

VIII. AND BE IT ESTABLISHED AND CRDAIN-ED, by the Authority aforefaid, That it may be lawful for the mayor, recorder and aldermen, or any three of them, and they are hereby required, to meet before the first day of September next, and to appoint a perfon to fweep chimnies within this city, and the precincts thereof, and to grant him a permission until January mayor's court next, and to receive the money in proportion to the time for which the permit is granted; and the perfon obtaining fuch permistion shall be liable to all the regulations and penalties inflicted by this by-law, during the time for which the faid permission shall extend, except that of fweeping chimnies without-licence.

IV. AND BE IT ESTABLISHED AND ORDAIN-ID, by the Authority ajorefaid, That if any perion or

## A BY-LAW to establish fire companies, and to ascertain their duty.

BE IT ESTABLISHED AND ORDAINED, by the Mayor, Recorder, Aldermen and Common-Council, of the City of Annapolis, and the Authority of the Jame, That the mayor, and any two or more aldermen, fhall, on or before the first day of September next, proceed

proceed to divide the faid city into three equal diftricts, as near as may be, having regard to the number of inhabitants that may relide in each; and that diffrict fo divided which fhall include the church. thall be the first district, and that which shall include the market-houfe, shall be the fecond district, and that which shall include the government-house, shall be the third diffrict; and having fo divided the diftricts, the faid mayor and aldermen fhall caufe to be made out, by the clerk of the corporation, feparate lifts of all the free able-bodied inhabitants, above fifteen and under fixty years of age, refiding in each diffrict, and furnish a copy thereof to the constable, who shall forthwith proceed to give notice to all those of the first district to meet at the stadt-house on a day to be by them appointed, and to those of the second diffrict to meet at the fame place on the fucceeding day, and to those of the third district to meet thereat on the day fucceeding.

II. AND BE IT ESTABLISHED AND ORDAINED. That each company, at their aforefaid meeting, fhall proceed, by ballot, under the direction of fome one alderman, who shall receive and count the votes, to elect one captain and two lieutenants of the faid company, which officers shall continue in authority, unlefs removed by the corporation, for three years, and no longer, and at the expiration of like term there shall be ever thereafter elections held for faid officers; and in cafe of any vacancy or vacancies happening among the faid officers in the intermediate fpace, by removal as above, by death, refignation, or ceafing to be a citizen, the company or companies wherein they may occur, shall proceed, by direction of the mayor, - 24

mayor, and under the direction of fome one alderman as afore defcribed, to fupply the fame.

III. AND BE IT ESTABLISHED AND ORDAIN-ED, That the captains of the feveral diffricts, fo elected, fhall proceed forthwith to take accurate lifts of all perfons as afore defcribed that fhall belong to their feveral companies, and in cafe of the removal of any perfon from the diffrict, he fhall ftrike his name out of the lift, and on the addition of any new refident to the diffrict, fuch as before directed to be enrolled, he fhall add his name to the lift, give him perfonal notice thereof, and inform him of the duties prefcribed by this act.

IV. AND BE IT ESTABLISHED AND ORDAIN-ED, That the officers of the feveral diffricts, fo elected, shall proceed, within ten days after their election, to choose that inhabitant of the city whom they shall deem most worthy of the trust, to be director of the fire companies, whofe authority, according to the duties prefcribed by this act, shall continue over all the faid officers and their companies, unlefs removed by the corporation, for three years, and no longer, at the expiration of which term, for ever thereafter, an election, as afore directed, shall be held to choose a director; and the faid director, fo appointed, shall take on him the full and entire charge and direction of the fire-engines, buckets, fire-hooks, ropes, ladders, and every other fuch article and implement belonging to the corporation, and shall provide for the prefervation, fafe keeping and keeping in perfect repair, the fame, and, for this purpole, he shall make ufe of the old council-chamber, or fuch other place

or

or places as he may judge most proper; and all charges and incidental expences arising from the performance of this duty, shall be contracted for by the faid director, with the approbation of the mayor's court, and paid for, on his order, by the treasurer of the corporation.

V. AND BE IT ESTABLISHED AND ORDAINED, That the faid director shall forthwith engage, by contract under writing, for and during the term of three years, conditioned for the performance of the duty prefcribed by this act under a penalty of twenty pounds, a fufficient number of able-bodied active citizens, to act as engine-men, who shall, at all times, hold themfelves in readinefs to work the faid engines, and, on any alarm, shall repair thereto, and as foon as pollible conduct the fame to the place whence the alarm of fire shall arife; and, in order to render the faid engine-men more expert in their duty, and prompt to execute the fame, and to provide that the engines shall at all times be kept in perfect order for ufe, the faid engine-men shall, under the orders of the director, exercife the faid engines once every month in the following months, viz. January, February, March, April, June, August, October, November and December, and, as compensation for the time they shall be fo employed in exercise, they shall receive at the rate of two fhillings and fix-pence per day, to be paid by the treafurer, on order from the director; and every engineman who shall refuse to perform this duty, after being duly required, shall be fued by the faid director on his obligation aforefaid; and every engine-man who shall fail to attend on any alarm of fire, shall forfeit and pay the fum of twenty shillings, and, on failure

to

to attend on a day of exercise, he shall forfeit and pay the sum of three shillings and nine-pence, unless prevented by reasonable excuse, to be judged of by the corporation.

VI. AND BE IT ESTABLISHED AND ORDAIN-ED, That every perfon enrolled in a fire company, on any alarm of fire, fhall immediately, under the penalty of ten fhillings, proceed to the place where the fire fhall prove to be, and join their refpective company or companies, and, during the emergency, every perfon fo attending fhall obey the directions of their officers, under penalty of feven fhillings and fix-pence for every freeman fo failing.

VII. AND BE IT ESTABLISHED AND ORDAIN-DD, That the director shall arrange all strangers and flaves that may attend in such companies, and in such departments as he shall judge most expedient, and distribute among the same, is necessary, the buckets belonging to the corporation.

VIII. AND BE IT ESTABLISHED AND ORDAIN-ED, That every director, on his entering into office, ihall caufe an account to be taken by the clerk of the corporation, to be figned by himfelf and lodged with the faid clerk, of all the fire apparatus belonging to the corporation, and on his leaving the office he fhall deliver the fame, or fuch part thereof as may remain, to the fucceeding director, but no director fhall be anfwerable for any lofs, unlefs a wilful neglect or mifapplication fhall be proved, in which cafe he fhall forfeit and pay the value thereof. IX. AND BE IT ESTABLISHED AND ORDAIN-ED, That the director shall, with the confent of the corporation, purchase any new fire apparatus that he may judge necessfary, to be paid for by the treasurer of the corporation.

X. AND BE IT ESTABLISHED AND ORDAINED, ED, That all and every the penalties and forfeitures by this by-law inflicted, fhall be recovered by information before a city magistrate, or by presentment, indictment or confession, in the mayor's court, and shall be for the use of the corporation.
