we have been often disappointed & one who is so gen<sup>ly</sup>  
taken notice of for his imperious behaviour as not thought fit  
for what your Hono<sup>rs</sup> have been pleased to confere upon  
therefore request your Hono<sup>rs</sup> to send us up a New Comiss<sup>o</sup>
