

them a convenient Supply of Men, Arms and Ammunition Lib. R.
 from other parts of the said County more remote and free
 from Danger, if any such be, but if the said County of its self
 shall not be capable of Supplying one part with Another as
 aforesaid, then the s^d Coll. George Wells is to apply himself
 by Lett^r or otherwise to Coll William Burges of Anne p. 124
 Arrundell County for assistance, and of him to make Demand
 of a Convenient number of men, as may suite the Occasion,
 who upon notice given him p^r said Coll Wells hath ord^r to
 Supply him, And Whereas Cap^t John Waterton hath raised a
 party of Men to march after the Indians without any ord^{rs}
 from his L^{spp} or his superio^r Officer for soe Doeing. It is
 further ord^{ed} that the said Coll George Wells forthwith
 cause to come before him the s^d Cap^t John Waterton, and of
 him Demand an Acco^t of such his rash and unadvised pro-
 ceedings, and by what power & Authority he hath soe Done,
 and that what answer the s^d Waterton shall make to such
 Demand be forthwith Signified to his L^{spp}: to the End that the
 same may be Duely inquired into, and considered off and
 that all Officers or others whatsoever within the s^d County
 doe for the future forbear to make any excursions or march
 out after any Indians upon any occasion w^{ts}soever without
 especiall ord^r and Command from his L^{spp}: or other p^{son} or
 persons thereunto Authorised and appointed, upon pain and
 perill of his L^{spps} Displeasure. And further the said Coll
 George Wells is hereby ord^{ed} to give notice to the Inhabi-
 tants of Cæcill County (who are in a like Danger) that they
 also stand upon their guard in manner and forme as is before
 Specified. Ordered also that armes powd^r and shott be sent
 into Baltemore County to Coll George Wells by him to be
 distributed amongst the Inhabitants takeing an Exact Acco^t
 thereof how and to whom disposed, to the End that the same
 may be reimbursed by each p^{ticular} p^{son} into his L^{spps} Maga-
 zine the next Shipping
