Be it Enacted by the Right Honourable the Lord Proprietary by and with the Advice and Consent of his Lordships Governour and the upper and lower Houses of Assembly and the Authority of the same That the above mentioned Act Intituled An Act for the Better Releif of Poor Debtors made at a Session of Assembly begun and held at the City of Anapolis The ninth Day of October Anno Domini Seventeen Hundred and twenty two be and is hereby Continued to be and remain in full Force for and During the Term of three years from the End of this Session of Assembly and to the End of the next Session of Assembly which shall happen after the said three Years Provided that this Act or the Act hereby Intended to be revived shall not Extend nor be Construed to Extend to Exempt any Person or Persons whatsoever from the Payment of his Lordships Quit Rents Alienation Fines or Other Dues & Duties payable to his Lordship the Lord Proprietary or His Governour for the Time Being for his or their Sole Benefit in any Specie or Manner to which such Person or Persons would have been Lyable if this Act had never been made
