We have received Major Bailey's Letter of the 8th Instant enclos- p. 310 ing the Proceedings of a General Court Martial held at Frederick Town the 6th of Decr 1781, for the Trial of Ensign Karr of Capt. Winchester's Company of Select Militia, the Sentence of which the Governor approves and orders it to be carried into Execution. He also mentions his great Difficulties in supplying Wood to the Prisoners, which he says has hitherto been done by Fatigue Parties from his Guard, which cannot be the Case in future, as the Men refuse to do the Duty. As we cannot possibly furnish Money for Wood Cutters, and as the Expedient has been already practised in other Places. we request that the Prisoners themselves may be made to cut their own Wood; a Guard should be turned out with the Fatigue Parties of the Prisoners, to prevent their escaping. We have this Day wrote to the Superintendent of the Finances, for Cash to support the Prisoners; as our Request is reasonable we have Expectations of succeeding, in which Case, some of your Difficulties will be removed.
