(fol. 256) By virtue of a warrant from the Right Hon.<sup>ble</sup> Charles Lord Baltemore directed to major William Coursey and m<sup>r</sup> Anthony Male to Enquire what Lands John Potter late of Talbot County deçd dyed Seized of at the time of his Death We the Jury whose names are hereunder written do find that the Said John Potter late of Talbot County who Ended his life in the year Anno 1668 was possessed and Seized of one hundred & fifty acres of Land viz.<sup>t</sup> as foll fifty acres Called by the name of Cabbin neck & fifty acres Called by the name of Potter's Lott & fifty acres Called by the name of Potter's delight also we do find neither heir nor heiress belonging to the aforesaid Potter & that the rent of the afores<sup>d</sup> Lands hath been paid by Nicholas Lurkey & Alex.<sup>er</sup> Lathmore Guardian of the Said Luckey's Children as appears by the Sheriff's Receipts And further We do find that no profit hath been made of the Said Land being Rough Land & that John Darby under Sheriff to m<sup>r</sup> Richard Tilghman did Seize and Carry away the Patents of the Said Land for the Prop.<sup>ty</sup> use as Wittness our hands and Seals the 12.<sup>th</sup> day of may Anno 1679
