the sd Month & other two till the 23 of the sd Month & one more
on the 11th of March Departed the other remaineing till the 24

his the sd Pl^{ts} house & upon his Cost & charge for all which the
sd Def^t haveing been severall times there unto required hath re-
fused & as yet doth refuse to make him the sd Pl^t any reasonable
