The Committee consisted of members of the National Rifle Association, the Board of Education, the Game and Inland Fish Commission, the Izaak Walton League, the Maryland Wildlife Federation, the Legislative Council, and representatives of farm groups. The Committee submitted its report to the Governor and General Assembly in 1965 (J. R. No. 10, Acts of 1964).
