The Governor appointed this Commission in 1976 to consider the remedy of certain inconsistencies and deficiencies in the operation, implementation and administration of the Law Enforcement Officers' Bill of Rights. The Commission consists of the Superintendent of the Maryland State Police, the President of the Maryland Association of Chiefs of Police, the Chief of a municipal police department as designated by the President of the Maryland Municipal League, three representatives of the Fraternal Order of Police as designated by its President, a member of a police community relations committee, a member of the State Senate as designated by the President and a member of the House of Delegates as designated by the Speaker. The Governor designates the Chairman. The Commission is to report in January of 1977 (Res. No. 33, Acts of 1976).
