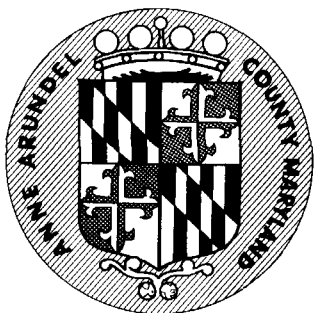


ANNE ARUNDEL COUNTY

Origin: Created by Chapter 8, Acts of 1650 (April Session).

Name: The county was named for the Lady Anne Arundel, wife of Cecilius, Second Lord Baltimore and founder of the Colony of Maryland.
