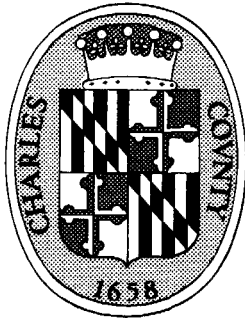


CHARLES COUNTY
