EXECUTIVE COMMISSIONS, COMMITTEES, TASK FORCES, & ADVISORY BOARDS

Executive commissions, committees, task forces, and advisory boards are created by the Governor, either on the Governor's initiative or at the request of the General Assembly. Through these units of government, the Governor draws upon the expertise of private cirizens and public servants. They often are assigned a specific area of inquiry or responsibility and must complete their work by a prescribed date.

The Governor's Advisory Council on Acquired Immune Deficiency Syndrome (AIDS) was created in May 1987 by the Governor (Executive Order 01.01.1987.14). The Council is devising a statewide strategy to stop the spread of AIDS.

Serving as the Governor's primary advisory body on prevention of the disease, the Council makes recommendations on health care and treatment. The Council investigates means by which State and local governments in partnership with the private sector may interrupt the spread of AIDS. In addition, the Council develops public awareness and promotes education to prevent the disease, advises the Governor on the role of State officials in implementing programs, and advises any organization in Maryland that seeks counsel on AIDS.
