The Maryland Higher Education Loan Corporation was created in 1963 (Chapter 589, Acts of 1963). The Corporation lends money or directly guarantees

loans made by approved lenders to State residents who attend or plan to attend colleges or vocational, trade and technical schools. Aid may extend to dependent undergraduate, graduate or professional students; independent undergraduates; or the parents of such students to help meet students' educational expenses. Eligible displaced homemakers also may receive such aid (Chapter 773, Acts of 1984).

The Corporation establishes the rules and regulations by which student loans are granted, administered, and repaid. It also may accept gifts, bequests, and governmental appropriations or grants for its purposes. In addition, the Corporation may enter into agreements with the U.S. Department of Education by which the federal government provides repayable advance funds to be added to the student loan reserve. Such agreements also may make Maryland residents eligible to receive a federal subsidy for part of the interest on their loans.

The Corporation is subject to the supervision and examination of the State Bank Commissioner.

The Corporation's Board of Directors has twelve members. With Senate advice and consent, the Governor appoints nine members for six-year terms. Three members serve ex officio. The Governor designates the chairperson and vice-chairperson (Code Education Article, secs. 18-1001 through 18-1014).

The Maryland Housing Resource Corporation originated in 1985 as the Rental Housing Resource Corporation, a nongovernmental entity established to stimulate the construction and rehabilitation of low-income rental housing in the State (Chapter 732, Acts of 1985). The Corporation received its present name in 1987 (Chapter 309, Acts of 1987). The Corporation operates a special fund that consists of interest money earned on trust accounts held by real estate licensees or on escrow accounts held by vendors or builders of new houses, and grants, donations, and federal funds. The Corporation is exempt from State and local taxes.
