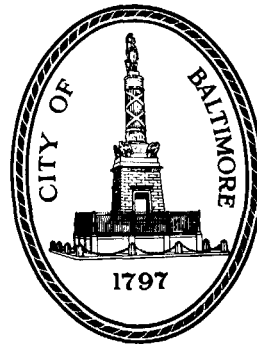


BALTIMORE CITY
