inquisition shall be taken, by reason of opening the aforesaid road CHAR. 178. through his, her or their land, shall thereupon proceed to assess and value the damages accordingly, taking into consideration the advantages and disadvantages, if any, and such inquisition and valuation shall be final and conclusive.

BE IT ENACTED, by the General Assembly of Marvland, That it Benefit of an act extended. shall and may be lawful for the county courts of the respective counties, or the several judges thereof during the recess of the said court, to extend to all such persons as may apply to such court for the same, all the benefits and privileges intended to be given to the persons included in the said act, on their complying with the provisions of the said original act and of the several supplements thereto.

CHAP. CLXXX.

BE IT ENACTED, by the General Assembly of Maryland, That the Width of road, road contemplated to be laid out by the act to which this is a supplement, shall be of the width of thirty feet.

CHAP. CLXXXI.

An Act relative to the Judges of the Court of Appeals, and of the Coun- Passed Jan. 7, 1810 ty Courts. Lib. TH. No. 2, fol. 396.

WHEREAS the speedy administration of justice is highly condu-Preambles cive to the prosperity, and is essentially promotive to the best interests of the good people of this state, and for the attainment of this most desirable object it is requisite that all judges should be punctual and regular in the discharge of their important official duties; to the end therefore that this general assembly may be enabled to form a correct opinion of the conduct of the judges in this respect, and to meet the responsibility which attaches to them as the grand inquest of this state,

2. BE IT ENACTED, by the General Assembly of Maryland, That Clerks to report the clerk of the court of appeals for the western and eastern shore gislature the duration of every respectively, and the clerks of the several county courts, be and they term, &c. are hereby required and directed to report, annually, to the general assembly, on or before the first Monday in December, the duration of every term or session of their several courts, and the number of days that the judge or judges of such court shall respectively attend for the performance of his or their official duties.

3. And BE IT ENACTED, That if the clerk of any of the courts Penalty for neglect herein mentioned shall fail to comply with the direction of this act in making his annual report as aforesaid to the general assembly, he shall forfeit and pay the sum of one hundred dollars, to be recoverable and applied as other fines and forfeitures are.
