WHEREAS in and by the above recited act no provision is made Preamble. to authorise and empower the governor and council to compound with, or sell the state's right to confiscated British property discovered or made known to the governor and council since the passage

of the said act; therefore,

2. BE IT ENACTED, by the General Assembly of Maryland, That Governor and council to come the governor and council shall be and they are hereby vested with pound with discoverers of British full power and authority to compound with all persons who have, confiscated prosince the passage of the said law, made or shall make discovery of perty.
