

*Avowry.*

An avowant recovering, shall have costs. 7 Henry 8, Ch. 4, S. 3; 21 Henry 8, Ch. 19.

Writs shall go to enquire of the sum in arrear, and the value of the distress, on nonsuit of the plaintiff, or verdict or judgment on demurrer against him. 17 Charles 2, Ch. 7, S. 2 & 3.

They who distrain for rent may avow generally. 11 George 2, Ch. 19, S. 22.

*Bail and Mainprize.*

What persons areailable, and by whom. 3 Edward 1, Ch. 15; 3 Henry 7, Ch. 3; 1 & 2 Philip & Mary, Ch. 13.

Sheriffs shall let all persons to bail that are in their custody, upon *mesne* process. 23 Henry 6, Ch. 10.

Justices of peace may bail persons arrested on suspicion of felony. 1 Richard 3, Ch. 3; 3 Henry 7, Ch. 3.

Bail bonds may be assigned to the plaintiff. 4 Anne, Ch 16, S. 20.

Special bail—when requisite. 12 George 1, Ch. 29.

Where bail may have writ of detainer against prisoner. 1 Anne, St. 2, Ch. 6, S. 3.

*Bailiffs and Bailiwicks.*

Distress to be taken by sworn bailiffs. 13 Edward 1, St. 1, Ch. 37.

Bailiwicks not to be let to farm. 23 Henry 6, Ch. 10.

*Baron and Feme.*

A wife that continues with her adulterer, barred of dower. 13 Edward 1, St. 1, Ch. 34.

Where alienations by a woman, of lands come from the husband, &c. shall be void. 11 Henry 7, Ch. 20.

Husband disabled from discontinuing his wife's estate. 32 Henry 8, Ch. 28, S. 6.

Where leases by husband and wife of her inheritance are good. 32 Henry 8, Ch. 28, S. 7.

*Bastard and Bastardy.*

Persons born before marriage deemed bastards. 20 Henry 3, Ch 9.

*Bigamy.*

Made felony—to what cases Act not to extend. 1 James 1, Ch. 11.

*Bills of Exceptions.*

*Bills of Exchange and Promissory Notes.*

Inland bills may be protested for non-payment. 9 & 10 William 3, Ch. 17.

And for non-acceptance. 3 & 4 Anne, Ch. 9, S. 4.

In what case the drawer is obliged to give another bill. 9 & 10 William 3, Ch. 17, S. 3.

Promissory notes assignable. 3 & 4 Anne, Ch. 9, S 1.

Where drawer excused from payment of costs or interest. 3 & 4 Anne, Ch. 9, S. 5.

Where acceptance of a bill of exchange in satisfaction of a former debt shall be deemed payment. 3 & 4 Anne, Ch. 9, S. 7.

*Bonds.*

In actions on bonds for non-performance of covenants, plaintiff may assign many breaches. 8 & 9 William 3, Ch. 11, S. 8.

Payment may be pleaded. 4 Anne, Ch. 16, S. 12.

Principal, interest and costs, may be brought into court. 4 Anne, Ch. 16, S. 13.
