To St. John's College, Annapolis, the sum of twenty-five hundred dollars, together with the further sums of five thousand dollars for repairs and ten thousand dollars to pay existing debts, for the fiscal year 1905, and the like sum of twenty-five hundred dollars for the fiscal year 1906.
- Anne Arundel County Academy. 59. To the Anne Arundel County Academy, the sum of three thousand dollars for the fiscal year 1905, and the like sum of three thousand dollars for the fiscal year 1906.
- Locust Point Social Settlement. 60. To the Locust Point Social Settlement, the sum of five hundred dollars for the fiscal year 1905, and the like sum of five hundred dollars for the fiscal year 1906.
