BIOGRAPHIES BAT

for his loyalty, probably for his services in the Battle of the Severn. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: a freeholder on St. Clement's Manor, 1657; 500 acres in 1661. WEALTH AT DEATH. DIED: in the early 1680s. LAND: at least 600 acres.

BARTON, WILLIAM (1667/68-1705). BORN: on February 27, 1667/68, in Charles County; oldest surviving son. NATIVE: third generation. RESIDED: in Calvert County; Charles County; Prince George's County, after 1695. FAMILY BACK-GROUND, FATHER: William Barton (?-1717), son of William Barton (ca. 1605-early 1680s); a justice of Charles County from 1672 to 1709 and a militia captain, but he never held provincial office. MOTHER: Ann (ca. 1640-?), widow of William Hungerford. BROTHER: William Barton (1662-by 1667/68). SISTERS: Grace (1659-died young); Elizabeth (1671/72-?). MARRIED Sarah (?-by 1739), widow of Basil Waring; daughter of Richard Marsham. She subsequently married by 1709 James Haddock, and finally Rev. William Brogden. CHILDREN. STEPSONS: Basil Waring, who married Martha, daughter of Thomas Greenfield (ca. 1649-1715); Marsham Waring. DAUGHTERS: Sarah (?-1733), who married first, by 1713 Samuel Perrie (?-1729), and second, Patrick Andrew; Katherine, who married Capt. John Murdock. PRIVATE CA-REER. EDUCATION: literate. RELIGIOUS AFFILIA-TION: Anglican. SOCIAL STATUS AND ACTIVITIES: he was a third generation justice; his family was very active in negotiations with the Indians on matters of trade and defense. OCCUPATIONAL PRO-FILE: Indian trader; merchant; planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Prince George's County, 1696-1697 (elected to the 5th session; Laws 7), 1697/98-1698 (resigned after the 2nd session to become sheriff), 1704-1705 (died before the 4th session). LOCAL OFFICES: St. Paul's Parish Vestry, Calvert County, 1693-1696; justice, Calvert County, 1694-1695/96, Prince George's County, 1695/96-1699 (quorum), 1702-1705 (chief justice, 1704-1705); sheriff, Prince George's County, 1699-1702, Charles County, 1704/5-1705 (served the remaining term of his deceased cousin, Thomas Smoote). MILITARY SER-VICE: major, 1695/96-1703; lieutenant colonel, 1703-1705. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: at least 2,243 acres. WEALTH AT DEATH, DIED: between October 23 and November 6, 1705. PERSONAL PROPERTY: TEV, £1,718.6.10 sterling (including 19 slaves); FB, £1,036.7.2. LAND: 2,493 acres.

BATEMAN, JOHN (?-1663). BORN: in England. IMMIGRATED: in 1658 or 1659 as a free adult with his wife from London, England. RESIDED: in Calvert County. MARRIED ca. 1649 Mary (?-1666/67), daughter of Margaret Perry. Her brother was Richard Perry (?-?). CHILDREN. DAUGHTER: Mary, a minor living in England when her mother died. PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: probably a Protestant. SOCIAL STATUS AND ACTIVITIES: enjoyed high status on his arrival in Maryland; brought eight servants with him; he quickly achieved appointment to the Council. OCCUPATIONAL PRO-FILE: haberdasher in London in the 1650s; factor for Henry Scarburgh, merchant of London; entrepreneur. PUBLIC CAREER, LEGISLATIVE SERVICE: Upper House, 1661, 1662, 1663 (died before the 2nd session). OTHER PROVINCIAL OFFICES: Council, 1660-1663; justice, Provincial Court, 1660-1663. WEALTH DURING LIFETIME. PERSONAL PROPERTY: his wife's dower amounted to £500; Bateman obligated himself to provide her £2,000 from his estate if he predeceased her. LAND AT FIRST ELECTION: over 2,900 acres. WEALTH AT DEATH. DIED: will probated on December 3, 1663. PERSONAL PROPERTY: TEV, 142,606 pounds of tobacco (including 12 servants, 5 of whom were blacks), with 89,000 pounds of the tobacco representing the value of his land; FB, 31,534 pounds of tobacco. LAND: over 2,900 acres.

BATHURST, EDWARD (?-1709). BORN: probably in England. IMMIGRATED: in 1694 as a free adult. RESIDED: in Kent County. MARRIED in 1697 after eloping with Rose Blakiston, daughter of John Tucker and wife Rose. She was the wife of Ebenezer Blakiston (1658-1709), nephew of Nehemiah Blakiston (?-1693). Her sister was Sarah, who married William Fitzhugh, of Virginia. ADDI-TIONAL COMMENTS: Rose was much mistreated by Blakiston during their marriage, and tried to commit suicide in the 1680s. PRIVATE CAREER. RELI-GIOUS AFFILIATION: Protestant. SOCIAL STATUS AND ACTIVITIES: Gent. in 1709. ADDITIONAL COMMENTS: In 1694 Bathurst accused Elias King (?-1706/7) and Mary Tilden of incontinent living. Bathurst's career was undoubtedly hampered by his elopement with Rose Blakiston, for which he was found guilty and fined 1,400 pounds of tobacco in 1700. OCCUPATIONAL PROFILE: probably the same Edward Bathurst, a merchant of London, England, mentioned in Maryland records before 1694; an agent for Micajah Perry and his partners, 1693; merchant. PUBLIC CAREER. LEGIS-LATIVE SERVICE: Lower House, Kent County,
