Her first cousins were Josias Beall (ca. 1725-1803): Samuel Hanson, Jr. (?-1817); Philip Thomas Lee (1738-1778); Thomas Sim Lee (1745-1819); Richard Potts (1753-1808); Sarah Lettice Lee (?-1761), who married Philip Richard Fendall (?-?); Hannah Lee (?-ca. 1763), who married George Plater (1735-1792), and Alice Lee (?-1789), who married John Weems (1737-1813). Sarah Fendall Contee died at "Brookefield," Prince George's County. CHILDREN. SONS: Alexander (ca. 1755-1810), who was a merchant and never married; Rev. Benjamin (1755-1815), a merchant and lawyer, born at "Brookefield," near Nottingham, Prince George's County, served as a lieutenant and captain in the Third Maryland Battalion during the Revolution, served as a delegate to the Continental Congress from 1787 to 1788 and as a representative to the U.S. Congress from 1789 to 1791, declared insolvency due to "mishaps in trade" by 1799, ordained as an Anglican minister in 1803, served as pastor of the Port Tobacco Church, Charles County, presiding judge of Charles County Orphans' Court at death, he married in 1794 Sarah Russell (ca. 1767-1810), daughter of Philip Thomas Lee (1738-1778). ADDITIONAL COM-MENTS: Alexander and Benjamin were partners in London in a merchantile business, ca. 1784, with stores in Nottingham, Queen Anne, and Upper Marlboro, Prince George's County. DAUGHTERS: Eleanor Lee (1758-1787), who married Dr. Michael Wallace (1749-1794), of Elkton, Cecil County; Jane (1761-1825), who married in 1782 William Worthington, of Anne Arundel County; and Sarah, who married (first name unknown) Slater. ADDITIONAL COM-MENTS: Contee was sent to Philadelphia, Pennsylvania, to confer with the Continental Congress about the organization of the army and the general plans for defense. OCCUPATIONAL PROFILE: merchant, by 1764; attorney in fact for William Molleson, of London, England, merchant, by 1766; in business in Nottingham, Prince George's County, with Fielder Bowie (ca. 1745-1794) in a firm engaged in the tobacco trade with Europe and the importation of large quantities of goods until the firm advertised its dissolution in 1775; had the management of a store at Pig Point, Prince George's County, ca. 1772-1775; agent for his sons Alexander and Benjamin, London merchants, for their stores in Nottingham, Queen Anne, and Upper Marlboro, Prince George's County, ca. 1784; attorney in fact for both John Yerbury & Company and John Walker, of London, merchant, by 1785; probably also a planter.
