

(?-1757), son of James Beall (?-1725); Mary (?-ca. 1759), who married Samuel Hanson, son of *Robert Hanson* (ca. 1680-1748). PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: Anglican. SOCIAL STATUS AND ACTIVITIES: Mr., 1702; Gent., by 1715. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Charles County, 1712-1714, 1715, 1716-1718, 1719-1721/22, 1728-1731 (Aggravances 1-5). LOCAL OFFICES: William and Mary Parish Vestry, Charles County, 1705, 1718; justice, Charles County, 1712-1729 (quorum, by 1722-1729). MILITARY SERVICE: captain, by 1715; colonel, by 1721. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: over 115 acres in his own right and 450 acres belonging to minor stepchildren. SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: by 1718 he had acquired an additional 800 acres; between 1729 and 1732 he disposed of 1,474 acres (much of it to his son); acquired 225 acres in 1731. ADDITIONAL COMMENTS: established his family's claims to 650 acres in North Carolina in 1694. WEALTH AT DEATH. DIED: will probated on October 28, 1734. PERSONAL PROPERTY: TEV, £1,579.11.9 current money (including 22 slaves); FB, £1,435.0.5. LAND: over 225 acres.

FENDALL, JOSIAS (?-by 1688). BORN: in England. IMMIGRATED: by 1654/55 as a free adult with his wife. RESIDED: in Charles County; immigrated to North Carolina, ca. 1683. FAMILY BACKGROUND. BROTHER: Samuel (?-1694), who immigrated in 1664. COUSINS: John Fendall, a mariner of Devonshire, England; James Fendall (?-1689), of Baltimore County. OTHER KINSHIP: probably a relative of Henry Fendall, a citizen and cutler of London, England. MARRIED first, Mary, daughter of *John Hatch* (ca. 1614-1681). MARRIED second, Mary (?-1691). CHILDREN. SONS: Josias (?-by 1723); Robert (1672-1711/12); *John Fendall* (1674-1734), who married Elizabeth (?-1736), widow of William Marshall (?-1697) and daughter of Randolph Hinson; and Henry. DAUGHTERS: Jane; Mary (1673-1751), who married first, John Theobald (1666-1713), and second, Matthew Barnes (1670-1745). PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: Protestant. SOCIAL STATUS AND ACTIVITIES: Gent. on first appearance; arrived with eighteen servants. OCCUPATIONAL PROFILE: planter; attorney in 1662. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Charles County, 1678 (elected to the 3rd session, but was not allowed to sit). OTHER PROVINCIAL OFFICE: governor, 1656-1660. MILITARY SERVICE: captain, by 1654/55-1660 (for the pro-

prietary government). STANDS ON PUBLIC/PRIVATE ISSUES: in 1654/55 he was an officer in Gov. William Stone's forces, for which he was placed in custody by the government of Parliamentary Commissioners; in 1657/58 he led the proprietary soldiers in recapturing Maryland's government from the commissioners; in 1659/60 he joined with a majority of the Lower House members in a rebellion that resulted in the colony's becoming a commonwealth; he was permanently barred from holding office in 1661; in 1678/79 he was accused of making scandalous speeches against the government; and in 1681 he was arrested for an alleged conspiracy against the government. He left the colony soon thereafter. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: over 4,050 acres. SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: sold most of his land by 1683. WEALTH AT DEATH. DIED: by May 14, 1688; size of estate unknown.

FENDALL, PHILIP RICHARD (?-?). BORN: of age by 1756. NATIVE: fourth generation. RESIDED: in William and Mary Parish, Charles County; left Maryland during the Revolution; Fairfax County, Virginia, 1786; Alexandria, Virginia, 1790. FAMILY BACKGROUND. FATHER: Benjamin Fendall (?-1764), clerk of Charles County from 1752 to 1756, son of *John Fendall* (1674-1734). MOTHER: Eleanor (1710-1759), daughter of *Philip Lee* (ca. 1681-1744). STEPMOTHER: Priscilla (ca. 1714-1763). UNCLES: *Richard Lee* (ca. 1707-1787); *Arthur Lee* (?-1760); *Francis Lee* (?-1749). HALF UNCLES: *Corbin Lee* (?-1774); *George Lee* (ca. 1736-?). STEPAUNT: Hannah Lee Bowie, who married second, *Joseph Sprigg* (1736-1800). BROTHERS: John (?-by 1777); Benjamin; Rev. Henry, rector of Durham Parish, Charles County from 1767 to 1775; and Samuel. SISTER: Sarah (ca. 1732-1793), who married *Thomas Contee* (ca. 1729-1811). FIRST COUSINS: *Thomas Sim Lee* (1745-1819); *Philip Thomas Lee* (1738-1778); *Richard Potts* (1753-1808); Rebecca Potts, who married *Benjamin Mackall IV* (1745-by 1810); Sarah Potts, who married *Thomas Gantt, Jr.* (?-1808); and Hannah Lee, who married *George Platter* (1735-1792). MARRIED first, on September 30, 1759, his first cousin Sarah Lettice (?-1761), eldest daughter of *Richard Lee* (ca. 1707-1787); niece of *Francis Lee* (?-1749), *Arthur Lee* (?-1760), and Hannah Lee Bowie, who married second, *Joseph Sprigg* (1736-1800); half niece of both *Corbin Lee* (?-1774) and *George Lee* (ca. 1736-?). Her brothers were Richard, Jr. (?-1834); *Philip Thomas Lee* (1738-1778). Her sisters were Hannah (?-1763),
