

these contenders, one was Marmaduke Tilden, son of Charles; the other was Marmaduke (?–ca. 1802), son of Marmaduke Tilden (?–1816). Marmaduke, son of Charles, was probably not the legislator because he is listed in the 1783 assessment as a single man without property. Marmaduke (?–ca. 1802) was younger, less wealthy, and less prominent than his father, and so is a less likely candidate for the term of service. Marmaduke Tilden (?–1816) was chosen because of his age and his wealth. Of the three men by that name, he was also the most active politically.

TILGHMAN, EDWARD (1713–1785). BORN: on July 3, 1713, at the “Hermitage,” Queen Anne’s County; fourth son. NATIVE: third generation. RESIDED: in Queen Anne’s County; his dwelling plantation was on the Wye River in Corsica Hundred. FAMILY BACKGROUND. FATHER: *Richard Tilghman* (1672/73–1738/39). MOTHER: Anna Maria (1677–1748), daughter of *Philemon Lloyd* (1646–1685). UNCLÉS: *Edward Lloyd* (1670–1718/19); *Philemon Lloyd* (ca. 1674–1732/33); and *James Lloyd* (1679/80–1723). AUNTS: Rebecca Tilghman (?–1725), who married *Simon Wilmer* (ca. 1656–1699); Margaret Lloyd (1683–1747), who married *Matthew Tilghman Ward* (ca. 1676–1741). BROTHERS: Philemon (1704–died young); Richard (1705–1766); *William Tilghman* (1711–1782); *James Tilghman* (1716–1793); and *Matthew Tilghman* (1717/18–1790). Her first cousins were Sarah Turbutt (1706–1773), who married *Nicholas Goldsborough* (ca. 1689–1766); Elizabeth Turbutt (ca. 1708–?), who married *Tench Francis* (1701–1752); Anne Turbutt (1715–1766), who married *John Goldsborough* (1711–1778); Mary Coursey, who married *Solomon Wright* (?–1729); Elizabeth Coursey, who married *Thomas Wilkinson* (1700/1–ca. 1758); Mary Anne Wright (?–1747), who married *William Hopper* (1707–1772); Anne Wright (?–by 1754), who married *Edward Oldham* (1709–1773); *Thomas Wright* (?–ca. 1784); *Michael Earle* (1722–1787); *Richard Tilghman Earle* (1728/29–1788); Anna Maria Earle (1725–1795), who married *Thomas Ringgold* (1715–1772); Henrietta Maria Earle (1730–1767), who married *William Hemsley* (1736/37–1812); *Joseph Earle* (1739–1777); and Mary Lowe (?–by 1739), who married *Edward Oldham* (1709–1773).
