The debate and votes on the question are given together with the conclusion that "... the senate were unanimously of opinion, that the memorialist cannot of right ask, or this state consistently with justice to others grant him, any compensation or retribution for the losses he states in his memorial to have been by him sustained in consequence of the revolution and acts of our legislature ..."
