A sufficient number of delegates being convened, they severally qualified in the presence of each other, by taking the several oaths required by the constitution and form of government, by subscribing a declaration of their belief in the Christian religion, and by taking, repeating and subscribing, the oath to support the constitution of the United States, and proceeded to ballot for a speaker; the ballots being deposited in the ballot box, on examination thereof it appeared, that the honourable Tobias E. Stansbury, Esq; was unanimously elected.

Mr. John Brewer was elected clerk. ORDERED, That he be qualified as such, by subscribing a declaration of his belief in the Christian religion, and by taking an oath that he will honestly, faithfully and diligently, discharge the office of clerk to the house of delegates, and that he will not reveal or disclose the secrets thereof.

Mr. John Sanders was elected assistant clerk. ORDERED, That he be qualified as such, by taking the several oaths required, by subscribing a declaration of his belief in the Christian religion, and by taking an oath that he will honestly, faithfully and diligently, discharge the office of assistant clerk to the house of delegates, and that he will not reveal or disclose the secrets thereof.

The house appointed Mr. Cornelius Mills sergeant at arms, Mr. John Trueman door-keeper, and Mr. John Sands assistant door-keeper. ORDERED; That they be qualified.

On motion, ORDERED, That Mr. Chapman inform the reverend Mr. Wyatt, that the house request he will perform divine service every morning at the meeting of the house.
